THIS ADDENDUM IS TO: ANSWER THE FOLLOWING QUESTIONS:

- Q1. Under the special provisions, it says to replace and adjust traffic signal loops, do we know how many intersections are involved in this?
- A1. The following list identifies possible locations where traffic signal loops might be needed. The exact limits of work shall be reviewed and delineated with the Engineer in the field prior to the Contractor beginning work. The Contractor is responsible for taking accurate measurements of actual field conditions prior to ordering proposed materials or beginning construction.
 - 1. Sargent St at Centre St 2 loops on Sargent St WB approach to Centre St
 - 2. Sargent St at Waverly Ave 2 loops on Sargent St EB approach to Waverly Ave
 - 3. Homer St at Walnut St 2 wide loops on Homer St EB approach to Walnut St and 4 loops on Walnut St SB approach to Homer St
 - 4. Walnut St at Comm Ave 4 loops on Walnut St NB approach to Comm Ave
 - 5. Homer St at Comm Ave 4 loops on Homer St NB approach to Comm Ave
- Q2. Do you have a list of the streets for this particular project.
- A2. The following list identifies possible locations of work. The exact limits of work shall be reviewed and delineated with the Engineer in the field prior to the Contractor beginning work. The Contractor is responsible for taking accurate measurements of actual field conditions prior to ordering proposed materials or beginning construction.
 - 1. Roosevelt Road from Parker Street to Brandeis Road
 - 2. Theodore Road from Parker Street to Roosevelt Road
 - 3. Homer Street from Commonwealth Avenue to Walnut Street
 - 4. Walnut Street from Homer Street to Commonwealth Avenue
 - 5. Sargent Street from Centre Street to Waverly Avenue
 - 6. Park Street from Sargent Street to Church Street
- Q3. Based on the hi demand and low availability of granite curbing at this time, would the City be willing to look at alternatives to Granite if the problem arises?
- A3. The project requires granite curbing, without exception. It shall be used as part of this project as shown on the drawings and project manual for Invitation for Bid #23-97.

All other terms and conditions of this bid remain unchanged.
