Dear Councilors:

I respectfully submit a docket item to your Honorable Council requesting authorization to transfer the sum of one hundred thousand dollars (\$100,000) from Acct # 0140123-513010 Snow & Ice Overtime to Acct # 0140123-529100 Snow & Ice Vehicle Contractors to "true up" the legal level of control of the cost for employee overtime versus contracted work for snow and ice removal. As you may recall, each year we need to rebalance these accounts.

Additionally, we anticipate that the City has remaining contractor invoices that we have not yet received, and expect to require an additional two hundred eighty thousand dollars (\$280,000) to cover those costs. Therefore, I request that your Honorable Council transfer the sum of \$280,000 from June 30, 2022 Certified Free Cash to Acct # 0140123-527300 Snow & Ice Vehicle Rental/Contractors.
