## ORDINANCE NO. C-15

June 21, 2022

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEWTON AS FOLLOWS:

That the Revised Ordinances of Newton, Massachusetts, 2017, as amended, be and are hereby further amended with respect to **Chapter 30 ZONING** as follows:

- 1. DELETE the last sentence in Sec. 5.2.2. Applicability.
- 2. DELETE the definition of "Sign, Election" in its entirety where it occurs in Sec. 5.2.3.
- 3. **INSERT** a new definition "Sign, Noncommercial. A sign which contains only noncommercial messages." in **Sec. 5.2.3.**
- 4. **INSERT** after the word "other" in the definition of "Sign, Non-Accessory" where it occurs in **Sec. 5.2.3** the word "commercial."
- 5. **INSERT** at the end of the definition of "Sign, Non-Accessory" where it occurs in **Sec. 5.2.3** ", or of a noncommercial sign."
- 6. **DELETE Sec. 5.2.6.B.6** in its entirety and **INSERT** in place thereof a new **Sec. 5.2.6.B.6** as follows:
  - "Noncommercial Signs. Noncommercial signs shall be allowed in all zoning districts, except as otherwise provided in this Chapter, and shall conform to the following:
  - A. The face of the sign shall be no higher than and no wider than 3 feet;
  - B. Signs may be located anywhere on a lot, but shall not create a traffic safety hazard by blocking visibility of traffic on a public street from a driveway. Signs shall not overhang a public sidewalk; however, where there is no sidewalk, no part of the sign shall be closer than 8 feet to the edge of the paved portion of the public way;
  - C. Signs shall not include any names or logos advertising goods, services, or businesses or otherwise constituting commercial speech;
  - D. Signs shall not be artificially illuminated except as permitted by Sec. 5.2.10."
- 7. **DELETE Sec. 5.2.6.B.7** in its entirety.
- 8. **INSERT** after the word "No" where it appears in the first paragraph of **Sec. 5.2.7** the word "permanent."

- 9. **INSERT** after the word "No" where it appears in the first paragraph of **Sec. 5.2.8** the word "permanent."
- 10. **DELETE Sec. 5.2.9.A** in its entirety.
