ORDINANCE NO. C-17

October 3, 2022

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEWTON that the Revised Ordinances of Newton, Massachusetts, 2017, as amended, be and are hereby further amended with respect to **Chapter 17 Fees for Licensing and Permits; and Civil Fines Generally and Chapter 11 Recycling and Trash** as follows:

- I. **INSERT** after subsection (d) Residential curbside pickup of bulky waste items for disposal where it appears in **Sec. 17-16 Fees to be paid to the Department of Public Works** new subsections (e) and (f) as follows:

(e) Residential curbside pickup of mattresses (Sec. 11-14).....per item, \$50.00

(f) Mattress recycling drop off at Newton Resource Recovery Center (Sec. 11-14)
.....per item, \$35.00

And **RELETTER** the remaining paragraphs accordingly.

- II. **INSERT** at the end of the title of **Sec. 11-14. Bulky waste items** the words “and mattresses”.
- III. **INSERT** after the words “Bulky waste items” where they appear in the first sentence of **Sec. 11-14(a)** the words “and mattresses”.
- IV. **DELETE** the words “disposed of” where they appear in the first sentence of **Sec. 11-14(a)** and insert in place thereof the words “properly managed”.
- V. **DELETE** the word “item” where it appears after the words “twenty dollars (\$20.00) per” in the first sentence of **Sec. 11-14(a)** and insert in place thereof the words “and fifty dollars (\$50.00) per mattress”.
- VI. **DELETE** the words “disposed of” where they appear in the first sentence of **Sec. 11-14(b)** and insert in place thereof the words “properly manage”.
- VII. **INSERT** after the words “bulky waste items” where they appear in the first sentence of **Sec. 11-14(b)** the words “and/or mattresses”.
- VIII. **INSERT** after the words “bulky waste items” where they appear in the second sentence of **Sec. 11-14(b)** the words “and/or mattresses”.

IX. **INSERT in Sec. 11-14 Bulky waste items and mattresses a new subsection c as follows:**

(c) Mattresses will be accepted at the Newton Resource Recovery Center upon application to the commissioner of public works by the owner or occupant of a building or premises in Newton who shall pay a fee of thirty-five dollars (\$35.00) per item.


