## Term of Office and Position Requirements:

Attendance at monthly Retirement Board meetings which are currently held the 3<sup>rd</sup> or 4<sup>th</sup> Tuesday of the month at a designated meeting room in City Hall (9am). Board members are also required to earn 18 educational credits per 3-year term through various seminars and course offerings (both in person and online) as approved by the Public Employee Retirement Administration Commission (PERAC). Retirement Board Members receive an annual stipend of \$3,000.

Members-in-service and retirees of the Newton Retirement System.

Any member-in-service (employee) or retiree of the Newton Retirement System may qualify as a candidate by filing with the Newton Retirement Board Office a nomination paper or papers containing the signatures and addresses of at least twenty (20) members or retirees of the Newton Retirement System.
