NOTE: The committee received a letter from His Honor the Mayor dated May 23, 2008 requesting this appropriation.

Lori Burke from the Human Resources Department joined the committee this evening for discussion on this item. Ms. Burke stated that this claim was for an injury to a fifty-eight year old man from the utilities department who sustained injuries in November 2004. This gentleman has had two major surgeries since November of 2004. The surgeries were performed in July 2006 and December of 2007. Ms. Burke stated that this gentleman has significant scarring and loss of function due to these surgeries

This settlement request is for Section 36, which is loss of function and scarring. This gentleman requested the settlement fee of \$15,500 including \$500.00 for his attorney fee. He has also applied for disability retirement. This gentleman's claim was not negotiated until his last surgery was completed.

#### **ACTION: APPROVED 6-0**

**NOTE:** The committee received a letter dated May 13, 2008 from His Honor the Mayor requesting upgrading the parking meter collection system. Thomas Daley and Clint Schuckel joined the committee for discussion on this item relating to parking meter maintenance and collection.

The funds requested will be used for Department of Public Works to purchase 1,000 new locked meter canisters, up to twelve collection canisters, three collection carts, a collection van with rear truck lift, and a meter maintenance pickup truck.

The funds will also be used for the Treasury Department to purchase a new counting machine and a lifting device for coin bags.



The funds are intended to implement recommendations from the City Auditor, Department of Public Works Safety Committee and Human Resources regarding the security and manual lifting of coin containers.

The committee made motion to approve this item without debate.

Clint Schuckel again joined the committee for this discussion. Mr. Schuckel stated this traffic signal would be operated by using a video camera, which is traffic sensitive. The City currently has two traffic signals that use the same style video camera. The camera will be programmed of the traffic patterns in this location.

Mr. Schuckel made clarification that the video picture is not clear enough to site tickets, note license plate numbers, and is not clear enough to be used for enforcement purposes.

The video camera will note when there are cars at the light and therefore will keep the light green for a longer period. The Washington Street traffic signal will remain green unless there are cars on Lowell Avenue.

The committee agreed this signal is necessary and made the motion to approve without hesitation.

**NOTE:** The committee received a letter from Thomas Daley dated May 3, 2008 regarding these assessments of sidewalk/driveway apron and /or curb betterments.

Thomas Daley again joined the committee for discussion of this item. Mr. Daley stated these residents meet the necessary assessment requirement because they are all over \$500.00. The work has been completed and the City will record this on the property homeowner's record.

These are new sidewalks that have been installed, the City pays fifty percent up-front to have the work completed and the homeowners will have twenty-years to re-imburse the City.

Ms. Burstein stated the settlement is with the meter collection and parking enforcement employees of the Police Department. The City has been trying to settle contracts to support the committee to investigate changing their schedule to allow them to return to being parking control employees for enforcement after their school crossing guard duties.

Ms. Burstein stated the money is to cover wages. Retroactive wages is for two percent in FY'07. The additional money is for two percent on July 1, 2008 and one percent on January 1, 2008. Two percent on July 1 and one percent on January 1, 2009.

The committee made the motion for approval without debate.

<u>Committee Clerk's Note:</u> Attached to this report as requested from the committee is the Fire Department's overtime account memorandum dated June 11, 2008 from Chief LaCroix.

Chief LaCroix joined the committee for discussion on this item. Chief LaCroix stated as of May 13, 2008 the Fire Department had a deficit of \$138,256.00 in the overtime account. From May 12 to June 30 of 2007, the Fire Department expended \$94,719.00 in overtime. Chief LaCroix stated if the status remains the same, he might only be requesting \$247,050.00 for overtime. Chief LaCroix believes this appropriation will carry the Fire Department to the end of the year. The additional money requested is to cover administrative and suppression salary issues.

When asked, Chief LaCroix did not know if the Fire Department would save money in the overtime account if he could employee additional firefighters.

The committee made the motion for approval without debate.
