#### Hi Keith,

Tamika, Eli and I are aligned on our combined top priorities for the HRC. We have 6 - only 2/3 of our allotment (3 per person:). Could you please circulate these to the rest of the committee, specifying we don't want comment (we know that's not allowed) but so people can see them in advance of the next meeting to be prepared to discuss. We'd love it if others wanted to share their priorities before the meeting too.

#### 1) Role definition - a few steps

#### A. Best practices

In order to define our ideal mandate, we feel it critical to understand what other HRCs do, and what is working/not working. We'd like to invited chairs from other HRCs to join our meetings, perhaps two at a time so they get more best practices too.

#### **B.** Fact finding

We survey different constituents in the community and ask how the HRC is serving them and what support they would like

- C. We talk to the Mayor about our role
- D. We set goals for the year, and monitor how we do against them so feel accountability.

#### 2) Receiving complaints.

We would like the commissioners to be able to hear the details of the complaints we receive and discuss them. This can be done in executive sessions.

## 3) Training

We would like to have training for Commissioners (of HRC but also disability, housing, etc.). Perhaps MCAD has training. Topics could include bias and engaging in difficult conversations.

### 4) DEI coordinator for the city of Newton

We think the HRC should advocate for a full-time DEI coordinator to be able to fully implement our city's DEI goals.

#### 5) Process issues

- -We'd love to brainstorm a new meeting format. It would be great if folks could share their reports beforehand, then the meetings could center on issues, discussion, and decisions
- We'd like to revisit how non-commissioners aren't supposed to speak until the end
- We'd like to understand student selection process and discuss ways to strengthen it

## 6) City audit

We'd like the HRC to apply for ARPA funds to do a study of the city in terms of DEI, examining a) workforce diversity b) policies and procedures and c) complaints
