At this time, we would request that the Administration docket the following item:

Mayor Ruthanne Fuller and the Planning Department request a discussion and adoption of a proposed Ordinance requiring vibration control measures for construction activities that cause vibrations.

The intent of the Ordinance is to create vibration control protections that will apply to both by right projects and special permit projects within the City that have the potential to cause negative impacts to abutters. Attached is the proposed language crafted in collaboration with various city departments, including the Law Department.

### **DRAFT ORDINANCE SECTION 5-23**

### Sec. 5-23 Regulation of Vibration Monitoring and Protection

- (a) Prior to the issuance of a demolition or building permit for any demolition, site work, or construction activities that require the driving of piles or piers, the removal or alteration of ledge, or significant soil reinforcement or compaction by vibratory roller, applicants shall submit the following to the Commissioner of Inspectional Services:
  - (1) A vibration control plan signed and stamped by a licensed and insured geotechnical consultant that determines the scope of preconstruction surveys needed; the basis for that determination; and the recommended vibration level limits and monitoring services to be provided for the duration of the construction activity.
  - (2) Proof of notice to all properties within such scope that a preconstruction survey was offered at no cost to the property owner.
  - (3) A list of all properties that were surveyed.
  - (4) Any other plans or specifications as the Commissioner of Inspectional Services may require.
- (b) The submitted vibration control plan shall be implemented and adhered to during all relevant construction activity. The applicant shall keep a record of all monitoring and shall provide copies to the Commissioner of Inspectional Services upon request.
- (c) Following construction and prior to the issuance of a certificate of occupancy, all properties subject to a preconstruction survey shall, subject to owner approval, be reinspected to determine any damages caused by vibration.
- (d) *Penalties:* Violations of any portion of this section, including violations of any regulation promulgated hereunder, or failure to comply with a vibration control plan submitted pursuant to this section, shall be punishable by a fine of three hundred dollars (\$300.00) for each day during which the violation continues. Where non-criminal disposition of specified sections of this section by civil fine has been provided for in sections 17-22 and 17-23 of these revised ordinances, as amended, pursuant to the authority granted by G.L. c. 40, sec. 21D, said

violation may be enforced in the manner provided in such statute. The civil penalty for each such violation is set forth in section 17-23(c).

- (e) *Enforcement:* The commissioner or his/her/their designee shall enforce all provisions of this section, including any regulation promulgated hereunder, and shall institute all necessary administrative or legal action to assure compliance.
- (f) *Regulatory Authority:* The commissioner has the authority to promulgate rules and regulations necessary to implement and enforce this section.
- (g) *Severability:* If any provision of this section is held to be invalid by a court of competent jurisdiction then such provision shall be considered separate and apart from the remaining provisions, which shall remain in full force and effect.

#### Petition #88-22 Request for a study on construction vibration standards

COUNCILORS ALBRIGHT, BAKER, BOWMAN, DOWNS, GREENBERG, HUMPHREY, LAREDO, LEARY, MALAKIE, NORTON, RYAN based on the Washington Place Liaison Committee recommendations, requesting the study, analysis, review of vibration standards related to construction projects as they affect neighboring buildings. The outcome of this analysis could be an amendment to Chapter 20, Sec. 13-22 Noise, to include a vibration section in construction projects.

#### Petition #314-23 Discussion and Possible Creation of Ordinance Regarding Vibration Control Measures

HER HONOR THE MAYOR requesting the discussion and possible creation of an ordinance that would require control measures for construction activities that cause vibrations in both by-right and special permit projects.

The above docket items originated from vibratory impacts of construction to neighboring buildings. This topic has been long discussed at the Land Use Committee depending on the size and scale of a project and as a result, a standard condition around vibration control was drafted. Following approval, development teams encountered unanticipated issues with the condition as written and most recently in July 2023, three projects came back to have their vibration control condition altered so they could begin the steps to apply for a building permit.

Upon review, city staff discovered issues with the way the condition is written and its applicability to only special permit projects within the city and acknowledged some measures should be applied to as of right projects dependent on unique characteristics of the land. As such, new language was drafted, to be

reviewed and approved by the City Council and with the goal of adoption as an Ordinance. The intent of the Ordinance is to ensure vibration control protections would apply to both as of right projects and special permit projects within the City. Attached is the proposed language crafted by the Law Department **(Attachment A).** 

When reviewing the former special permit condition, Commissioner of Public Buildings Josh Morse strongly recommended against using a one size fits all approach regarding the distance for preconstruction surveys, vibration monitoring and control measures as each project and site conditions (including subsurface conditions) are unique; instead he recommended requiring a plan prepared and submitted by a licensed and insured geotechnical professional that would determine the appropriate scope of vibration monitoring and control measures in light of given the construction methods, site conditions and site location. When evaluating the potential impact of city construction projects, Commissioner Morse tailors the approach taken as to which properties to include in the pre-construction survey dependent on the scope of construction and characteristics of the site and neighborhood. Commissioner Morse also noted that regulating vibration solely through the use of a special permit condition does not capture by right projects which can also impact surrounding properties with their construction. The City Engineer and Commissioner of Inspectional Services agree with this approach for a revised condition.

Based on the feedback from these experienced City officials and our charge in developing a set of regulations which are reasonable in terms of protections offered and would apply to both Special Permits and by-right projects alike, City Staff recommend a city-wide ordinance that would require vibration control for all private projects utilizing certain construction methods. The proposed Ordinance would require a vibration control plan prepared by a licensed and insured geotechnical consultant, proof of notice to all properties within the scope that a preconstruction survey was offered, a list of all properties surveyed, and any other plans or specifications required by the Commissioner of Inspectional Services. If the geotechnical professional submits a signed and stamped letter indicating that vibration controls are not necessary based on the scope of work and construction methods proposed, then the submission of a vibration control plan will not be required. While this differs from the original vibration control condition, it allows a specialized approach dependent on site conditions and construction methods. The proposed Ordinance would also govern by right projects, not currently captured as the vibration control condition is only applied to special permit projects.
