# #206-23 Discussion and possible ordinance to allow for breweries, brew pubs, and other craft beverage production

<u>COUNCILOR LIPOF</u> requesting review, discussion, and possible ordinance amendments relative to Chapter 30 zoning ordinances pertaining to craft beverage production. Possible amendments would remove prohibition on bottling alcoholic beverages and propose opportunities for other craft beverage production and accessory retail.

<u>Clerk's Note</u>: Councilor Humphrey put this on Second Call with the intention to make a Motion to amend to re-insert the language that the intentional release of helium balloons is prohibited. Councilor Krintzman explained that when this ordinance was under discussion, the language used the word "prohibiting" and that Commissioner Walsh had raised concerns about the enforceability of this, as well as the equitable nature of enforcement, so requested that language be changed from prohibited to a "strong discouragement".

#### #303-23 Request for a grant of location in 925 Chestnut Street

CAMBRIDGE NETWORK SOLUTIONS petition for a grant of location to install underground conduit for fiber installation, which includes picking up proposed fiber running along Chestnut St. from a newly installed pole riser at pole #116 on the north side of Boylston Street and then beneath both the east and west bound lanes of Boylston Street. This run will then terminate at a newly placed pole riser, just south of Boylston Street. This fiber conduit will be run approximately +/- 252 feet and will then be run north and south of the utility poles in an aerial fashion.

CAMBRIDGE NETWORK SOLUTIONS petition for a grant of location to install approximately 190 feet of underground conduit from utility pole #85/92 and extend southerly 190-feet to utility pole 85/94. The proposed alignment is near the westerly gutter line of Chestnut Street that received Hot-in Place overlay last construction season.

Clerk's Note: Items #303 and #304 were taken up together given that they are very similar, with same company and same street. Councilor Humphrey put this on Second Call. Councilors noted that this would be ripping up a major street that just had this work last year. Councilors referenced a city rule that streets once opened up, could not be not be re-opened for 5 years, unless there were extraordinary circumstances. A Councilor further clarified this policy and stated that in instances where a street was dug up again within 5 years, then the street must be re-paved, and made like new. Councilor Gentile made a Motion that approval for this item should only be given if the city requires the infra-red treatment (which will make it look like a new street).

#### #306-23 Establish and Appropriate funds to an Operations Booster Stabilization Fund

HER HONOR THE MAYOR requesting authorization to Establish an "Operations Booster Stabilization Fund" to pay for a portion of the annual general fund appropriations for the City's pension system; appropriate the sum of \$20,500,000 Overlay Surplus as declared by the City's Board of Assessors to the Operations Booster Stabilization Fund; and transfer the sum of \$5,513,000 from Acct 01C10701-576300 Appellate tax Board Interest and Penalties Fund to the Operations Booster Stabilization Fund.

Finance Denied Motion to Approve Subject to Second Call 3-4-1 (Councilors Humphrey, Malakie, Oliver and Noel Opposed, Councilor Gentile Abstaining) Motion to send this back to the Finance Committee City Council Approved 20 Yeas, 2 Nays (Councilors Grossman, Kalis), 2 Absent (Councilors Markiewicz, Norton)

<u>Clerk's Note:</u> Councilor Grossman made a Motion to invite CFO Ms. Maureen Lemieux to come inside the rail. Councilor Humphrey had put this on Second Call, and made a Motion to return this to Finance Committee. He felt the plan had been changed from what was voted on in committee, i.e., initial plan was about a direct spending plan towards pensions, but that had been revised, and is now a direct spending plan for NPS and other city departments-not what was discussed in committee, per Councilor Humphreys. Moreover, this would require a 2/3<sup>rd</sup> vote to pass, and as it stands now, not likely to pass. Therefore sending it back to committee would be in fact, giving it a life line.
