NOTE: The Committee spent a significant portion of this evening's meeting in review of the Annual Financial Audit Report for FY2007. Chris Rogers was present from the firm of Sullivan and Rogers, and he gave a presentation of the findings, after which time the Committee reviewed the contents of the report and other documents (such as the Management Letter), which were prepared by Sullivan & Rogers as part of the audit process.

The Committee thanked the auditors and David Wilkinson for all of the work that they performed in getting the audit completed and in preparation of the submitted documents. In keeping with current practice, the Committee will continue to monitor the City's financial position through the work of the Financial Audit Subcommittee throughout the fiscal year.

Ultimately, the Committee voted 7-0 to approve (and accept the audit report).

The Committee thanked David for all of his tireless efforts to keep the City's accounts in good order as well as providing detailed reports as required and/or requested on various projects (especially the Newton North Construction Project, as well as other bond issue projects). The Committee looks forward to working for yet another term with David.

This re-appointment was approved unanimously by a vote of 7-0.

NOTE: This item was discussed and approved at the Programs and Services Committee meeting on December 15th. Bob DeRubeis, Deputy Commissioner of Parks and Recreation, was present this evening. He explained that this request was filed because the Parks and Recreation Department has deemed it necessary to remove trees that have been identified as potentially hazardous to persons or property *before* major winter storms can make matters worse. The remainder of the routine tree removal operations will be funded during the spring months.

The Committee understood the need to perform this work sooner (rather than later), and voted 7-0 to approve this request.

NOTE: This item has been a topic of discussion in this Committee for months now. There has been discussion with the Executive Department regarding the need for establishing formal financial policies, and it is hoped that this can be accomplished (and implemented) very soon. Sandy Pooler, Chief Administrative Officer, and Susan Burstein, Chief Budget Officer, were present this evening. They explained that Mayor Cohen has reviewed the proposed policies draft, and wished to make some changes to that document. It was requested that a red-lined version be prepared (by the Executive Department) to clearly delineate the proposed changes to the document.



With the anticipation that the red-lined document will be available for distribution in the weekly packet (on December 14th, in preparation for further discussion on December 18th), the Committee voted 7-0 to hold this item for further review at the December 18th special Committee meeting.

NOTE: There was lengthy debate on this item in Committee this evening, to follow-up on the previous discussions that took place in the Public Facilities Committee. The discussion was focused on the terms of the proposed contract, and consideration of amendments to the contract document.

For two reasons, a detailed written report will not be given at this time. The first reason being that, since there are conflicting Committee votes on this item, it will need to be placed on SECOND CALL on the floor of the Board on December 17th. Therefore, there will be a need for further discussion, possibly at that time, but more likely there will be a motion to postpone discussion of this item until January in the Full Board forum (as opposed to having the item sent back to both Committees.

The second reason for lack of a detailed written report is that, subsequent to this Committee meeting, Mayor Cohen has agreed to further changes to the contract document. It is also understood that Waste Management (the contractor) is also still conducting ongoing review of the document, which means that there could be further changes before the Board takes its final vote.

Ultimately, the Committee voted 4-1-2, with Ald. Schnipper opposed and Ald. Lennon and Salvucci abstaining to deny the version of the contract that was available at this evening's meeting.
