The Youth Commission is "by the youth, for the youth". That mission statement perfectly sums up the impact and role of the Youth Commission to me, and it's a mission that continues to inspire me today.

I joined Youth Commission last fall, driven by the desire to express my voice as a young person and evoke change, along with a group of equally passionate teens. The Youth Commission to me is the perfect opportunity to express my voice and collaborate at the same time and amplify all of our voices, as a collective. Too often, young people are discredited for their ideas and visions; however, just as all age groups have valuable perspectives and contributions, youth, in particular, represent the voices and change of the future. I hope to continue leveraging the outreach of the Youth Commission to spread information about events and topics that impact Newton youth, hopefully expanding the outreach of the newsletter to more people and adding features such as summarizing what is going on over at City Hall to get more youth civically engaged and aware, bridging the rift that often occurs between municipal government and the residents, particularly young people.

All in all, my past year on the Advisory Board has inspired me to become more involved in this community of teens with ideas that can—and will—come to fruition. Thus, I'm applying to become a Commissioner to turn ideas into reality, one newsletter, one youth-centered event, and one *dream* at a time.

Prompt: Why are you interested in becoming commissioner, what would you like to achieve/work on/ and why are you the best candidate?

I, Zack Gusenoff, would like to further my involvement with the City of Newton Youth Commission by taking on the role of commissioner. Since my first commission meeting back in September 2021, I have felt like a part of something bigger than myself. The idea that, my family and my friends could see the impact of my work made me eager to participate, and the concept that a group, spanning over five years in age, could have a say in local government appealed to me. I have been on the Commission's advisory board for two years, and have loved being involved in the projects, discussions, and events that we take on. After the conclusion of last year's meetings, I considered what I could achieve and help others accomplish if I am allowed to become a commissioner.

Becoming a commissioner would allow me to not only get more involved, but also to become more vocal in terms of pitching ideas, and helping those who are less comfortable. I know from many experiences that speaking out loud can be difficult, especially when it is in front of a group of people that you do not know very well. As a result, many advisory board members' ideas are never discussed due to their sense of unfamiliarity. As a commissioner, I want to make sure everyone has a chance to speak and develop the skill of public speaking which is important for both local government and life. I will also lead the advisory board by determining which groups people are most interested in while helping to set reasonable and achievable goals for each sub-committee.

On a larger scale, I am going to work hard to limit antisemitism within Newton schools and help the ever-growing mental health crises that many students experience. Both of these issues are common in my public school system and are not addressed nearly as much as they should be. It is important to have experiences and events for students that are purely fun, taking their minds off of school stress while helping them build social skills. If appointed, my goal is to create an annual event that the students of Newton can look forward to, rather than stress about. I know from experience,

having gone through two demanding years of high school, that these events are crucial in helping students both mentally and physically. Additionally, I want to strengthen the Newton school's response to antisemitic incidents and racism. This means more serious investigations into hate speech and a better attempt at consoling students through the use of after-school meetings and WIN blocks.

Out of the other equally deserving candidates, I believe I am the best candidate for this position because of my persistent determination and my ability to take ideas and make concrete plans. In 2018, I was interested in creating a book club with the non-profit organization The Home for Little Wanderers. As part of this book club, I would facilitate a fun and educational discussion among kids ranging in age from 5-11, helping them develop better social and emotional bridges between both their lives and their peers. As an eighth grader, I was in regular contact with the organization's CEO, and board of directors. After many Zoom calls and emails, the first meeting was held in 2021. Now in my junior year of high school, I am still having regular meetings with the CEO, I have been running my book club, named Page Turners, for four years. My passion when working on projects is unparalleled and my commitment drives the success of not just my work but those around me.

I have been leading for the past four years through my book club and it is something that I do not take for granted. I believe that if I am honored with the role of commissioner, there is no limit to how much progress the commission can make and how we can improve the City of Newton.

Sarina Chand - Newton Youth Commissioner Statement of Intent

Prompt: What has inspired you to get involved with the Youth Commission and local government? What does the Youth Commission mean to you and what do you hope to influence?

Growing up in Indian culture meant my path had always stemmed to be pre-set. When I was 8, my Dad told me to decide what I wanted to do when I grew up. When I was 10 and I visited DC, my aunt told me I should be the president of the United States. By the time I was 12, I decided that if everyone would insist on a medical career, I would specialize in {eye specialty} At 14, my mom had decided that I would be an excellent lawyer. While I'm appreciative of the confidence these sureties built for me, they never gave me a real sense of passion. I never decided what I wanted to be, only that I wanted to create change. I wanted to be a changemaker. I wanted to make decisions that would help bolster those around me, and inspire a confidence similar to what I had, but without the restrictions of one path. I would watch as decisions were made on different sized scales and ponder over what I would've done differently or how it could have been done better. I watched as our world was hosted by adults, and the growing issues that would impact my generation were largely ignored in favor of present, less pressing issues.

The Youth Commission presented to me an opportunity to open doors not just for myself, but also for the youth around me. The decisions made on the youth commission impact not just the adults of our city, but help to create change among the youth as well, offering youth, like me, a chance to voice our opinions and form our paths.

It is hard to be taken seriously as a youth, as I've experienced firsthand. The Youth Commission opens pathways for me to use my voice to make sure that we are heard, in ways many youth don't have the privilege of demanding. The Youth Commission is a place where we can address issues that matter to the youth, which is often drastically different from the views of adults. The commission offers a new perspective to our community, and allows us to make decisions that matter through proposing ideas to better our city. Even further, the youth commission helps to create a space where individuals such as myself, changemakers, are able to come together in order to voice the concerns of those who are often overlooked. The Commission gives me a way to shape my own future and gives light to issues I am passionate about.

The youth voice is of utmost importance, with our futures in mind, we are the driving force of the next generation. Being involved with the commission in the past and helping to create awareness on different topics, including mental health and recycling, has

helped me realize how to prioritize issues that matter to me and has helped learn how to work with others of my age to develop solutions. Involvement with the youth commission in the past few years and involvement with different departments of city hall has reignited my passion for change, and has given me the means to influence the future of myself and those around me. The Youth Commission allows me to have a chance to influence younger generations and to influence adults who are making decisions today. Through the community engagement committee, I've been able to discuss with a wide range of people, giving me the experience necessary to push the commission to have even more of a voice within our communities and cities. I would help to elevate voices not often heard, to lessen biases and ignorance that exist in our city.

While the youth commission allows me to inspire others, it has also inspired me. The ideas and frameworks we have laid out have bolstered my desire to work towards a political career, offering an entry to a world where I can further my ambitions in order to help effect positive change not just within our community, but also throughout our world.

When I initially joined the Youth Commission as an Advisory Board member, I aimed to represent youth who may not feel comfortable giving opinions and ensure everyone's voice is heard. I hoped to help shape Newton into a safe space for young people of diverse backgrounds, and I want to increase my efforts and involvement by becoming a Commissioner.

As an avid member of the Newton South Public Forum Debate Team, I have gained particular knowledge and understanding of the important traits of good policymakers. These include listening to everyone's perspectives with a sense of integrity and funneling this information into an action/policy to promote a certain cause; I hope to put these traits into use through my work as a Commissioner.

Last year, I was involved with both the Community Engagement and Communications subcommittees and one of the things we aimed to do as part of the Community Engagement Subcommittee was to increase awareness of bike lanes and biking in general. I represented the Newton Youth Commission at Newton's Earth Day Event; I collaborated with Bike Newton and Safe Routes to School to educate the public on biking and plug the Bike Rodeo. In speaking to many adults at the event, I noticed many mentioned how important youth voice is in the local community and government, and I completely agree. I strongly believe the youth voice can influence those "in power," like policymakers and representatives.

For example, on the NPS school district's Superintendent Search Committee this year, I was the sole Student Representative for over 11,000 K-12 students. I am sensitive to the needs of various student groups and wanted to ensure that the next Superintendent would listen to their concerns (yay, Anna Nolin!) But it became clear that it would be challenging for me, the sole youth member, to get my voice heard by the rest of the Committee – 16 adults. I needed to change how I interacted and presented myself. I believed the best way to have fellow committee members listen to me was to take diligent notes during interviews - in fact, I took more notes than I thought was possible to have objective quotes to reference when speaking about the candidates. During the discussions, the quotes enabled me to make credible arguments. In fact, one of the committee chairs commented that she was thoroughly impressed with my analysis of the candidates, so I believe I was able to get my voice heard.

A few areas of interest to influence change within the Newton youth include educating and providing workshops for domestic violence, teen dating violence, and safe biking. I would also like to implement a workshop that perhaps the Community Engagement takes on; this workshop would focus on educating middle-high schoolers about the foundation of civic engagement and youth voice. I would have benefited from having the opportunity in middle school to learn how to speak out and have a voice in a community where it may feel hard at times, so I would like to provide this experience for others and hopefully get them interested in joining the Youth Commission (plug!)

During the City Council meeting on Monday November 20th, I received the attached text messages from a City Council colleague. This exchange was inappropriate, unwanted, and unwelcome.


The next day I spoke with Ms. Michelle Pizzi O'Brien, Director of Human Resources for the City of Newton, regarding the text messages. She informed me, after consulting Newton's Law Department, that Human Resources and Law have no oversight in regard to City Council conduct.

I reached out to Carol Moore, the City Clerk, and she expressed that there was no mechanism in our rules, or any sort of ethics commission to address unwanted or unwelcome behavior, or behavior that is unbecoming of a City Councilor. I then met with the Council President, and she stated that while there is no current mechanism to investigate and escalate conduct issues, she agreed the Council should have such a process.

I recognize my time on this council is short. It is my intention by docketing this discussion item that we can begin the conversation to establish a set of standards by which we conduct business that is more in line with what you might expect in professional settings, so no one on the council must ever be the recipient of such an inappropriate exchange. And, if one finds themselves the recipient of any inappropriate, unwelcome, or unwanted conduct from a sitting City Councilor, there is a clear process through which the conduct can be investigated and individual(s) can be held accountable, at a bare minimum. I look forward to discussing it further.
