Honorable City Councilors:

I respectfully submit this docket item to this Honorable Council requesting a revision to City Ordinance Sec. 10-28 to change the number of Deputy Chiefs in the Fire Department from five to six. This change will improve departmental management and not change the overall number of FTE positions within the Fire Department.

The proposed ordinance would now read: "There is hereby established a fire department under the charge of the fire chief. The fire department shall consist of the chief of the fire department, one assistant chief of operations, six deputy chiefs...". This section currently specifies that the Fire Department shall have five Deputy Chiefs.

This Deputy Chief position would replace a current Lieutenant position and would not add to the current fulltime employees. In recent years, the Lieutenant position that would be replaced by the new Deputy Chief's position has taken on a much larger administrative role within the department, a role more appropriate for a higher-ranking member. The duties of this Deputy Chief will include but are not limited to: maintenance and upkeep of the department's staffing program; leading the hiring committee; public outreach and relations; serving as the public information officer including media relations and public information requests; developing updates to, and enforcing, policies and procedures; and providing training.

The creation of this additional Deputy Chief position would also improve the department's current span of control. At this time there are up to ten individuals who report directly to the Assistant Chief. The additional Deputy Chief would allow some of these employees to report to the newly established Deputy Chief.

Attached is a memo from Fire Chief Greg Gentile with additional details.

I respectfully request to docket a revision to City of Newton ordinance Sec. 10-28. I request to revise this section, changing the number of Deputy Chiefs from five to six. The ordinance would now read: "There is hereby established a fire department under the charge of the fire chief. The fire department shall consist of the chief of the fire department, one assistant chief of operations, six deputy chiefs...". This section currently specifies that the Fire Department shall have five deputy Chiefs.

I believe the Fire Department would greatly benefit from an additional Deputy Chief position. This Deputy Chief position would replace a current Lieutenants position and would not add to our current full time employees. In recent years, the Lieutenants position that would be replaced by the new Deputy Chief's position has taken on a much larger administrative role within the department which would be more appropriately completed by a higher ranking member. These duties include but are not limited to: maintenance and upkeep of our staffing program, leading our hiring committee, public outreach and relations, public information officer including media relations and public information requests, updating and enforcing policies and procedures, and training. Having an additional Deputy Chief would also improve the current span of control. At this time, we have up to ten individuals who report directly to the Assistant Chief. The additional Deputy Chief would allow some of these employees to report directly to the newly established Deputy Chief, adding a layer underneath the Assistant Chiefs level, decreasing the Assistant Chief's span of control.
