25-01 HIS HONOR THE MAYOR requesting authorization to appropriate and expend \$250,000 from Budget Reserve for the purpose of supplementing the overtime account in the Fire Department.

29-01 HIS HONOR THE MAYOR requesting authorization to appropriate and expend \$283,000 from Budget Reserve for the purpose of supplementing the snow and ice accounts in the Department of Public Works.

28-01 HIS HONOR THE MAYOR requesting authorization to appropriate and expend \$30,230.34 in order to fund the cost of items set forth in the labor contract agreed upon with the American Federation of State, County, and Municipal Employees, Building Inspectors, Local 3092B.

#518-00 HIS HONOR THE MAYOR requesting adoption of an ordinance providing for the acceptance of gifts of tangible personal property by the mayor, a department, board, agency, or commission. **(SUBCOMMITTEE APPOINTED: GERST, PARKER, R. LIPOF ON 12/11/00.)**

#158-00 ALD. COLETTI requesting review and discussion of the fifteen items identified in the Powers & Sullivan management letter of December, 1999, including actions taken thus far and the city's status as it prepares for the next financial audit.

89-99 ALD. CICCONE AND ANTONELLIS recommending that there be a requirement that all H-grade employees hired in the future who will earn an annual salary in excess of \$60,000 reside in Newton.

#350-98 ALD. CICCONE requesting discussion regarding the demand for (vs. the current number of) Constables in Newton, and the possibility of creating an ordinance which would require Police background checks on each Constable candidate prior to his/her appointment/reappointment.

#362-93(C) FINANCE COMMITTEE proposing that a fee for non compliance be set in order to assist the Fire Department in enforcement of MGL Ch.148, Section 56.

#295-96 ALD. COLETTI requesting that the Comptroller of Accounts and the Director of Personnel implement a Weekly Payroll Time Sheet to monitor attendance for all salaried City of Newton employees.

#296-96 ALD. COLETTI requesting that the Mayor and Board of Aldermen create a policy which defines the circumstances regarding the earning and use of Compensatory Time by all H-Grade employees.

#297-96 ALD. COLETTI seeking adoption of a new Ordinance which would require public disclosure of all outside employment and consulting work conducted by City of Newton employees earning above a certain level of compensation for serving as a Department Head or Assistant Department Head.

#174-99 ALD. CICCONE requesting that Board of Aldermen staff members be removed from their current "H-grade" status and that all future salary adjustments be governed by City Ordinance, in the same manner as the Board of Aldermen sets the salary for the City Clerk.

#128-98 ALD. PARKER, SANGIOLO, MERRILL, MANSFIELD requesting an adjustment to the water and sewer rate structure to allow rate relief for low-volume water and sewer users.

#476-97 ALD. SAMUELSON, LIPSITT, PARKER & COHEN requesting that the Board of Aldermen consider options that could be provided to City of Newton employees to provide additional family members, blood relatives, etc. with health benefits.
