Below is a link to the content of the presentation we will be delivering on March 27th. There are 4 tabs in this file:

- 1. Questionnaire responses. These are the un-edited comments collected from the public-facing questionnaire that we created and launched almost one month ago.
- 2. Themes. This working group synthesized all of the responses into a series of themes in order to make them manageable and actionable. This portion of the work is relatively subjective process, but we have taken every measure to capture all of the voices we heard in the responses.
- 3. Full list of Recommendations. The group then worked together to create a list of actions that we believe will help to resolve the issues identified within the themes.
- 4. Final Recommendations to City Council. The full list of recommendations was then prioritized to arrive at a smaller list of actions that we believe are actionable, would be impactful to our mission.

On March 27th, during the city council's Committee of the Whole meeting, we will talk through this content with a focus on recommendations. The purpose of that meeting is to discuss and agree on these recommendations, to continue to move to implementation.

We encourage everyone to read the responses from the public, and consider which recommendations might have the most impact for the city council to act on.
