- ☐ **Virtually:** if you wish to offer public comment virtually, please submit your NAME, ADDRESS and TOPIC by email with the subject line: "Public Comment for [DATE]" to [schoolcommittee@newton.k12.ma.us](mailto:schoolcommittee@newton.k12.ma.us) at least 30 minutes PRIOR to the official start time of the meeting. When the School Committee chairperson calls your name, you will be permitted to unmute your microphone and turn on your video. You will have 3 minutes to deliver your comments.
