


## Mission

To provide effective, professional, caring, and ethical legal advice and representation to all elected and appointed officials and to all City departments to enable the City government to operate at maximum potential while minimizing risk.



The Law Department for the City of Newton provides in-house counsel representation and legal support to the City, its departments, boards, and commissions, as well as to the officials and employees of the City in all areas of municipal law. This includes supporting the City in its work with all nine City unions as well as representing Newton before federal and state courts and administrative agencies in matters of civil litigation; personal injury and other torts; civil rights; labor and employment; education law; contracts; land use; zoning; real estate acquisitions, dispositions and development public construction; public records; and

open meeting and conflict of interest laws.

The staff in Newton's Law Department continues to work hard and with success to provide sound, independent legal advice on policy matters important to the City and to defend the City in litigation matters. This past year, the Law Department maintained strong, flexible and creative support to departments, the City Council and City employees as we managed a number of challenging issues.

#### Recent noteworthy accomplishments include:

- Support to the City during unprecedented public teachers strike
- Provided legal support in passage of Village Center Zoning
- Successfully defended appeal of NewCAL development
- Provided guidance to the Planning Department and the Zoning Board of Appeals (ZBA) on achievement of 40B safe harbor
- Provided assistance to ZBA on passage of Northland 40B project and ongoing consideration of three additional 40B projects
- Advised on sustainability initiatives, including implementation of the State's Municipal Fossil Fuel Free Building Construction and Renovation Demonstration Project, enactment of the specialized energy code and adoption of the plastics reduction ordinance
- Provided legal support in executing pivotal contracts, including new health insurance provider contract, a new trash hauler contract, and contracts for solar placement on city buildings and facilities
- Assisted Newton Public Schools on studentbased disciplinary issues and discrimination investigations, including those governed under Title IX
- Asserted claims to recover thousands of dollars for damaged police and fire vehicles, including \$45K for damaged police cruiser
- Successfully defended multiple license to carry firearms appeals


- Provided legal support in comprehensive amendments to the City's tree ordinance
- Assisted on the drafting and passage of ordinances such as craft beverage zoning and vibration control ordinance
- Supported the Clerk's office for election recount
- Supported Health and Human Services enforcement efforts concerning rodents, tobacco and sanitary code violations
- Supported Inspectional Services
   Department enforcement, including filing multiple criminal complaints
- Supported the enforcement of leaf blower ordinance, including multiple criminal complaints; recovered thousands of dollars through demand letters
- Assisted the Planning Department and the Newton Community Development Authority with managing affordable housing programs and initiatives
- Led transition of cannabis Host Community Agreements under new legal framework enacted by state legislature and the state Cannabis Control Commission
- Provided support to Mayor and departments regarding the opening and operation of shelters in Newton to address migrant/housing crises
- Supported the Department of Public Works in the change out of all water meters
- Responded to increasing number of public records and subpoenas

In FY2025, the Law Department looks forward to continued success in representing the City in litigation matters and to working with the City Council, Mayor and Executive Office and all departments to support them in continuing and new initiatives.

# Law Department Fiscal Year 2025 Outcomes and Strategies

## Outcome 1

Support Land Use Decision Making

The Law Department provides legal advice regarding all land use matters, including zoning, special permitting, ordinance drafting, construction, conservation restrictions, zoning enforcement and disposition of real estate to the Executive

Office, City Council, Planning Department, Department of Inspectional Services and Engineering Department. We staff and provide legal support to the City Council committees concerned with land use, specifically Land Use, Zoning and Planning and Real Property Reuse, and the Zoning Board of Appeals and historic commissions. In addition, we provide litigation advice and defense of City Council special permits as well as for decisions of the Zoning Board of Appeals and the historic commission.

In FY 2025, we will continue to provide legal support for the implementation of MBTA Communities zoning, assist with the reuse process for the use of the newly acquired Walker Center parcel for affordable housing, and provide guidance to the ZBA on the City's Chapter 40B safe harbor status. We will also continue to work closely with City departments to address abandoned and nuisance properties, and pursue compliance orders and recovery to the City of unpaid fines as a result of code violations.

The Department is an active partner to the City Council, regularly furnishing legal opinions and advice on legislative matters. We continue to provide advice on the law as it relates on proposed docket items and to assist in drafting related orders, ordinances and home rule petitions.

## Outcome 2

Provide Advice on Legislative Matters

In FY 2025, the Law Department will work directly with Newton Public Schools on an updated and comprehensive update to the school department's Title IX policy and protocol to ensure compliance with new and upcoming regulations as well as provide support and advice to the City Clerk's office to prepare the ballot question for repeal of the winter parking ban for presentation to voters during the next local election.

The Department also looks forward to working with the Council on their legislative priorities as they emerge and evolve during the coming fiscal year.

# Law Department Fiscal Year 2025 Outcomes and Strategies

## Outcome 3

Manage Litigation and Claims

The Law Department defends, prosecutes, and commences all legal actions and other matters on behalf of the City, including the Newton Public Schools, in all state and federal courts and administrative agencies, from the filing of an initial Complaint

through the trial and appellate stages of the case.

The Department also provides defense to the City from claims for damages to personal property or for injuries. We investigate these claims and provide advice to the City in defending the matter or reaching fair resolution. In addition, the Department continues to focus efforts on assessing our own losses in order to pursue opportunities for affirmative recovery of damages sustained by the City.

Continuing in FY2025, the Law Department will work in conjunction with specialized outside legal counsel to defend Boston College's legal challenge of the City's taking of Webster Woods by eminent domain. Other notable litigation that will be a focus for the Law Department includes a pending wrongful death lawsuit against the City and defending actions of the Newton Historical Commission and City officials across four pending litigations concerning the unauthorized demolition of a historic property at 29 Greenwood Street.

The Law Department works closely with the Human Resources Department as wells as City department heads to address personnel matters, manage employee grievances and arbitrations, and to negotiate collective bargaining agreements with the City's unions.

## Outcome 4

Assist in Labor and Employment Matters and Collective Bargaining

In collaboration with Human Resources, we will complete the City's project to integrate all MOAs, MOUs and CBAs with each union to a comprehensive contractual agreement. The Department, along with outside specialized counsel, is currently in negotiations with those unions whose contracts have expired and, in FY 2025, we will begin negotiations with those bargaining units whose contracts are set to expire during the course of the close of this fiscal year. The Department anticipates representing the City's interests in multiple grievances, arbitrations and other union related disputes. We will also continue to work closely with the Human Resources Department on addressing personnel matters, updating employee policies, and hiring practices.
