Instructions Regarding your Excise Tax Bill

- An application for Abatement does not stay collection of the Motor Vehicle Excise Tax. In order to avoid interest, charges and fees, your excise tax bill must be paid thirty (30) days from the bills issue date.
- If you wish to apply for an abatement on your excise tax bill, print and fill out the form below and return it to the Excise Department at the address on the bottom of the form. Abatement applications must be filed by December 31, of the following tax year.
- In the event an abatement is granted due to sale, trade, theft, total loss, removal of the vehicle from the City of Newton, or overvaluation, the amount abated will be refunded to you if you owe no prior balances.
- Refunds are processed by the collector's Office within 6-8 weeks. You can reach them at 617-796-1330.

Note: Refunds and abatements of less than \$5.00 may not be granted and no abatement may reduce the excise bill to less than \$5.00. (M.G.L. Ch. 60A)
