Top three things you should know:

- We are holding our Annual Open Enrollment period for our Flexible Spending Account (FSA) plans.
- We are announcing exciting changes to our dental insurance options through Blue Cross Blue Shield and holding a *Special Open Enrollment* period for benefits effective January 1, 2025.
- We are announcing that our Life Insurance plans will transition as of January 1, 2025 to The Hartford.

No action needed unless you wish to update your beneficiary information or terminate your plan.

- Dependent Care Reimbursement
 Account— \$5,000 annual max

New Dental provider for 2025

Blue Cross Blue Shield Dental Blue Freedom will be the new dental provider starting January 1, 2025. The new 2025 plan provides enhanced benefits and a broader network than before. All employees currently enrolled in a dental plan will receive a Dental Blue Freedom ID card in the mail prior to January 1, 2025.

New Dental Provider for 2025!

BCBS Dental Blue Freedom will be our dental provider starting January 1, 2025. If you are currently enrolled in Guardian Dental, your plan will remain in effect until December 31, 2024 and automatically transition as of January 1, 2025 to BCBS Dental Blue Freedom.

If you are currently enrolled in a Guardian Dental insurance plan and you do not want to make changes, NO ACTION IS REQUIRED.

Introducing The Hartford Life Insurance

Beginning January 1, 2025, The Hartford will become the city's new Life Insurance carrier. There will be no changes to your basic and supplemental life insurance benefit level.



This is informational only as new enrollment is not available at this time for existing employees. Therefore, NO ACTION IS NEEDED.

Here are a few key things to keep in mind:

- **Update Your Beneficiaries**: This is the perfect time to ensure your beneficiary information is upto-date. If you are unsure who you have designated as your beneficiary, we strongly encourage you to complete a beneficiary form to reflect your wishes. Forms can be located at this <u>link</u>.
- **No Action Needed**: Your existing life insurance coverage will automatically transfer to The Hartford. No action is required unless you wish to terminate your policy or update your beneficiary.

Flexible Spending Accounts (FSA)



RE-ENROLLMENT IS REQUIRED IF YOU WANT TO PARTICIPATE IN AN FSA PLAN IN 2025

Annual Open Enrollment for FSA plans will also be held November 1st through November 30th, with plans effective January 1, 2025. FSAs allow you to set aside pre-tax dollars for eligible medical, dependent care, and commuting expenses, helping you save up to 30% on these costs depending on your tax situation.

Types of FSAs Available:

Medical: Cover out-of-pocket medical, dental, and vision expenses. This upcoming year, you can set aside up to \$3,300 annually.

Dependent Care: Save for daycare expenses for children or dependent adults, with a limit of \$5,000 per family per year.

Commuting: Set aside up to \$325 per month (up to \$3900 per year) for qualified transportation and parking expenses.

Key Points:

- **<u>Re-enrollment Required</u>**: Remember, FSA plans do not roll over automatically. You must re-enroll each year if you wish to continue using these benefits.
- If you have a 2024 FSA plan, be sure to check your balances and use any unused funds by the deadline.
