# Newton Sustainable Materials Management Commission (SMMC) Meeting Minutes Thursday, September 26, 2024, 7:00 p.m. Remote Meeting via Zoom

# **Improving Waste Reduction in Schools:**

Andrew Thompson, a Newton HS South teacher and member of the Green Captains Program, joined the meeting and reported on the status of this program at Newton South high school:

- This stipend position is currently funded with MassDEP RDP grant funds;
- It is anticipated that funds/rebates from the Helpsy program will fund future years;
- The Green Captains positions are filled in all Newton Schools;
- Goals of the program include: expand recycling in the schools; begin composting where feasible; work with students interested in recycling/solid waste reduction; better coordinate recycling programs with the Facilities staff (custodians).

Ms. Kahng asked members of the SMMC to email her if they are interested in being on a sub-committee to work on waste reduction in the schools. Ms. Trabert will provide the Commission with available resources to assist in this effort. It was also suggested that Commission members identify examples of recycling/solid waste issues in the schools that may need attention.

### **Approval of July 22, 2024 Meeting Minutes:**

On the motion by Mr. Smith, seconded by Ms. Kessler, the Meeting Minutes of July 22 were approved, 6-0-2 on a roll call vote. Ms. Slote, Mr. Valente, Ms. Kessler, Mr. Ferrey, Ms. Kahng and Mr. Smith voting yes. Ms. Rambelle and Mr. McKay abstaining.

Ms. Kahng also pointed out that this is Ms. Slote's final SMMC meeting, as her term is ending, having served two terms. She thanked Ms. Slote, recognizing her many accomplishments and contributions to the Commission.

## Discussion of Scope of Comprehensive Zero Waste Plan/Long-Term Plan:

Ms. Trabert reported that:

- One proposal was submitted in response to the RFP
- Mid-Atlantic Waste Consultants was the selected consultant
- The various tasks for the consultant were reviewed (also a handout)

• The work is expected to be completed by December 2025

The SMMD update was deferred to a subsequent meeting.

- Ms. Kessler commented on how well the recent hazardous waste collection day was organized.
- In response to a question from Ms. Kahng, Ms. Trabert commented that the City is not currently collecting data on the food waste drop-off bins, but that Resy is developing an application/portal that will show this information.
