STEELE petition to AMEND Special Permit #62-01, granted in May, 2001, for a rear addition above a rear porch, to allow the placement of fill where the existing contours of the land are to be altered by more than three feet and to replace the existing site plan to reflect the new grades at 105 TEMPLE STREET, Ward 3, WEST NEWTON, on land know as Sec 32, Blk 12, Lot 8, containing approx 14,861 sf of land in a district zoned SINGLE RESIDENCE 2.
