**HELD:** Marcia Cooper, President of Green Decade and Jay Walter, EcoTeam Project Co-Chair of Green Decade joined the committee to introduce the item. Mr. Walter shared that this proposal is about making our consumer world more sustainable by making manufacturers more responsible for what they produce. This is accomplished by insisting that they reclaim the waste that they produce and reuse it. This would halt the now ubiquitous process of taking resources, producing goods, and throwing resources away. Requiring that they reclaim the waste from their products would incentivize the manufacturers to recycle those resources as it would not be economical to pay to throw them away, only to then go acquire more new resources. Mr. Water explained that the purpose of this resolution is to express support.

Ms. Cooper added that the e-waste bill that's part of the EPR resolution would save Newton considerable costs. Residents would not need to pay to recycle their electronics for instance. She informed the committee that local governments in California, British Columbia, northwest Wisconsin, Vermont, Texas have all formed product stewardship processes. Additionally, many other communities in Massachusetts, including Amherst, Cambridge, Carlisle, Concord, Salem, Springfield, Worcester, have all come out with resolutions in favor of this bill.

Members of the Committee expressed that they agree with the idea and think this is a good first step, but question how this will be implemented especially given the potential legal problems that could arise regarding interstate commerce.

It was explained that a method for how to go about this hasn't yet been developed by the state, but that this is something created by environmental groups to encourage a state level initiative. Ald. Baker made the motion to approve the item which carried unanimously.

**NOTE:** Former Alderman Coletti joined the committee to discuss his proposal that the city impose a 1.5% surcharge on residents, similar to the process in which the Community Preservation Act (CPA) is funded; the purpose of this surcharge would be to create a Capital Preservation Fund. Ideally, Mr. Coletti would, in time, like to see the state create a match for this as they do CPA funds, but stressed that this is necessary because the city needs a mechanism short of a debt service override, as debt service overrides are continuous and all for certain periods of time. Seed money for the Capital Preservation fund is necessary as the city needs a dedicated source for capital projects. Mr. Coletti encourages the committee to vote this at the start of the next term so that the Mayor can have this before the budget is put in place and so that it can be put on the ballot next November.

Ald. Baker expressed that there is a legal and policy issue in that generally speaking property needs to be taxed on a uniform basis, so you need a statewide authorization. He expressed hesitation for how easy it would be constitutionally for the city to be able to get a special surcharge for this. He stated that the implementation of the CPA surcharge was different as it was created locally under existing state legislation. Before this is pursued, Ald. Baker would like the City to understand the legal questions so that we can know whether or not this is able to move forward. Maureen Lemieux, Chief Financial Officer, opined that this discussion belongs within the CIP discussion. She stated that it's clear that another source of funding is needed, and that the best approach will be decided in the near future.

Ald. Baker moved referral of this item, and the Committee requested that the docketers confer with the law department before this goes any further. The motion to refer carried unanimously.

#### **RESOLUTION NO.**

#### RESOLUTION OF THE CITY OF NEWTON SUPPORTING EXTENDED PRODUCER RESPONSIBILITY (EPR)

WHEREAS, manufactured goods and packaging constitute nearly three quarters of the materials managed by U.S municipalities at considerable costs; and

**WHEREAS**, there are significant environmental and human health impacts associated with improper management of hazardous products; and

WHEREAS, products and packaging are often toxic or disposable by design, and local governments have no input into the design or marketing of products, make no profit from the products, and do not have the resources to adequately address the rising volume of discarded products and associated packaging; and

WHEREAS, Extended Producer Responsibility (EPR) is an environmental policy approach in which producers (brand owners or first importers into the State) accept responsibility for management of their discarded products, so that those who produce and use products bear the costs of recycling and responsible disposal; and

WHEREAS, when producers are responsible for ensuring that their products are reused or recycled responsibly, and when health and environmental costs are included in the product price, there is an incentive to design products that are more durable, easier to repair and recycle, and less toxic; and

WHEREAS, the Massachusetts Department of Environmental Protection Draft Solid Waste Master Plan: Pathway to Zero Waste, 2010-20 includes producer responsibility as one of five major components of the Plan; and

WHEREAS, the Massachusetts legislature has enacted producer responsibility programs for certain mercury-containing products; and

WHEREAS, 32 of the states in the US have EPR laws; and

WHEREAS, jobs in disassembly, reuse, repair and recycling are generated by EPR, offering significant local economic development opportunities; and

WHEREAS, the City of Newton supports statewide legislation to hold producers responsible for product discard management and other product waste management costs,

WHEREAS, Framework EPR codifies the EPR principle and would give the Massachusetts Department of Environmental Protection the authority to address multiple products over time; and

WHEREAS, the City of Newton supports the mission of the Massachusetts Product Stewardship Council, working with other Massachusetts municipalities and other states to move EPR policy forward, and supports the *Framework Principles for Product Stewardship Policy* adopted by seven Product Stewardship

# <u>Appendix</u>

## Framework Principles for Product Stewardship Policy

The following principles are intended to guide development of product stewardship policies and legislation that governs multiple products. It is primarily aimed at state legislation but is also intended as a guide for local and federal policy.

#### **1. Producer Responsibility**

- 1.1 All producers selling a covered product into the State are responsible for designing managing, and financing a stewardship program that addresses the lifecycle impacts of their products including end-of-life management.
- 1.2 Producers have flexibility to meet these responsibilities by offering their own plan or participating in a plan with others.
- 1.3 In addressing end-of-life management, all stewardship programs must finance the collection, transportation, and responsible reuse, recycling or disposition of covered products. Stewardship programs must:
  - Cover the costs of new, historic and orphan covered products.
  - Provide convenient collection for consumers throughout the State.
- 1.4 Costs for product waste management are shifted from taxpayers and ratepayers to producers and users.
- 1.5 Programs are operated by producers with minimum government involvement.

#### 2. Shared Responsibilities

- 2.1 Retailers only sell covered products from producers who are in compliance with stewardship requirements.
- 2.2 State and local governments work with producers and retailers on educating the public about the stewardship programs.
- 2.3 Consumers are responsible for using return systems set up by producers or their agents.

#### 3. Governance

- 3.1 Government sets goals and performance standards following consultation with stakeholders. All programs within a product category are accountable to the same goals and performance standards.
- 3.2 Government allows producers the flexibility to determine the most costeffective means of achieving the goals and performance standards.

#### NOW, THEREFORE BE IT RESOLVED THAT THE CITY OF

**NEWTON** gives notice to the Commonwealth of Massachusetts and to manufacturers and distributors of products and packaging sold in the Commonwealth, that it supports the transfer of responsibility for the costs of managing discarded products to producers (brand owners and first importers), under oversight of the Massachusetts Department of Environmental Protection; and

**BE IT FURTHER RESOLVED,** that the City of Newton departments be authorized to send letters to the State legislature and State associations and to use other advocacy methods to support EPR legislation; and

**BE IT FURTHER RESOLVED,** that the City of Newton urges the Massachusetts legislature to enact EPR legislation for discarded electronic waste this year, and

**BE IT FURTHER RESOLVED,** that the City of Newton urges the Massachusetts legislature to enact comprehensive EPR legislation based on the *Framework Principles for Product Stewardship Policy*; and

**BE IT FURTHER RESOLVED,** that the City of Newton will work with the Massachusetts Product Stewardship Council and the Massachusetts Department of Environmental Protection to enact EPR legislation and regulation.

- 3.3 Government is responsible for ensuring a level playing field by enforcing requirements that all producers in a product category participate in a stewardship program as a condition for selling their product in the jurisdiction.
- 3.4 Product categories required to have stewardship programs are selected using the process and priorities set out in framework legislation.
- 3.5 Government is responsible for ensuring transparency and accountability of stewardship programs. Producers are accountable to both government and consumers for disclosing environmental outcomes.

#### 4. Financing

Producers finance their stewardship programs as a general cost of doing 4.1 business, through cost internalization or by recovering costs through arrangements with their distributors and retailers. End of life fees are not allowed.

#### 5. Environmental Protection

- 5.1 Framework legislation should address environmental product design, including source reduction, recyclability and reducing toxicity of covered products.
- 5.2 Framework legislation requires that stewardship programs ensure that all products covered by the stewardship program are managed in an environmentally sound manner.
- 5.3 Stewardship programs must be consistent with other State sustainability legislation, including those that address greenhouse gas reduction and the waste management hierarchy.
- 5.4 Stewardship programs include reporting on the final disposition, (i.e., reuse, recycling, disposal) of products handled by the stewardship program, including any products or materials exported for processing.

Contamination clean-up from discarded products is an additional burden on taxpayers.

## Extended Producer Responsibility (EPR) requires manufacturers to pay for the collection and recycling of their products:

Gives producers an incentive to design products that are less toxic, and more reusable and recyclable.

Allows the recycling or disposal costs to be incorporated into the purchase price of a product so that these costs are shared by the producer and consumers of that product—not the taxpayer.

#### Relieves the financial burden on local governments. Protects the environment.



## Framework EPR: a consistent process

Well-developed EPR (Extended Producer Responsibility) principles outline roles for government, industry, retailers and consumers. Legislation places most responsibility on those who design and market products: the producers.

EPR requires brand owners (or first importers) of covered products to plan for, and pay for, the collection and reuse or recycling of their products.

- With stakeholder input, state governments set goals and standards.
- Producers have the flexibility to design cost-effective means of reaching goals and standards.
- Retailers only sell the designated products from producers who are in compliance of the stewardship requirements.
- State and local governments work with producers and retailers to educate the public about stewardship programs.
- Consumers are responsible for using return systems set up by producers.
- Paying for discard management gives producers a financial incentive to design products that are less wasteful and easier to repair or recycle.
- The state regulatory agency designates additional product categories to be included in the program over time.

## Two ways to support EPR in Massachusetts

**1.** Ask your Senator and Representative to pass EPR laws filed in the Legislature this session. Find their contact information at http://www.malegislature.gov/People/FindMyLegislator.


EPR laws for electronic waste and for mercury- containing lamps and thermostats would protect public health and the environment.

The **Framework EPR** bill would (1) eliminate the need to pass new legislation for each new product category (2) provides a clear and predictable process and (3) incorporate opportunity for stakeholder and producer input in developing the details related to each product category.

2. Urge your city or town to join the Massachusetts Product Stewardship Council (MAPSC). No dues! The MAPSC represents the interests of cities and towns: budget relief, new jobs in reuse and recycling, products designed for easy disassembly, repair, or recycling, with no toxic components.
