Ms. Mondshein is an attorney and has worked with civil rights and fair housing issues working with investigations and was supervisory attorney in charge of the legal aspects. She has worked with investigations and settlements of fair housing complaints. In addition, she has also been teaching housing discrimination at various law schools. Ms. Mondshein has taught at Suffolk University, New England School of Law, and Roger Williams Law School and is strongly committed to Human Rights as well as civil issues. She did work on juvenile justice issues and rights of persons in Houses of Correction and for a number of years was a special Assistant Attorney General in Massachusetts where she developed and helped pass the alternative judicial dispositions for persons operating under the influence of liquor. She would like to help the city enhance its commitment to fair housing and contribute her expertise to this effort.

ACTION: APPROVED 7-0

NOTE: Back-up information on this item explained this was money that has to be paid to the spouses of veterans. This program is reimbursed 75% by the state to the City.

Ald. Parker said that he would hope that before this item is discussed at the Finance Committee meeting, there would be clarification on whether the amount in the budget would be a realistic number for next year.

The Committee voted to approve 7-0.

ALD. YATES, & ALD. SCHNIPPER proposing an amendment to the Rules and Orders of the Board stating that when the City Clerk/Clerk of the Board position is to be filled, a search committee shall be established consisting of representatives of all sectors of the board (officers, chairs rank and file) employees of the department, department heads who frequently interact with the Clerk's office and lawyers and other representatives of the public who frequently interact with the Clerk's office.

ACTION: HELD 7-0 (Ald. Sangiolo absent)

NOTE: This item was voted out unanimously by the Rules Sub-Committee. An amendment had been arrived at by the co-docketors that would propose to the Board that when the City Clerk/Clerk of the Board position is to be filled, any search committee established shall include representatives of all sectors of the Board (officers, chairs, rank and file). That was voted out of the Rules Sub-Committee 3-0.

In Ald. Parker's opinion this item needed more work and should be held. There was also some discussion that the need for this item had disappeared as it may have been a reaction to what happened with the selection process.

Ald. Coletti felt there should be verbiage included that states that in the event a Board determines not to reappoint, there should not be a necessity to go through this whole process. If it is a reappointment, there would not be a need for something like this docket item.

In conclusion Ald. Hess-Mahan stated that the lack of a formal rule was of concern to some of the aldermen.

Since Ald. Yates was ill and Ald. Schnipper was chairing Public Facilities, Ald. Parker moved hold and the Committee voted 7-0.
