ITEMS SCHEDULED FOR DISCUSSION:

- #105-06 <u>STUART LIPOFF</u>, 192 Kirkstall Road, Newtonville, requesting a discussion of the decision on January 18, 2006 by the Newton Library Director requiring a search warrant from investigators looking into the source of a threat e-mailed to Brandeis University prior to providing access to the Newton Library public access computers, including the possibility of a review of guidelines for future decisionmaking by the director relating to library records, if and when such an incident were to recur.
- #106-06 <u>ROBERT L. CERRA</u>, 77 Auburn Street, Newton requesting that the Newton Board of Aldermen conduct an inquiry into the manner in which the City of Newton responded to a request by law enforcement authorities for assistance. This event which took place on January 18, 2006 at the main library has generated extensive and conflicting media reports, raised public concern and warrants a public review.
- #94-06 <u>HIS HONOR THE MAYOR</u> requesting an appropriation in the amount of \$280,000 from Budget Reserve for the purpose of supplementing the FY06 School Department budget . The School Department will use these funds to supplement its various energy accounts.
- #20-06 <u>ALD. YATES, & ALD. SCHNIPPER</u> proposing an amendment to the Rules and Orders of the Board stating that when the City Clerk/Clerk of the Board position is to be filled, a search committee shall be established consisting of representatives of all sectors of the board (officers, chairs rank and file) employees of the department, department heads who frequently interact with the Clerk's office and lawyers and other representatives of the public who frequently interact with the Clerk's office.

#437-05 <u>ALLAN CICCONE</u>, 22 West Street, Newton, requesting the Board of Aldermen file a home rule petition amending the Charter re filling vacancies on the Board of Aldermen and School Committee so if an alderman or school committee member resigns or dies while in office, the runner up to that person in the last election



would fill that vacancy. If there is no runner up for this person the Mayor, with the approval of the Board of Aldermen, would appoint a citizen in that district to fill that vacancy.

rights for permanent resident aliens residing in Newton.Item recommitted by Full Board on February 7, 2005
- #47-05 <u>ALD. SANGIOLO</u> requesting amendment to the Tree Preservation Ordinance to provide a provision for notification to the Board of Aldermen of any price adjustment for payment for trees removed in accordance with the ordinance.
- #225-05 <u>ALD. JOHNSON, DANBERG, FISCHMAN, HESS-MAHAN, PARKER AND</u> <u>SANGIOLO</u> requesting a 3 month, 6 month, and 12 month update regarding the reorganization of the Health and Human Services organization in light of the Board's concern that there was an insufficient focus on youth services.
