Note: Commissioner of Public Works Jim McGonagle presented the request to transfer \$1,000,000 for snow and ice removal. He noted that there have been seven snow events resulting in 17" and that the item may be amended prior to the full Council vote due to upcoming snow events. Commissioner McGonagle noted that while there has not previously been procedure for communicating directly with the Superintendent of schools when unexpected weather conditions may require delayed openings. Going forward the Commissioner agreed this will be incorporated. With a motion from Councilor Albright to approve the item, the Committee voted 7-0 in favor.

#32-17 <u>HIS HONOR THE MAYOR</u> requesting authorization to transfer the sum of fifty-five thousand dollars (\$55,000) from the Department of Public Works Engineering Full-time Salaries Account to the Department of Public Works Engineering, Engineering Services Account to hire engineering consultants to prepare final engineering design services for the Newton Corner ADA Ramp and Sidewalk Improvements Project. [01/30/17 @ 3:39 PM]

Action: <u>Public Facilities Approved 7-0 (Danberg not voting)</u>

Note: Commissioner McGonagle presented the request to transfer funds within the Department of Public Works in order to fund design services for the Newton Corner sidewalk

improvements. The improvements will include curb cuts, access ramp installations and the removal of deteriorating brick at the site. As the City's in house engineer left during the summer, this expense for design was unanticipated. Commissioner McGonagle noted that the total budget for the project is \$353 thousand dollars and that funds will come from the DPW's operating budget, COD and CDBG. Committee members requested that budget details be provided for the Finance Committee meeting. Councilor Lennon motioned to approve the item which carried unanimously.

#33-17 <u>HIS HONOR THE MAYOR</u> requesting authorization to appropriate and expend one hundred twenty-one thousand dollars (\$121,000) from Free Cash for the purpose of funding additional design engineering services for the West Newton Square Rehabilitation Project. [01/30/17 @ 3:39 PM]
 Action: Public Facilities Approved 7-0 (Albright not voting)

Note: Commissioner Mcgonagle presented the request to appropriate \$121 thousand dollars from free cash to fund additional design services needed to complete the construction documents for the West Newton Square project. Because this project is the first project to be fully designed with Complete Streets specifications, the design and corresponding funding is greater than originally anticipated. The scope of the project has grown to include bike lanes, storm water improvements and state of the art streetlights. Committee members noted that as the City has adopted the Complete Streets policy, other projects will also have increased budgets. Commissioner McGonagle confirmed that the design will not prevent a left turn from Watertown onto Washington Street. With a motion from Councilor Brousal-Glaser, the Committee voted unanimously to approve the item.

 #386-16 MWRA loan financing for homeowners to replace lead service lines <u>COUNCILORS CROSSLEY AND GENTILE</u> proposing to establish policies and procedures for the use of approved Massachusetts Water Resource Authority (MWRA) no interest loan financing to encourage homeowners to participate in the lead service line replacement program. [10/26/16 @ 3:12 PM]

 Action: Public Facilities Approved 8-0

Note: Mr. Jerdee presented details of the Lead Service Replacement Program to the Committee. The Department of Public Works examined its property records to identify possible existing lead service mains. After identifying and contacting 585 homeowners with potential lead service, DPW sent staff to mark the necessary work and an engineer to determine public and private costs (attached) on each property, which varies based on the complexity of the work. It was noted that while the replacement cost estimates on private property are for standard paving, loam and seeding; any custom paving or landscaping would be at the expense of the homeowner. Commissioner McGonagle noted that the cost estimates include a 20% contingency and are conservative.

The DPW intends to advertise the bid as soon as possible and send certified letters detailing the Lead Service Replacement Program and cost estimates to the affected homeowners. He noted that efforts to coordinate the time and construction path with the contractor will be essential to maintaining the timeline. DPW aims to complete construction by June 2018. Because 23% of homeowners have not responded to the original certified letters notifying them of possible lead service mains, Committee members asked how the DPW plans to address these residences. Mr. Jerdee confirmed that if necessary, department staff will go in person to notify residents.

Councilors discussed the terms of extending the MWRA zero interest loan to residents. It was noted that in the past, homeowners would be required to pay for the replacement by themselves, but this situation is different because the MWRA is incentivizing municipalities to replace lead mains in the City by offering the loan at zero interest. It was emphasized that if a homeowner opts out of the program and the City replaces the public portion of the service main, the change in pressure could result in damage to the homeowner's portion. As the City has the right to maintain their portion, Committee members requested that the letter to residents explicitly explain the risk of opting out. Councilors agreed that the zero interest terms should be extended to residents as a betterment and that the Finance Committee discuss execution with the Law Department. Committee members suggested that the DPW post information about the program online or in the TAB to reach homeowners who have not responded. Committee members requested that the letter for residents be drafted prior to the Finance meeting and reviewed by the Law Department. Councilor Gentile motioned to approve the extension of the loan terms to homeowners where applicable and the Committee voted unanimously in support of the motion.

#31-17 Ordinance Amendment to eliminate sewer cleaning fees

 <u>HIS HONOR THE MAYOR</u> proposing an ordinance amendment to remove Section 29-67A, Sewer cleaning fees from the City of Newton Revised Ordinance, 2012. [01/30/17 @ 3:39 PM]

 Action: Public Facilities Approved 7-0 (Albright not voting)

Note: Director of Utilities Ted Jerdee presented the request to eliminate section 29-67A, Sewer Cleaning fees of the City's ordinances. He noted that the City has been providing the service to residents for \$25. He stated that the service requires up to three staff members, use of costly City equipment and raises liability concerns. Since the fees for the service was raised in 2010 to be closer to actual costs, DPW has seen a reduction in the number of requests from 425 to 131. Mr. Jerdee believes that this is the appropriate time to eliminate the use of the City's resources to maintain private infrastructure. Mr. Jerdee confirmed the City could assist a resident given an emergency situation. With Committee support, Councilor Laredo motioned to approve the elimination of sewer cleaning fees and the Committee voted 7-0 in favor.

Ordinance Amendment to allow City to shut water to allow access

<u>COMMISSIONER OF PUBLIC WORKS</u> proposing revisions to Article II Sec. 29-26 Inspection of water taker's premises to include language to allow the City to shut water off to properties with proper notice in order to allow for the City to inspect, repair or replace Water Meters. [01/30/2017 @ 3:39 PM]

Action: <u>Public Facilities Approved 5-0-1 (Gentile, Albright not voting, Lennon abstaining)</u>

Note: Mr. Jerdee presented the request to revise Sec. 29-26 to allow the City, in the event a property owner cannot be reached, to shut water off to allow for inspection, replacement or repair of water meters on private property. DPW requires the ability to inspect or repair water meters. Mr. Jerdee noted that after numerous attempts to notify; some residents remain unresponsive, or even refuse to allow access. Approximately 300 water meters a year fail and require inspection and/or replacement. The ordinance amendment would allow the City, to shut off the water at a property to inspect, repair or replace the meter. A Committee member questioned whether shutting off the water is necessary or if there may be alternative solutions. It was noted that in the past a fine on the water bill had been successful in alerting homeowners to the City's needs.

It was noted that there are approximately 137 unresponsive property owners who could have their water shut off temporarily as a result of the proposed amendment. When asked if there is a pattern to why residents have not responded, Mr. Jerdee noted that the reasons range from some residents trying to avoid additional expenses to other residents who may have improperly installed irrigation meters. He added that some residents have transponders that have not been paid for. Committee members agreed that DPW should bill the property owners the full amount for these transponders.

Councilor Laredo motioned to approve the item which carried 5-0-1 with an abstention from Councilor Lennon.

Note: The Chair introduced the item to establish/increase the fee for wireless attachment grants of location. The Wireless Subcommittee has been working with the Planning and Fire Departments to establish design guidelines. Fire Department Director of Technical Services, Alex Chadis has indicated that significant City costs are associated with monitoring wireless attachments. The Chair noted that the average filing fee in other municipalities was reported at \$300, but cities, such as Salem, charge a \$500 filing fee. Councilor Laredo motioned to approve and refer the item to Finance for a review of the City's costs and to set the fee. The Committee voted unanimously in favor.

#36-17 Ordinance amendment to require peer review of wires communication attachments

<u>COUNCILOR CROSSLEY, ALBRIGHT AND LAPPIN</u> requesting an Ordinance, pursuant to Mass. General laws Chapter 166, Section 22 and Chapter 44, Section 53G, the adoption of which would enable the City Council to require peer review of grant of location petitions, including proposed wireless communications equipment attachments to poles or structures in the public way (and on public lands), at the petitioner's expense, to assist the Council in deciding requested grants of location.

Action: <u>Public Facilities Held 6-0 (Gentile, Albright not voting)</u>

Note: The Municipal Modernization Law provides that municipalities may require review at the expense of a petitioner seeking grants of location, with the adoption of a local ordinance to that effect.

Background: The Wireless Subcommittee has met with a potential consultant for assistance on drafting guidelines for wireless carriers, peer review of submitted radio frequency reports from wireless carriers petitioning for grants of locations and possibly assisting a comprehensive plan for locating wireless communication equipment across Newton. Committee members are seeking consensus from the Committee so the Law Department can draft an ordinance that will allow for the enactment of the Municipal Modernization Law pertaining to grants of location. Committee members were supportive of the drafting of the ordinance and voted unanimously to hold the item pending a draft from the Law Department.

The Committee adjourned at 8:57 pm.
