<u>NOTE</u>: The Committee met jointly with the Public Safety & Transportation Committee to discuss funding for the additional study and schematic design of Station #3 (Willow Street) and Fire Headquarters. Commissioner of Public Buildings Josh Morse provided the Committees with detailed information, which was attached to the Committee agendas. The Board of Aldermen previously approved \$130,000 for a study of programming and some schematic design at fire headquarters, Station #10 (Dedham Street), and #3 (Willow Street.) The study included recommendations to replace the headquarters and fire station buildings and construct a combined facility for Station 3 and headquarters. The recommendations were supported by a number of findings, such as the lack of space at headquarters and Station #3 and the deteriorated buildings and systems.

The requested funds will be used to confirm and refine the suitability of redeveloping the station and headquarters on site, address program requirements including apparatus bays that front Centre Street, develop a plan to keep and/or relocate the existing, historically significant headquarters building, and develop a plan to relocate the Fire Fighters' Memorial and the 911 Memorial. In addition, the funds will be used to generate plans up to the site plan approval process. The study will also address the need to house the Fire Department's critical support systems in a seismically reinforced building.

The Commissioner has met with the Massachusetts Water Resources Authority (MWRA) regarding the aqueduct located on the fire headquarters site. The MWRA requires enough space around the aqueduct to access it for maintenance. The City has also started preliminary

discussion with the property owner at 1148 Centre Street regarding the sale of that property but it is too early to tell if that is a possibility. Commissioner Morse added that he wants the feasibility process to drive that option. It was pointed out that it may make sense to determine if it is a possibility before the study in order to include it or not as part of the study.

The Public Building Department will continue to work with and update the Board of Aldermen and the working group on this project. The Commissioner expects the feasibility study to be complete within the next six months. At that point, the Site plan approval process should begin. Ald. Lappin moved approval in Public Facilities Committee, which carried unanimously. Ald. Kalis moved approval in the Public Safety & Transportation Committee, which carried unanimously.

NOTE: Commissioner of Public Buildings Josh Morse presented the request for \$1 million for a feasibility study and schematic design services for Cabot School. The Massachusetts School Building Authority (MSBA) has invited the City to participate in the eligibility period for the Cabot Elementary School. The first step in the MSBA process is to undertake a feasibility study to determine the the best options and most cost effective solution for the Cabot School to provide to the MSBA Board of Directors. The feasibility study process and cost for Cabot School will be similar to the Angier and Zervas Elementary School feasibility studies.

The Cabot Elementary School site has some unique issues that will be addressed through the study. There is an aqueduct located on the site that must be considered during the study. The Cabot Elementary School property site was the location of an underground storage tank leak, which was reported to the Department of Environmental Protection in 1990. The site was remediated according to Massachusetts General Law Chapter 21E requirements and declared a clean site by the Department of Environmental Protection. However, the study should take into account that there may be some soil contamination.

The feasibility study will look at all options from renovation to replacement. The chosen option must meet all of the MSBA's requirements for school construction in order to receive funding from the MSBA. The commissioner added that there would be an effort to preserve the Humpty Dumpty statue located on the existing school. With that, Ald. Albright moved approval, which carried unanimously.
