**ACTION:** HELD 7-0

**NOTE:** Director of Environmental Affairs Elaine Gentile provided the Committee with the attached information pertaining to the collection and disposal of "white goods" and bulky items. White goods consist of items such as washers, dryers, water heaters, refrigerators, air conditioners, computers, monitors, televisions, and printers. Bulky items are considered pieces of furniture, rugs, and things of that nature.

White goods are collected weekly on Saturdays but require a resident to call in advance to schedule collection. There is no limit to the amount of white goods that can be placed curbside for collection. The City also accepts white goods at the depot. The City pays \$10 per curbside stop, which includes one television. If there is more than one television, there is a \$10 per television additional pick-up charge. The City pays \$10 per television for depot collection. The cost of white good collection went down in FY 09 due to the metal market. However, this fiscal year the contractor learned that he had to pay prevailing wage to his employees; therefore, the cost of collection rose.

The bulky items are picked-up separately from white goods and are collected on regular collection days. Residents must call to schedule the pick-up in advance and there is a five-item limit per pick-up. Waste Management as part of the trash collection contract collects the bulky items. Ms. Gentile requested information from Waste Management regarding the actual cost of the bulk collection and will provide the information as soon as it is available.

Many other communities charge a fee for the collection of white goods and bulky items. The fee is cost recovery for a service provided by the City. The service is a benefit to the citizens. Ald. Fuller added that the City should look at whether the City should supply the service or if a private contractor could do it more efficiently.

The Chair polled the Committee to determine if there was support of a cost recovery fee for these types of collection. The Committee was in favor of moving forward on a fee proposal. The Chair suggested that a fee proposal should be included in budget discussions. A motion to hold the item for further information carried unanimously.

#55-11 ALD. FULLER, CROSSLEY, ALBRIGHT, DANBERG, FREEDMAN, HESS-

MAHAN recommending that Section 29-67A of the City of Newton Revised Ordinances 2007 regarding sewer clean-out fees be updated either to increase the fee from \$25 during normal hours (\$75 during overtime hours) to a fee more closely representing the full cost of service of cleaning a privately-owned building sewer lateral or, alternatively, eliminating the service. [02/14/11 @ 5:25 PM]

ACTION: HELD 7-0

**NOTE:** Ald. Fuller explained that the item was docketed to determine if the City should be providing sewer clean-outs for privately owned building sewer laterals and if so, how much should be charged for the service. Utilities Director Fred Russell provided background information on sewer clean-outs, which is attached. The property owner is responsible for the sewer line from the house to the street connection. The information provided included a chart of the actual cost to the City for providing the service and the revenues generated by providing the service for the past seven months. The actual cost of the service was \$71,229 and revenues generated were \$6,975, which created a \$64,254 loss to the City.

If the City were to eliminate the service, Public Works employees could be redirected to address a backlog of much needed preventive maintenance on the City's water and sewer infrastructure. Currently, providing the service requires a working supervisor and truck driver to spend 60% of their time addressing sewer clean-outs.

Several Committee members felt that the City needed to be available to respond to emergencies. Mr. Russell responded that 80% of the calls for clean-outs are service calls. Ald. Freedman suggested providing emergency service with a charge to the property owner that recovers the cost of the service.

The Committee members were willing to continue discussion regarding the possibility of eliminating the clean-out service and charging a fee for emergency services that reflects the true cost to the City. The Committee requested that the Utilities Director provide further information regarding the cost of providing the service. Ald. Crossley moved hold on the item for further discussion, which carried unanimously.

NOTE: Ald. Schnipper informed the Committee that the Newton North High School has received a Leadership in Energy & Environmental Design (LEED) Gold Certification. It is the only school building in Massachusetts to receive that certification. However, there have been some issues relating to training custodians to run the new HVAC system. The new systems that have been put in place at both high schools and at some of the middle schools require a certain amount of technical expertise to operate. The School Department is proposing a new position in their budget similar to the position of Facilities and Maintenance Specialist within the Public Buildings Department. The addition of this position should provide the expertise and result in substantial cost benefits. It is expected that the person hired would work closely with the Public Buildings Department.

The abatement process at the old school is on track. The demolition of the old school should be completed in early July. The process is working well and the Department of Environmental Protection is proposing using the abatement process as a model for demolition of other buildings of the same vintage.

Chief Operating Officer Robert Rooney submitted the attached petition from residents along Hull Street requesting reduction of plantings along a 150' portion of the slope along Hull Street on the south side of the multi-purpose stadium as depicted in the attached plan. The residents no longer wish to have the heavy landscaping proposed in the original site plan. The Newton North Liaison Committee has discussed the request for reduced landscaping and has no issues with the proposal. The proposed unused landscaping would be used elsewhere on the Newton North High School site. The Law Department has been consulted and is of the opinion that the change to landscaping is not significant enough to trigger the site-plan approval process.

There was nothing further to update the Committee on; therefore, the item was held for future updates.

## In what circumstances does the City of Newton currently provide cleaning of Building Sewers (house connection or private sewer)?

The City of Newton Utilities Division provides personnel during normal business hours (7:00 AM-3:00 PM) for residents that pre-schedule (preventative maintenance) or call that day (emergency) to clean/flush private building sewers. For emergencies during non-business hours, residents through the police control center, will be put in contact with an emergency on-call person from the Utilities Division. That person will first creen the call, and then will either respond and clean the building sewer if Utilities personnel are available, or direct the resident to contact a commercial drain cleaning company if they are not. Approximately 80% of the service calls for cleaning private building sewers are for non-emergency, preventative maintenance.

## What are the fees that the City of Newton charges for this service and what is the cost to the City of Newton of this service?

The fees for this sewer cleaning service are provided for in Sec. 29-67A of our ordinances. Specifically, the ordinance says: whenever the city is engaged to rod-out, unclog or otherwise clean a building sewer, a fee shall be charged. Except in those cases involving excavation, such fees shall be as follows:

\$25.00 flat rate for a service call during normal hours;

\$75.00 flat rate for a service call during overtime hours.

The table below reflects the actual cost (labor & equipment, overhead and benefits *not* included in labor cost) to the City of Newton to provide this service for the first seven months of FY 2011.

- Q: How often is the sewer cleaning service provided annually?
- A: During FY 2010 there were 480 cleanings of which 60 were repeat customers, therefore 420 out of approximately 24,600 building sewers (residents) used our service.
- Q: What personnel provide the service? Do these employees have other responsibilities?
- A: A Working Foreman and Truck Driver are used to perform the cleaning service +/-60% of the time, on the occasion when there is the need for a flushing truck, a Operator will assist in the operation. When these employees are not engaged in cleaning building sewers they will typically: flush public sewer mains, mark out services (Dig Safe), pickup or place barricades where needed and/or any other misc. activities that may come up during the day.
- Q: What equipment is used to provide the service? Is this equipment used for other services?
- A: The equipment used is a Ford Van and a International Hydraulic cleaner (Jet Truck). The Jet Truck is used for flushing the public sewers in commercial areas that are known for the accumulation of grease in the public sewer mains, therefore causing backups if not maintained.
- Q: What is the condition of the privately owned sewer laterals? What is the relationship between them and the infiltration problem that the City of Newton faces?
- A: The vast majority of the private sewer laterals are vetrified clay pipe (VCP), many installed in the early to mid 1900's. Without televising each individual building service, there is not a clear way to determine the condition of the pipe. Without knowing the condition of each pipe, it would be impossible to quantify the relationship between them and the infiltration problem. However, given the age of these pipes, and the typical condition we encounter when we have televised, it is safe to assume that there is a significant contribution to the infiltration problem.

## **Petition to Request Reduction of Plantings Adjacent to Hull Street**

The undersigned are requesting that the approved NNHS planting plan for the area adjacent to Hull Street, above the stadium, be reduced on its scope. The site plan bid for contract (Enclosure A) shows a heavily planted slope on the south side of the all-purpose stadium. We request a planting plan which reduces the planting along the 150 foot section (Enclosure B) to be mainly grass with some ground-level shrubs, the existing trees, and "fill-in" trees. We would ask that the Executive Office through the Project Team take the necessary steps to review this proposal and gain approval as a permanent change to the planting plan.
