PROJECT GOALS & ELIGIBILITY

Through its 14 April 2008 recommendation for docket item 147-08, the Community Preservation Committee supported appropriating \$359,400 to rehabilitate and expand the research library/ archives at the Jackson Homestead, to preserve existing collections, provide space for future additions, and enhance public access, including access for users with limited mobility. This supplemental recommendation relies on the detailed goals and evaluation in that original recommendation.

On 21 July 2008, the Board of Aldermen appropriated \$37,500 of the recommended total funding, to be used for design only. Once the resulting design had been approved by all required City bodies, including the Board's Public Facilities Committee, the Board then planned to consider appropriating the remainder of the recommended funding for construction.

Over the past two years, the Public Buildings Department has worked closely with the staff and Board of Historic Newton to hire and supervise a qualified historic preservation architect, and to refine the project's scope of work. As a result of this process, the Public Buildings Department and Historic Newton submitted in January 2010 the attached revised proposal requesting additional funds to complete the design phase of the project. They plan to submit a separate proposal for construction funding once the design has been completed and approved as required by the Board and the "other recommendations" below.

FUNDING RECOMMENDATION

& Requested Vote of "No Action Necessary" on Docket Item 147-08

On 24 February 2010 the Community Preservation Committee recommended by a vote of 9-0 the requested supplemental design funding of **\$63,845**, to be appropriated from the fiscal 2010 historic and general reserves of the Community Preservation Fund, and allocated 100% to historic resources. The CPC respectfully requests that the Board now vote "no action necessary" on all remaining, unappropriated funds from its previous docket item 147-08.

OTHER RECOMMENDATIONS

The Community Preservation Committee further recommends that:

- 1. Funds for this project be appropriated to the spending authority of the Public Buildings Dept., to be used for any of the purposes described in the January 2010 proposal & budget.
- **2.** The final design resulting from this project:
 - be subject to review and approval by Newton's Design Review Committee, the Mayor's Committee for People with Disabilities, the Newton Historical Commission, the Board of Aldermen's Public Facilities Committee, and the Massachusetts Historical Commission (MHC)

This process reflects City of Newton requirements for all public building projects, Newton ordinance 22-76 ("preservation of city-owned properties subject to funding under the Community Preservation Act"), and the preservation restriction held by MHC as a result of prior state-funded work at the Jackson Homestead.

- follow the Secretary of the Interior's Standards and Guidelines for the Rehabilitation of Historic Properties, as required by the CPC's original April 2008 recommendation
- include final estimates by a professional cost estimator, to be used as the basis for a construction funding request
- **3.** The project manager designated by the Public Buildings Dept.:
 - provide regular updates and assistance in publicizing the project as requested by the CPC, its staff, or the Board of Aldermen; updates should include any additional funding requested or committed for the project, such as the Community Development Block Grant funds recently recommended for accessibility improvements
 - before releasing the final payment for architectural or other services, submit to the CPC a report of how all funds were spent, comparing actual expenditures with the budget outlined in the attached January 2010 proposal
- **4.** The project (design phase) be completed no later than 31 December 2010, or any later deadlines approved in writing by the Director of Planning and Development.
- **5.** Any portion of the Community Preservation Fund grant not used for the purposes stated herein be returned to the Newton Community Preservation Fund.

Of the multipurpose room/classroom addition mentioned in the original, December 2007 proposal, the Community Preservation Committee further notes:

- As this was always intended to be funded privately, its eligibility for CP funds was never reviewed.
- It was removed from the final plan for the revised, January 2010 proposal, partly because design changes eliminated the need for this new space, and partly because such an addition would require meeting more demanding and significantly more expensive standards for accessibility.

The CPC has informed the Museum and Public Buildings Dept. that it will not consider a request for funding of construction costs or accessibility improvements required by this addition, should the plan for it be revived in the future.







NOTE: Ald. Baker explained that this docket item was the first step in developing a long term capital budget. He said the School Department had done a similar inventory and that the Municipal side needed to do the same thing.

Ald. Fuller said it was the sponsors' intent to be very comprehensive in this docket item. They did not want to limit it to just buildings, but went on to include many more assets throughout the City. They also did not want to limit this to just a survey of physical conditions but wanted to go farther and include maintenance, renovation and replacement needs as well. They also want to put the information in a database so that it can be prioritized and monitored. She said she understands this is an enormous project and will probably need to happen in phases, over a period of years. The information is necessary to responsibly plan for the capital needs of the City. Currently, the information resides with the departments heads in charge of the assets and needs tend to be met as problems arise rather than through a working plan. Ald. Crossley agreed. She said any other institution would have this kind of plan. She understands that the list will probably be overwhelming but they do need to know where they stand. This inventory will help the Board make the day to day determinations regarding allocation of resources with a bigger picture in mind as well.

Ald. Lappin supports this item. She said that many have been asking for years what the priorities are when the Board is making allocation decisions. Ald. Fuller said that once the document is prepared, it would need to be updated continuously. Ald. Linsky agreed and supported this as did Ald. Fischman. Ald. Fischman noted that some projects may be subsidized through the MWRA or other state or federal agencies. It will be important to identify those and prioritize them.

Bob Rooney said that the Mayor supports this and finds it essential. Someone would need to manage this project to have consistency with the prioritization and work with the Chief Financial Officer. This is the essence of managing the City's infrastructure. He noted that the Public Works Department has done a road inventory and they have condition reports. The road report will help them determine what roads need attention and when and is the basis for the allocation of resources. He said that DPW has commissioned a study called "Computerized Maintenance"

Management System" that information can be entered into. And as mentioned, the Schools have also done their study. He said once the city wide study of resources is complete, it will be staggering, but it is information that is essential. He said the City owes it to the residents to give them this information - they can then see what it costs to keep the city safe, secure and functioning and they can be part of the decision making process.

Art Cabral noted that there was a request for a similar study in 2007 but the Board did not approve it. He said that his department had been pushing even earlier than that to get it done. The Public Buildings Department is completely on board with this item and welcomes it. Josh Morse said that the Citizen Advisory Group estimated the City's buildings value at just shy of \$1B. He feels it is common sense to establish a baseline of the assets. Prioritizing is difficult but essential as is a commitment to adhere to the plan. Mr. Morse said a short and long term plans are necessary. He did not want to commit resources to a building that might be torn down in a few years, for example.

Bob DeRubeis also supported this study. He agreed that it is essential to have a comprehensive survey and establish a baseline in order to properly prioritize and address issues.

Ald. Hess-Mahan said the Mayor-elect and his transition team started to look at this issue. There were many citizen volunteers and he would like to see that resource utilized.

Ald. Fuller urged Mr. Rooney to have a hefty line item in the FY11 budget to get this work started. In 2007, \$300,000 was requested to do a partial inventory. She understands that money would have to be taken from other worthy projects in order to get this funded, but she said she would be supportive and expected other Board members to be as well.

Ald. Merrill moved approval of this item. He felt it would be money well spent for the future of the City. The Committee voted in favor 8-0.

Newton Schools Long-Range Facilities Master Plan Newton, Massachusetts

1 Executive Summary

The goal of this study is to provide the City of Newton and the Newton Public Schools with a needs assessment, space standards and long-range utilization plans for the 21 elementary and middle school buildings evaluated. Working with the Newton Schools Study Steering Committee, HMFH Architects, Inc. began the study in February 2007.

Process

The 21 facilities assessed include 15 elementary schools, 4 middle schools, the Education Center and Carr School. Through the use of a facility questionnaire, review of previous reports, tours of each facility, and interviews with faculty and staff, the study team assessed each school building in three categories:

- · Facility condition
- Educational space
- Enrollment growth

In determining the current physical condition of each property the following components were assessed:

- Building exterior
- Building interior finishes
- Building systems (mechanical, electrical, plumbing, fire protection)
- Accessibility
- Code requirements
- Site conditions
- Building and site limitations

The educational space assessment identifies space deficiencies based on use, size (square feet), configuration, location within the building, and overcrowding with respect to the established Newton standards.

The enrollment growth projected for each elementary and middle school was between the current school year (2006/07) and five years from now (2011/12). The middle school enrollment projection for an additional 5 years indicates continued significant growth.

Assessment

Of the 21 buildings assessed, 16 were originally built over 50 years ago and three more than 80 years ago. Eight buildings were constructed during the 1950's, while the newest building is 36 years old. Additions and various levels of renovations have occurred on most buildings over the years. Burr, Horace Mann, Mason Rice, and Zervas have not had additions.

Based on the detailed physical assessment, the study team assigned a numerical rating of 1, 2, 3 or 4 to each property, with 1 for the lowest level of need in that category and 4 for the highest level of need.

Facility Condition Assessment

Six buildings are assessed at the highest level of facility condition needs: Angier, Cabot, Countryside, Ward, Zervas, and Carr. These buildings are all greater than 50 years old, and Angier and Ward are greater than 80 years old. The buildings assessed with the lowest facility condition need are Bowen, Memorial-Spaulding, Williams, and Oak Hill. These buildings all have had additions and partial renovations within the past 10 years.

The other eleven facilities need various levels of renovation work. All buildings require upgrades to the mechanical, electrical and plumbing systems. The majority of the buildings require at least some level of upgrades to meet the accessibility codes.

Educational Space Assessment

Angier, Cabot, Peirce and Zervas rated highest in level of need for educational space, reflecting undersized classrooms, the low net square feet of space per pupil, and minimal size or the absence of shared spaces (library, gym, auditorium). Many of the educational space deficiencies are due to the age of the buildings. Of course,

educational requirements also have changed dramatically over the past 50 years, adding the following spaces to a typical school building:

- Special needs programs
- Separate music and art classrooms
- Cafeterias
- Full-time kindergarten spaces

Bowen, Burr, Memorial-Spaulding and Williams, three of which have recent additions, have the lowest level of educational space needs.

Enrollment Assessment

The elementary enrollment is predicted to grow by nearly 1,000 students by the 2011/12 school year. The current elementary school buildings, regardless of the physical and educational space deficiencies identified in this study, cannot accommodate this expected growth. The school districts expecting the highest percentage of growth are Lincoln-Eliot (50%), Bowen (42%), Underwood (36%), and Countryside (29%). Significant growth is expected to occur on both the north and south sides of Newton. This pattern is similar at the middle schools, with the greatest growth at Day on the north and Oak Hill on the south side of Newton. Additionally, when the enrollment is projected out 10 years, the expected increase of 900 middle school students cannot be accommodated in the existing four schools. Current building capacity was assessed and the majority of schools are overcrowded in varying degrees, with Zervas experiencing the most severe overcrowding in the school system.

System-wide Options

With this combination of population growth and facilities needs, Newton faces both a challenge and an opportunity to create a visionary educational plan for the decades ahead. Based on the building assessments three system-wide options were developed. Each option provides a phased, long-range plan to address the facility conditions, educational space needs and the projected enrollment growth and incorporates the following planning assumptions identified by the committee:

- Maintain neighborhood schools
- Maintain current grade structure
- Limit elementary schools to no more than 500 students
- Redistrict as a "no cost" first step
- Include Education Center and Carr School in the planning process
- Consider "modular" classrooms as only temporary, short-term solutions

The first priority of the options is to accommodate the expected five-year enrollment growth. The second priority is to replace obsolete, and educationally deficient facilities. The third priority is to renovate and upgrade buildings to provide appropriate educational spaces and environments.

Each of the three options includes redistricting, renovation of Carr School, and relocation of the school administration and pre-school program from the Education Center for renovation as a school building. Each option assumes that Newton will submit Statements of Interest to start the Massachusetts School Building Authority process for funding assistance. Each option provides a multi-phased approach; how long any one option may take will be determined by community commitment and support, annual review of enrollment projections, and the City's capacity to oversee and fund building projects.

In all three options new construction/replacement projects are undertaken first, then renovation/addition projects, and lastly, renovation-only projects. This approach creates the most new classroom space in the short-term to meet the first priority of accommodating enrollment growth.

In brief, the key attributes of the three options are:

• Option 1 – accommodates the expected enrollment growth within the existing 15 elementary schools and adds a fifth middle school

- Option 2 adds an additional elementary school and a fifth middle school to accommodate the expected growth
- Option 3 adds two new middle school locations to accommodate the expected growth and converts Oak Hill Middle School to an elementary school

Each option allows for future flexibility in response to reassessment at each step of the long-range plan. October enrollment projections will be reviewed each year and the long-range plan will be adjusted to reflect new findings. Further study and community input are required to determine which option best serves the long-range needs of the school department and the City of Newton.

The Board of Aldermen of the City of Newton supports and requests the administration **execute a municipal energy action plan** that will assure reduction of energy use and emissions of at least 20% below the established FY2007 baseline energy inventory, by continued rigorous implementation of existing guaranteed energy savings (ESCO) programs, continued attention to dramatic building performance improvements as we are able to address large scale capital renovations as well as continued investigations into new opportunities and technologies so as to accrue said reductions, and therefore request that the administration implement and maintain these measures.

The following sewer projects were bonded:

Oakdale Rd (37A401E1A) = \$125,000 Farina Rd (37A401E2A) = \$125,000 Irving St (37A401E3A) = \$135,000 Old Farm Rd (37A401E4A) = \$115,000 Total = \$500,000

We received bids on the Oakdale, Farina, and Irving sewer construction projects, for a total bid of \$168,053. The bids are much lower than expected due to the the favorable bidding climate. The Old Farm Rd project is a design project.

I divided the bid costs as follows;

Status of Construction March 2010

As you may be aware, the construction of the Newton South High School Athletic Fields and Track Facilities is not completed, and will continue through June of 2010. The construction effort was delayed due to the citizens' appeal of the Conservation Commission's Orders of Conditions, and the subsequent citizens' appeal of the Department of Environmental Protection's Superseding Orders of Conditions. The contractor worked on site until early December 2009, and will return this month to complete the work by the end of June.

Remaining items to be completed include the following;

The track area around the football field (the westerly field with the bleachers) needs final asphalt paving, and installation of the top rubber surface. Additional synthetic turf also needs to be placed on the westerly edge of the field. This work will be completed in May.

The softball field outfield (the field second in from Brandeis Road) was not completed in the fall. The entire surface needs to be rolled, and finished with loam and grass turf. However, the softball outfield is not drying properly due to the shade trees. The area is in shade in the fall, winter, and spring. The civil engineer from Gale Associates will design additional subsurface drainage features to properly drain the outfield, which will be installed in April.

The baseball field (the field adjacent to the football field) is not yet completed. The pitcher's mound needs to be installed.

The soccer field (closest to Brandeis Road) is not completed. The contractor needs to roll and rake the synthetic turf surface, and remove excess sand and silt deposited there during construction, so that it will properly drain.

The long narrow area between the softball and baseball outfields and the abutting properties was designed and constructed as a surface drainage swale, to shed surface water from the fields. This area will be used as a cross country course. The drainage swale is working according to its design, channeling the water to the low points of the swale. However, a series of catch basins at the low points of the drainage swale, including one near the baseball field scoreboard, are covered with silt sacks, in order to keep sedimentation from the drainage system during construction, as per the Orders of Conditions. The silt sacks must remain in place during the remainder of construction, and can be removed with permission of the Conservation Agent, most likely upon issuance of a Certificate of Compliance at the completion of the project this summer. The silt sacks are trapping silt and sand on the surface, preventing this material from entering the storm drain system. Therefore the catch basins are not draining the surface water, and surface water is clearly visible. Once the silt sacks are removed from the catch basins, the drainage swale will drain properly, and will shed surface water from the fields.

Regarding the back yards of the abutters, these areas were always wet during rain events. The stormwater is coming from upstream contributory areas (the direction of Littlefield Road and Winston Road, via the front yards) not the athletic fields, as the athletic fields and drainage swale are lower than the back yards. This was explained at the numerous public hearings held during the design process. As mentioned above, the drainage swale was designed to channel the stormwater from the fields and from the abutting properties. Once construction is completed, the surface water will drain to the drainage swale.

As per the Superseding Orders of Conditions, and the Settlement Agreement between the City and the concerned citizens, the first round of environmental sampling testing has been performed in January. Another round is scheduled for spring.

The synthetic turf fields performed very well during the storm event of March 13 to 16. The synthetic turf fields drained completely, as they were designed to do. The natural grass fields take longer to drain during storm events such as these.

The Athletic Director of Newton South High School is pleased overall with the performance of the athletic fields to date. Both the synthetic football field and synthetic soccer field were successfully used in the fall of 2009 (during construction), and will continue to be used in the spring. The track is scheduled to be ready by Memorial Day weekend. The baseball field is ready to use this spring. The softball field requires another season of natural grass growth, and will not be available until the fall.

See attached memo from the design engineers of record, Gale Associates, explaining the status of construction in further detail.
