**ACTION: APPROVED 6-0** 

**NOTE:** Commissioner Daley provided the Committee with the details of the petition. There are two property owners involved in the petition and they will share the cost of the sewer extension, which will serve their homes. One of the homes is on a septic system and the other is on a cesspool, both are full and need to be pumped out regularly. The City will need to accept an easement as Pine Grove Avenue is a private way. The Engineering Division has reviewed the plans and recommended approval of the petition.

The public hearing was opened and no one spoke for or against the petition. The Committee reviewed the plans. Ald. Mansfield asked if there were any health issues with the septic system or cesspool. Mr. Robinson, 136 Pine Grove Avenue, responded that his home is on a cesspool that needs to be cleaned out because it overflows every couple of months. Ald. Lappin moved approval of the item with an emergency preamble. Both the motion and emergency preamble were approved by a unanimous vote.

ACTION: HELD 6-0

**NOTE:** The City's Traffic Engineer, Clint Schuckel, Ald. Johnson, and Ald. Linsky joined the Committee for discussion of this item. The item was held on February 4, 2009, to give the Traffic Engineer an opportunity to respond to alternatives suggested at the meeting. Mr. Schuckel provided the Committee with a PowerPoint presentation, which is attached. The presentation incorporates the suggestions and new alternatives that were given at the previous meeting.

The presentation began with a review of the site plan board order and the traffic/circulation goals around the Newton North site. The highest priority is to provide safe access to the site for pedestrians, bicycles, and busses. Clint Schuckel referred the Committee to Condition #4 of Board Order #224-06, which states that the Commissioner of Public Works shall recommend possible street improvements to improve safety on Walnut Street between Mill Street and Cabot Street. The stretch of Walnut Street includes the Hull Street intersection and it has been suggested that the intersection would benefit from safety improvements. Mr. Schuckel presented aerial photos of the Hull Street intersection, which included an as is photo and a photoshopped version which displayed the intersection with curb extensions. The curb extensions would narrow a 90' crossing to a 41' foot crossing. There is currently an island located in the center of Hull Street, which would need to be removed to accommodate the curb extensions. Mr. Schuckel stated that John and Anne Joyce, 503 Walnut Street, own the home located at the corner of Hull Street and are in support of the proposed traffic island removal and road narrowing. The have signed up for the Adopt a Space program for the Hull Street traffic island and would like to continue the service in the area that will be created by a curb extension. The projected cost of the Hull Street curb extension is \$35,000. There is still some question whether to offer to sell the additional land created by the curb extension to the property owners at 503 Walnut Street. The Traffic Engineer would like some direction from the Committee regarding this proposed traffic improvement.

Ald. Mansfield if there has been any study to show how changing the turn radius could affect the traffic on Walnut Street. Mr. Schuckel does not share the concern regarding slowing traffic on Walnut Street. The design of the Hull Street intersection is the same as any other intersection designed as a side street meeting a main street. There should not be any type of negative impact. Ald. Schnipper asked if it was possible to do a trial of the curb extensions. Mr. Schuckel explained that the current traffic island would need to be removed in order to hold a trial. Ald. Albright pointed out that it would increase pedestrian safety and it is likely that the neighborhood would support the change. Ald. Albright suggested that the Committee take a straw vote on whether to recommend that the Traffic Engineer proceed to the design phase of the intersection reconfiguration. The Committee voted unanimously in favor of proceeding with the project.

Mr. Schuckel continued with his presentation and addressed Condition #5 of Board Order #224-06, which relates to the school's driveway located on Walnut Street directly across Trowbridge Avenue. The condition states that there shall be a study of the traffic circulation if restrictions are put into effect when entering and exiting the driveway. It also requests there be a study to determine the feasibility of providing a pedestrian crossing at, or north of, the driveway. Mr. Schuckel addressed the pedestrian crossing first. A pedestrian crossing becomes less attractive to pedestrians the further north it moves from the entrance to the school. It is very difficult to predict the number of crossings as school construction currently does not allow access to the school from Walnut Street. Therefore, the current crossings are likely due to the bus stop location on Walnut Street. Mr. Schuckel reviewed the traffic signal and school crossing warrants with the Committee. Walnut Street at Trowbridge Avenue meets the criteria for a traffic signal.

The Traffic Engineer reviewed the eight alternatives for the Walnut Street/Trowbridge Avenue. The alternatives run the gamut of no restrictions or signals to a full signal with an island. Mr. Schuckel provided the pros and cons for each alternative. The alternatives that include raised islands create access issues for the Fire Department and he suggested that it is appropriate for the Committee to consult the Fire Department regarding their concerns. The presentation concluded with a cost summary of all of the alternatives.

Ald. Mansfield stated that the median island displayed in Alternate 1A appeared to be unduly long and suggested that if it were shortened the Fire Department's access may not be as restricted. The Traffic Engineer stated that he would look at shortening the island. Ald. Albright spoke on the alternatives. She favors a right in/right out with a raised island and a mid-block crossing with some type of pedestrian signal. Mr. Schuckel stated that he did not believe the entrance was wide enough to accommodate a raised island. She suggested investigating widening the entrance to the school to allow a raised island in the center of the entrance. She would also like to see how the pedestrian warning signals work at other sites in the city to determine whether it is a viable option on Walnut Street. Ald. Johnson stated that the warning signals should be in place by the summer at five locations in the city. The Ward Two Aldermen submitted a letter to the Committee detailing their goals as they relate to traffic around the Newton North site. The letter is attached to the report. Ald. Schnipper stated that she was not comfortable supporting the alternative without input from the Fire Department.

Mr. Robertson, 30 Trowbridge Avenue, spoke for the neighbors. The neighborhood has spent a lot of time studying the options. The neighborhood supports Alternative 3 as it accomplishes all of the goals represented in the letter from the Ward Two Aldermen. Ald. Linsky also felt that Alternative 3 was the best option to address the goals. He supported investigating the possibility of a raised island.

Ald. Albright asked that the Traffic Engineer investigate the feasibility of a delta island with a raised curb. She would also like a cost estimate for the new alternative. Ald. Albright moved hold until the Traffic Engineer has a chance to address the requests, which carried 6-0.

The building floorplans and elevations are subject to modification as the plans are developed during the Design Development and Construction Document phases of the Project. Pursuant to §5-54(c) of The Revised Ordinances of Newton, 2001, the Design Review Committee shall make periodic reviews of the Project's plans as it moves through the various design phases.

- 2. The Board of Aldermen acting through its Public Facilities Committee will receive regular updates and plans on the status of the Project, on the issues to be analyzed pursuant to the conditions contained in this board order.
- 3. During the Design Development phase, the Project's Design Team shall make a comparative design and associated financial analysis of the following alternatives:
  - a) Building the multi-purpose playing field at grade rather than sinking it;

- b) Providing basement space for such of the mechanical equipment as may be relocated from the roof;
- c) Providing basement space above and beyond that needed for mechanicals to be used for secure storage;
- d) Adjusting the layout of Elm Road in the area of the bus waiting zone to maximize the opportunity to increase the landscape buffer between Elm Road and the abutting residential properties and narrowing the width of Elm Road to not more than thirty (30) feet;
- e) Providing a drop-off area or alternative vehicular entrance along Lowell Avenue and creating alternative traffic patterns on Elm Road;
- f) Covering the stairs leading from Hull Street into the east side of the site and developing a plan to better utilize Hull Street as a drop-off location;
- g) Designing the classroom building to allow expansion space for additional classrooms to be built later;
- h) Comparing different mechanical equipment systems and life-cycle costs of such systems;
- i) Developing a plan to mitigate noise to be generated by the HVAC system if located on the roof or on the ground; and,
- j) Creating an alternative bus drop-off area on Walnut Street.
- 4. The Public Works Commissioner shall recommend to the Board of Aldermen possible street improvements to promote safety on Walnut Street from Mill Street to Cabot Street, including at the intersection of Hull Street and Walnut Street. Such street improvements might include, but not be limited to, signage and the narrowing of the intersection at Hull Street and Walnut Street. Such improvements as approved by the City shall be undertaken as soon as possible and in no event later than the Project's opening.
- 5. The Design Team shall study the effect on traffic circulation if the turning movements are limited to a right turn into and out of the driveway to the project entrance on Walnut Street, and shall also study providing a pedestrian crossing north of such driveway. If the results of the said study so recommend, a traffic signal shall be considered by the City at such driveway. If approved by the Board of Aldermen, such signal shall be operational at the time of the Project's opening.
- 6. The City shall use best efforts to retain and protect the existing trees on the site along the north side of Hull Street to provide a landscape buffer for the adjacent residential properties.

7. No further parking spaces shall be added at the entrance on Trowbridge Avenue.

The Public Buildings Department respectfully requests the sum of \$404,905 cover the cost of replacing and removing two, twenty-three year old 10,000 gallon underground gasoline tanks, firel dispensing island and related equipment at the Crafts Street DPW Yard. Due to site constraints, the existing tanks will be replaced in kind with underground storage tanks.

Both of these tanks have falled a number of inspections in regards to vapor recovery, exhadic protection, as well as the existing underground piping, although wrapped with a secondary containment, does not meet the current code for secondary containment, interstitial piping is all correded and could not be removed for testing of the interstitial space and overall piping and tank tops are extremely corroded. I am suggesting that both tanks be replaced due to their age as opposed to making remporary repairs.

We have been in contact with both the State Fire Marshall's Office and the Newton Fire Department and been advised that the existing tanks may remain in service until the commencement of their replacement, which we anticipate to occur during the months of August and September, 2009.

However, should the above time line not be met, the existing tanks with be taken out of service effective August 2009 and remain out of service until such time as the realiscement project is completed.

Ms Wang's recommendation was to add parking restriction in morning hours to deter commuters all day parking.

Sgt. Norcross said the parking problem would move if restrictions were put in. From the point of view of the Police Department, a two hour restriction is a drain on manpower. He noted that a specified time has always worked.

Chairman Koses suggested a 30-day trial from 8 am to 10 am and see if there needs to be any adjustment.

Ms. Wang will be able to put in "No Parking Here to Corner Signs which would address some concerns. Jerome Grafe agreed with the Traffic Engineer that there be no parking on east side of Hancock Street between Williston and Grove Street. Ms. Wang pointed out that a 60-day trial would be more appropriate.

The Committee voted a 60-day trial of No parking, west side of Hancock Street between Williston Road and Grove Street, and no parking 8:00 am - 10:00 am, Mon-Fri, east side of Hancock Street between Williston Road and Grove Street.

This Item will be heard again in September or later.

★ TC61-08 ALD. SANGIOLO, HARNEY, GENTILE requesting traffic calming measures along Concord Street in Newton Lower Falls; either two center islands or alternatively a bike lane along Concord Street. (Ward 4)

#### **ACTION: NAN 3-1 (Grafe)**

Ald. Sangiolo said when the Jordan Marsh warehouse was renovated a traffic study was done for lower falls and a number of traffic calming measures were recommended by Rizzo and Associates. The recommendations included two traffic islands to be installed on Concord Street. Ald. Sangiolo said she often sees bicycles on this road and notes it is not safe because there is no striping.

Nina Wang's presentation showed 12-18 cars parked at east side of Hancock Street on weekdays (2/3 of them from commuter's near Grove Street end and 1/3 school related). The existing parking restriction covers most of the west side between Woodland and Grove, width of street is too narrow to support parking on both sides. Currently 0-2 cars parked on Williston Road. Adding parking restrictions would push commuters to park on nearby Streets. Her recommendation was to add parking restrictions in the morning hours to deter commuter's whole day parking.

Norm Seaman of Clearwater Road who is a member of the Lower Falls Improvement Association said this is a project that has been worked on for the past several years. He said at one time there was only a center line on Concord Street and it had been requested that Concord Street be striped as narrow as possible.

Sgt. Norcross told the Committee that the Police Department does at least 200 directed patrols in this area during a year.

Jerome Grafe said he was in favor of a bike lane. He was also in support of the islands. Ms. Wang did not feel there was enough room for a bike lane. David Koses felt islands could cause problems with plows, bicycles, etc. and would not support putting in an island.

Ald. Harney felt this is a very dangerous situation and needs some creativity to solve the problems.

Ald. Sangiolo said we certainly do not want to impede residents from getting out of their driveways.

Ms. Wang reiterated that the street was too narrow for bike lanes; "Share the Road" signs could be used.

Chairman Koses made the following motion: Recommend that DPW consider the following during resurfacing: bicycle signage, reduced travel lanes, striped shoulders. Recommend that the Police Department continue aggressive enforcement of speed limit.

The Committee voted no action necessary 3-1 (Grafe no)

#TC14-09 <u>CAPTAIN MINTZ</u>, Newton Police Department, requesting that six (6) parking spaces on the south side of Davis Street nearest Chestnut Street be designated "Police Personnel Only, Mon through Fri, 7:00 am to 5:00 pm" to accommodate parking associated with a transfer of staff from police headquarters to the Chestnut Street annex. (Ward 3)

#### **ACTION: APPROVED 4-0**

**NOTE:** Captain Mintz said that currently there is insufficient parking for the Newton Police Annex. Presently there are 15 parking spaces plus 1 handicapped space. In a typical day, there are 18 to 20 personnel as well as parking needs for 13 vehicles for the department. There are approximately 20 private cars and, in addition to that, there are 13 of the police fleet on the premises plus other bureaus visiting the facility. In the winter this becomes a critical situation. If this is approved, the problem will not be totally alleviated but will certainly help.

Nina Wang wanted to emphasize that this area has very tight parking. Ms. Wang recommended adding six reserved Police parking spaces on the south side of Davis Street.

One letter was received from a resident of 17 Davis Street who is concerned that if six spots are reserved, traffic on the street will increase as people circle the block looking for parking. This letter was in favor of changing the rules on Chestnut Street and not in favor of this petition.

ACTION: HELD 4-0 (Lennon and Mansfield not voting)

Ald. Harney and Ald. Sangiolo joined the Committee for discussion of this item. NOTE: Clint Schuckel, Traffic Engineer, gave a PowerPoint presentation, which included "Traffic" Safety & Calming Projects: How to get from Concept to Construction" and Grove Street (attached.) The presentation began with an explanation of how to bring a traffic-calming project to fruition. The presentation pointed out that most streets do not qualify for traffic calming and funding for traffic calming is limited. The Traffic Council came up with traffic calming criteria/scoring to be used, when determining whether a specific street is an appropriate place for traffic calming. The criteria focus on volume of cars, speed of cars, police, and fire ranking, proximity to a school and pedestrian volume. There are three ways that traffic-calming projects are funded; 1) the Mayor could appropriate funds within the budget or allocate Chapter 90 funds 2) via mayor/special appropriation such as parking meter receipts, budget reserve or free cash and 3) other funding sources like CDBG funds, development mitigation funds or as a condition of a special permit project. The traffic-calming projects most likely to move forward in a timely manner are the ones funded through the other funding sources, which are the preferred options and projects with an aldermanic champion.

Mr. Schuckel's presentation also included several examples of completed projects and other projects that are in the pipeline. The examples incorporated recent traffic calming construction costs for curb extensions, speed humps, raised intersections and raised crosswalks. It was very clear that the speed humps were the least expensive option at \$7.5 thousand. The second least expensive option was the curb extensions at \$20 thousand each. The cost of raised intersections and raised crosswalks are driven by the necessity for drainage at the location of the intersection or crosswalk because water cannot flow through them to a catch basin. The raised intersections installed on Woodland Road cost approximately \$60,000 a piece.

## PUBLIC FACILITIES COMMITTEE REPORB42-08 WEDNESDAY, OCTOBER 22, 2008

Mr. Schuckel gave a history of the request for this project and other projects on Grove Street in Newton Lower Falls. The Traffic Council voted approval of the raised intersections at Grove and Cornell Streets and Grove Street and Pine Grove Avenue (report attached.) Using the scoring criteria for traffic calming projects, Mr. Schuckel came up with 4 points out of a possible 11 points for traffic calming at this portion of Grove Street. It received the maximum number of points for volume and speed but received none for proximity to a school or volume of pedestrians. The project has the support of the three Aldermen representing the ward and funding through traffic mitigation funds from the Cabot, Cabot, and Forbes project. Ald. Sangiolo stated that the intended purpose of a portion of the traffic mitigation fund was for traffic calming in the Grove Street Lower Falls area. There is approximately \$96,016 in the mitigation fund for the Lower Falls improvements.

Ald. Schnipper asked if emergency response vehicles had any problems with the raised intersections that were installed on Woodland Road. Ald. Salvucci responded that a firefighter was injured and the truck's steering column was snapped when it went over one of the raised intersections. It was stated that the accident occurred when the raised intersections were first installed and the Fire Department was unaware that they were there.

Ald. Gentile is concerned that there is not enough money in the mitigation fund for both raised intersections. Mr. Schuckel stated that the intersections on Grove Street might cost less, as the city now has some experience installing raised intersections. The Chair requested a more accurate estimate for the raised intersections and an absolute figure on what is in the mitigation fund. Ald. Gentile asked what portion of the cost for improvements at Concord, Hagar and Grove Streets the city is paying. The City Engineer, Lou Taverna, responded that it was his understanding that the improvements were to be completely funded through the mitigation fund. Ald. Albright suggested doing one raised intersection and one raised crosswalk. Mr. Schuckel explained that it is difficult to place a raised crosswalk at an intersection, as it creates turning issues for vehicles.

Several members of the Lower Falls community were present and spoke on the item. Josh Princeton was concerned that if the mitigation funds are not used for the project, it will not be done. Ald. Gentile asked for their thoughts on which intersection of the two would be more appropriate for a raised intersection. Jim Slattery stated that the Grove and Cornell site is more important. Norman Seaman stated that he has done research on traffic calming and learned that traffic calming devices should be spaced 600' to 800' apart to be effective. There needs to be some type of traffic calming at these locations on Grove Street. Mr. Seaman asked if there other less expensive alternatives that would work at either location. He felt that it would be possible to place a raised crosswalk just north of Pine Grove Avenue and a raised intersection at the Cornell location.

Mr. Schuckel stated that speed humps are a more effective alternative and less expensive. However, to install speed humps on a street, it would require an ordinance amendment. Ald. Sangiolo asked if the proposed improvements were to be changed would it have to go back to the Traffic Council. Mr. Schuckel replied that the item is effectively out of the Traffic Council. Ald. Danberg asked if the Fire Department would have any issues with the use of speed humps on Grove Street. Ald. Salvucci stated that there was no way that the Fire Department would be in favor of speed humps at any location. Mr. Schuckel pointed out that there have been many

improvements in construction of speed humps, which make them less detrimental to emergency vehicles.

Ald. Albright moved hold on the item for further investigation of the speed hump alternative, better estimates on the raised intersections and the absolute amount of funding available in the mitigation fund. The Chairman would like a sense of when the information will be available. Mr. Schuckel stated that he would have the information within three or four weeks. The item will be discussed again at the second meeting in November or the first meeting in December.

NOTE: City Engineer Lou Taverna joined the Committee for discussion of this item. He explained that ordinance amendment is needed to add language, which designates the Commissioner of Public Works or his designee as the official empowered to issue trench permits. It was decided that the Commissioner was the most appropriate official as the department already handles street opening permits and it makes sense to tie the trench permits to that function. The amendment will bring the City into compliance with the new State trench-safety legislation that will go into effect on January 1, 2009. The new legislation is designed to prevent the public from accessing an unattended trench on both private and public property. The draft amendment to §25-1 of the ordinances is attached, as well as a description of the responsibilities of the permitting authority from the State's Department of Public Safety and Department of Labor, Division of Occupational Safety.

Ald. Coletti stated that he hopes the authority is vested in the Commissioner and not his designee. He is concerned that the trench permits will create timing problems especially in the case of an emergency. He feels strongly that there should be a mechanism to waive the permit if there is an emergency. Mr. Taverna believes that there is a measure within the legislation, which allows emergency work to take place. He will check with the Law Department to make sure that is the case and will provide the Board with that language. (Please see attached FAQ from the State's website.)

The Chairman pointed out that the Board does not have much of a choice on whether to approve the item or not. The change is needed to bring the city into compliance with State law. Ald. Salvucci moved approval of the item, which carried unanimously.

Cost Estimates for Speed Humps, Raised Crosswalks, Raised Intersection

**Traffic Calming Improvements** 

In response to your request during discussions at the Public Facilities Committee meeting of October 22, 2008, Public Works has developed some estimated costs of the construction of speed humps, raised crosswalks, raised intersections, and traffic calming improvements. The costs assume construction by City of Newton Public Works crews.

#### Speed Humps:

The cost estimate for speed humps, which were reconstructed on Tyler Terrace in 2006, was \$7,500 each. Note that speed humps are currently only allowed on Tyler Terrace and Clark Street per ordinance.

#### Raised Crosswalks:

The cost estimate for the raised crosswalk on Middlesex Road at Brimmer and May was \$25,800, as prepared by McMahon Associates, the engineers from Brimmer and May. The actual cost of the raised crosswalk on Middlesex Road constructed by Public Works was \$34,700. This included drainage improvements (catch basin and drain pipes), sidewalk regrading, ADA ramps, and curbing. There were extensive sidewalk modifications to meet ADA slope requirements, which were not anticipated in the original estimate. This was the first raised crosswalk constructed by Public Works crews, and there was a learning curve. There was a mix of construction materials, including asphalt slopes, stamped concrete crosswalk, and granite curb crosswalk edging. Brimmer and May contributed \$25,800 to the construction effort.

#### Raised Intersections:

The cost estimate for the raised intersection on Woodland Road at Cheswick Road was \$20,000 (plus another \$20,000 for the intersection of Woodland at Lake), and was prepared by Engineering Division. The estimate was made long before the Public Works crews had ever constructed a raised intersection or crosswalk, and was based on time and material. The actual cost of the raised intersection constructed by Public Works was \$60,000. (The actual cost of the raised intersection on Woodland at Lake was not tracked.) This cost included drainage improvements (catch basin and drain pipes), sidewalk regrading, ADA ramps, raised manhole

castings, and extensive curbing and sidewalk improvements, which were not anticipated in the original estimate. This was the first raised intersection constructed by Public Works crews, and there was a steep learning curve. There was a mix of construction materials, including asphalt slopes, stamped concrete intersection table, granite curb crosswalk edging, and stamped concrete crosswalks. Lasell College offered \$20,000 for the construction effort, which has not yet been collected.

#### Traffic Calming Improvements:

The cost estimate for the <u>traffic calming improvements</u> on Grove at Hagar and on Hagar at Concord is \$30,000 total. This includes a new granite curb traffic island on Grove at Hagar, and a scored concrete traffic island on Hagar at Concord. Public Works has not estimated the cost of additional traffic calming measures on Concord St (torpedo-shaped granite traffic islands in the center of the roadway), as these have not yet been approved by Traffic Council. Actual costs are not yet available.

The cost estimate for the <u>traffic calming improvements</u> on Daniel St at Jackson St is \$25,000. This includes a new granite curb traffic bump out, and drainage improvements (catch pasin). Actual costs are not yet available.

#### Summary:

For future estimates, we present the following:

Speed Humps (without drainage improvements) = \$7,500 each (no contingency needed). Raised Crosswalks (with drainage improvements) = \$25,000 each + 20% contingency = \$30,000. Raised Intersections (with drainage improvements) = \$50,000 each + 20% contingency = \$60,000.

Traffic Calming Improvements = varies on a case by case basis, currently averaging \$25,000 to \$30,000.
