NOTE: Arthur Cabral, Budget and Project Specialist, and Fire Chief LaCroix were present for the discussion of the renovation of Station #4 at the corner of Crafts and Watertown Streets. The Committee had reviewed the Fire Station #4 evaluation, architectural programming, and conceptual design report from Maguire Group, Inc. that was attached to the agenda for the meeting. Public Buildings Commissioner Parnell had also provided an estimate of approximately \$2.1 million for the proposed renovation, which is more than was budgeted. In order to keep within the budget the architect recommended ways of reducing the scope of work. The architect provided a revised scope of work, which includes six bid alternate recommendations that should be done if the budget allows because they are key programmatic needs. Mr. Cabral provided the Committee with a summary of the project, which is attached to the report. The project summary includes the six bid alternates and a breakdown of the project costs.

The Committee reviewed the plans with the Fire Chief and Arthur Cabral. The Public Buildings Department is still working on the most efficient and practical solution to the heating system. The system will be converted from steam to hot water. Ald. Coletti suggested that the generator for the station be enclosed or moved away from the proposed training room and that the diesel pumps be removed. Chief LaCroix stated that the pumps are used; however, the department could fill the trucks at the Crafts Street Public Works Yard. The Committee felt strongly that the project should be done right and include all of the recommended work. Ald. Coletti suggested that the Committee ask the Mayor for the additional money to include the bid alternates in the project. The Committee created the resolution below to request the additional funds. Ald. Lappin moved approval of both items, which carried unanimously.

<u>NOTE</u>: Ald. Schnipper reminded the Committee that this item was recommitted due to the unacceptable installation of the guy and anchor. Verizon also installed the guy and anchor before the Board of Aldermen approved the grant of location. Verizon installed a different type of guy than what was understood and did not install a reflective shield on the wire. Verizon has since corrected the problems; therefore, Ald. Salvucci moved approval, which carried. Ald. Mansfield voted in opposition of the item due to the early installation without approval of the Board of Aldermen. Ald. Schnipper opposes all guy and anchor installations, as she believes they pose a safety issue to pedestrians.
