COMMISSIONER OF PUBLIC WORKS requesting an extension of the public sewer main on WOOD END ROAD from an existing manhole in front of 71 Wood End Road easterly 200'± to BOWDOIN STREET, then northerly 100'± on Bowdoin Street to Hillside Road, then easterly 150'± on HILLSIDE ROAD to 87 Hillside Road to service #93 Hillside Road, which is mistakenly connected to the public drain system,
