ITEMS SCHEDULED FOR DISCUSSION:

REFERRED TO PUBLIC FACILITIES AND FINANCE COMMITTEES

#82-05 HIS HONOR THE MAYOR requesting an appropriation in the amount of \$960,978 (\$457,856 from Free Cash/\$503,122 from Overlay Surplus) for the purpose of supplementing the snow and ice control accounts in the Public Works Department.

27-03 ALD. SALVUCCI, SCHNIPPER, LINSKY, STEWART, LAPPIN AND YATES requesting a review of all change orders to date with Public Buildings Commissioner and the Project Manager on the Newton South High School project.
