**ITEMS SCHEDULED FOR DISCUSSION:**

#122-05 ALD. ALBRIGHT, JOHNSON, LINSKY AND SANGIOLO requesting the adoption of written designer selection procedures consistent with those set forth in model state procedures, guidelines and policies.

**REFERRED TO PUBLIC FACILITIES AND FINANCE COMMITTEES**

#130-05 COMMISSIONER OF PUBLIC WORKS requesting authorization to enter into an Intercommunity Agreement with the Town of Needham to use a Trommel Screen (to be used to process approximately 13,000 cubic yards of compost to be used for resale in the coming year).

#109-04(2) COMMISSIONER OF PUBLIC WORKS requesting that the City's Inter-Municipal Agreement with Wellesley Municipal Light Plant (approved as a one-year agreement expiring on 2/16/05) be extended through June 30, 2005. (NOTE: The FY06 will provide for the transfer of this function to the Fire Department Wires Division)

#131-05 HIS HONOR THE MAYOR requesting that the sum of \$50,000 (514-99(2)) be appropriated from funds held by the City from Bradford Development, Inc. under the terms of Special Permit #514-99(2) (granted July 18, 2000) for the purpose of designing and purchasing a sedimentation basin at the Hampton Place condominiums on Florence Street.

#132-05 HIS HONOR THE MAYOR requesting that the sum of \$158,000 be appropriated from Water Surplus for the purpose of supplementing the Water and Sewer Division overtime accounts for FY05.

**REFERRED TO PUBLIC FACILITIES AND FINANCE COMMITTEES**

#133-05 HIS HONOR THE MAYOR requesting that the sum of \$650,000 be appropriated from bonded indebtedness for the purpose of accepting and reconstructing the following three streets: COUNTRYSIDE ROAD; PATTEN CIRCLE; and MOSLEY ROAD.

PUBLIC HEARING TO BE ASSIGNED FOR 4-20-04**

#121-05 KATHLEEN & JOSEPH GUZZI, 60 Stratford Road, petitioning for a common sewer to be constructed in STRATFORD ROAD from an existing sewer manhole located in front of 48 Stratford Road, extending 45' ± southerly to a proposed sewer manhole.

**REFERRED TO PUBLIC FACILITIES AND FINANCE COMMITTEES**

#134-05 CITIZEN'S PETITION, Newton North Ballot Committee of the Newton Taxpayers Assoc., Samuel Robbins, 300 Prince Street, W. Newton submitting a petition pursuant to Section 10-2 of the City Charter, which contains approximately 73 signatures validated by the Newton Election Commission requesting the Board of Aldermen to hold a Public Hearing which seeks the passage of the following measure:  
"The total cost of renovating and expanding Newton North High School shall be limited to \$65 million including reimbursements. Cost increases due to inflation, as reported by the Consumer Price Index of the U.S. Department of Labor, will be allowed."

**REFERRED TO PUB. SAFETY/TRANS. AND PUBLIC FACILITIES COMMITTEES**

#61-05 ALD. SAMUELSON, DANBERG AND CANDACE HAVENS requesting that, as part of the reconstruction process for TYLER TERRACE and/or CLARK STREET, speed humps be redesigned in order to improve safety for moving traffic while still slowing speeds to 25 mph.

**REFERRED TO PUBLIC SAFETY & PUBLIC FACILITIES COMMITTEES**

#21-05(5) ALD. STEWART requesting that certain pedestrian safety improvements, including traffic islands, rebuilt curb cuts, and relocation of a stop sign, be made at the intersection of Hagar and Concord Streets, Newton Lower Falls.

**REFERRED TO PS&T AND PUBLIC FACILITIES COMMITTEES**

#479-04 ALD. LENNON, GENTILE, SALVUCCI, COLETTI et al requesting that a detailed analysis be conducted by the Public Buildings Dept., Fire Dept. (and any necessary outside sources) of all necessary improvements for each fire station within the city. Said analysis should include, but not be limited to: living quarters (bedrooms, kitchens, etc); offices and workstations; HVAC and plumbing systems; window replacement; apparatus floor and any other physical plant improvements. Said analysis should assist the Board of Aldermen in understanding and prioritizing all needed improvements and create a "blueprint" and timeline to have improvements implemented and completed.

#386-04 ALD. SANGIOLO, HESS-MAHAN, JOHNSON, AND DANBERG proposing an ordinance to require that designers selected have LEED certification and include high performance/life cycle analysis for all municipal construction projects in the City of Newton.
