ITEMS NOT YET SCHEDULED FOR DISCUSSION: PUBLIC HEARING BE ASSIGNED FOR JUNE 8, 2005

#171-05 <u>RUBEN & CARLOTA FAGUNDA</u>, 32-36 Hurley Place, petitioning for a common sewer to be constructed in HAGEN ROAD from a proposed sewer manhole in Hagen Road 117' <u>+</u> northerly through a proposed 20' wide easement in Hurley Road to a proposed sewer manhole to be located in the easement to service 24-26 and 32-36 Hurley Road.

PUBLIC HEARING ASSIGNED FOR JUNE 8, 2005

#172-05 <u>KEYSPAN ENERGY DELIVERY</u> petitioning for a grant of location to install and maintain 502' <u>+</u> of 4", 6", 8", & 12" in CARTHAY CIRCLE from the existing 12" gas main in Walnut Street @ Carthay Circle East to the proposed district regulator in Carthay Circle.

#173-05 <u>BOSTON EDISON CO. & VERIZON NEW ENGLAND, INC.</u> petitioning for a grant of location to transfer ownership of Pole 31/16 located on the northwesterly side of WATERTOWN STREET approximately 40' southwest of Adams Street, from solely owned by Verizon to jointly owned by Boston Edison Company and Verizon New England, Inc.

PUBLIC HEARING ASSIGNED FOR JUNE 8, 2005

- #174-05 <u>BOSTON EDISON CO.</u> petitioning for a grant of location to install pole 137/5A in the westerly side of ELM STREET approximately 70' south of Webster Street.
- #175-05 <u>ALD. YATES</u> requesting the School Department, School Committee and Public Building Department to request information from other communities across the Commonwealth and the nation as to problems encountered with HVAC systems in schools to find possible commonalities that might lead to possible joint legal action against defective suppliers or contractors and to possible connections to defective systems that have been successful elsewhere.

YATES</u> offering a resolution to the Design Review Committee asking that a site plan of Newton High School and visual depictions of the exterior appearance of Newton High School be include in the informational packet to be provided to designers applying for the contract to design Newton North High School.

<u>CITIZEN'S PETITION</u>, Newton North Ballot Committee of the Newton Taxpayers Assoc., Samuel Robbins, 300 Prince Street, W. Newton submitting a petition pursuant to Section 10-2 of the City Charter, which contains approximately 73 signatures validated by the Newton Election Commission requesting the Board of Aldermen to hold a Public Hearing which seeks the passage of the following measure:

"The total cost of renovating and expanding Newton North High School shall be limited to \$65 million including reimbursements. Cost increases due to inflation, as reported by the Consumer Price Index of the U.S. Department of Labor, will be allowed."

REFERRED TO PUB. SAFETY/TRANS. AND PUBLIC FACILITIES COMMITTEES

#61-05 <u>ALD. SAMUELSON, DANBERG AND CANDACE HAVENS</u> requesting that, as part of the reconstruction process for TYLER TERRACE and/or CLARK STREET, speed humps be redesigned in order to improve safety for moving traffic while still slowing speeds to 25 mph.

#21-05(5) <u>ALD. STEWART</u> requesting that certain pedestrian safety improvements, including traffic islands, rebuilt curb cuts, and relocation of a stop sign, be made at the intersection of Hagar and Concord Streets, Newton Lower Falls.

Said analysis should include, but not be limited to: living quarters (bedrooms, kitchens, etc); offices and workstations; HVAC and plumbing systems; window replacement; apparatus floor and any other physical plant improvements. Said analysis should assist the Board of Aldermen in understanding and prioritizing all needed improvements and create a "blueprint" and timeline to have improvements implemented and completed.
- #386-04 <u>ALD, SANGIOLO, HESS-MAHAN, JOHNSON, AND DANBERG</u> proposing an ordinance to require that designers selected have LEED certification and include high performance/life cycle analysis for all municipal construction projects in the City of Newton.
