<u>EVELYN D. IAGULLI</u>, 1086 Shell Isle Boulevard, Unit 3E, St., Petersburg, FL petitioning for a common sewer to be constructed in ROCKLAND STREET from an existing 24" sewer main that flows parallel to South Meadow Brook and extending 155' <u>+</u> westerly along Rockland Street (a private way) to service a proposed single family dwelling.

Note: The Law Department has advised that the City must acquire an easement in the affected portion of Rockland Street, either by eminent domain or as a result of voluntary conveyance by all abutting property owners.
