ITEMS SCHEDULED FOR DISCUSSION:

Appointment by His Honor the Mayor

#202-05 RALPH GREENWOOD, 94 Shady Hill Road, Newton Highlands, appointed as a member of the Citizens' Commission on Energy for a term of office to expire on June 1, 2008. (60-day Board action date 08-05-05)

Public Hearing

#174-05 BOSTON EDISON CO. petitioning for a grant of location to install pole 137/5A in the westerly side of ELM STREET approximately 70' south of Webster Street.

Public Hearing

#200-05 MELORA M. BALSON, 276 Highland Street, West Newton petitioning for a main drain to be constructed in HIGHLAND STREET from the existing drain at Fountain and Highland Streets easterly 265' ± to a proposed drain manhole in Fountain Street to service 276 Highland Street.

Public Hearing

#201-05 EVELYN D. IAGULLI, 1086 Shell Isle Boulevard, Unit 3E, St., Petersburg, FL petitioning for a common sewer to be constructed in ROCKLAND STREET from an existing 24" sewer main that flows parallel to South Meadow Brook and extending 155' ± westerly along Rockland Street (a private way) to service a proposed single family dwelling.

Note: The Law Department has advised that the City must acquire an easement in the affected portion of Rockland Street, either by eminent domain or as a result of voluntary conveyance by all abutting property owners.

#171-05 RUBEN & CARLOTA FAGUNDA, 32-36 Hurley Place, petitioning for a common sewer to be constructed in HAGEN ROAD from a proposed sewer manhole in Hagen Road 117' ± northerly through a proposed 20' wide easement in Hurley Road to a proposed sewer manhole to be located in the easement to service 24-26 and 32-36 Hurley Road.

- #233-05 COMMISSIONER OF PUBLIC WORKS recommending that Sec. 26-31, of the Revised Ordinances of the City of Newton, 2001, be amended by deleting the \$25 application fee plus an additional \$10 fee pertaining to the number of boxes and inserting a fee of \$50 per box per.

- #142-05 BOSTON EDISON d/b/a NSTAR ELECTRIC requesting a grant of location to relocate Pole 52/3 located 160' north of Washington Street on the northerly side of COURT STREET approximately 16' north of Washington Street.
- #178-04(2) ALD. LAPPIN requesting an update on progress and implementation of the construction information database.
- #175-05 ALD. YATES requesting the School Department, School Committee and Public Building Department to request information from other communities across the Commonwealth and the nation as to problems encountered with HVAC systems in schools to find possible commonalities that might lead to possible joint legal action against defective suppliers or contractors and to possible connections to defective systems that have been successful elsewhere.

- #61-05 ALD. SAMUELSON, DANBERG AND CANDACE HAVENS requesting that, as part of the reconstruction process for TYLER TERRACE and/or CLARK STREET, speed humps be redesigned in order to improve safety for moving traffic while still slowing speeds to 25 mph.

REFERRED TO PUBLIC SAFETY & PUBLIC FACILITIES COMMITTEES

- #21-05(5) ALD. STEWART requesting that certain pedestrian safety improvements, including traffic islands, rebuilt curb cuts, and relocation of a stop sign, be made at the intersection of Hagar and Concord Streets, Newton Lower Falls.

REFERRED TO PUBLIC FACILITIES AND FINANCE COMMITTEES

- #134-05 CITIZEN'S PETITION, Newton North Ballot Committee of the Newton Taxpayers Assoc., Samuel Robbins, 300 Prince Street, W. Newton submitting a petition pursuant to Section 10-2 of the City Charter, which contains approximately 73 signatures validated by the Newton Election Commission requesting the Board of Aldermen to hold a Public Hearing which seeks the passage of the following measure:
"The total cost of renovating and expanding Newton North High School shall be limited to \$65 million including reimbursements. Cost increases due to inflation, as reported by the Consumer Price Index of the U.S. Department of Labor, will be allowed."

- #479-04 ALD. LENNON, GENTILE, SALVUCCI, COLETTI et al requesting that a detailed analysis be conducted by the Public Buildings Dept., Fire Dept. (and any necessary outside sources) of all necessary improvements for each fire station within the city. Said analysis should include, but not be limited to: living quarters (bedrooms, kitchens, etc); offices and workstations; HVAC and plumbing systems; window replacement; apparatus floor and any other physical plant improvements. Said analysis should assist the Board of Aldermen in understanding and prioritizing all needed improvements and create a "blueprint" and timeline to have improvements implemented and completed.

- #386-04 ALD. SANGIOLO, HESS-MAHAN, JOHNSON, AND DANBERG proposing an ordinance to require that designers selected have LEED certification and include high performance/life cycle analysis for all municipal construction projects in the City of Newton.
- #321-04(2) ALD. JOHNSON requesting a RESOLUTION to His Honor the Mayor requesting that he expeditiously as possible find funding to create traffic calming measures on Mill Street as requested by the Traffic Council.
