**ITEMS SCHEDULED FOR DISCUSSION:**

**PUBLIC HEARING ASSIGNED FOR NOVEMBER 9, 2005**

#370-05 KEYSPAN ENERGY DELIVERY petition for a grant of location to install and maintain 27' ± of 4" gas main in GOULD ROAD from the existing 4" gas main in Gould Road to Quinobequin Road.

#348-05 ALD. STEWART recommending an amendment to Section 26-47 (c) of the revised ordinance to allow for the acceptance of new streets without sidewalks.

#175-05 ALD. YATES requesting the School Department, School Committee and Public Building Department to request information from other communities across the Commonwealth and the nation as to problems encountered with HVAC systems in schools to find possible commonalities that might lead to possible joint legal action against defective suppliers or contractors and to possible connections to defective systems that have been successful elsewhere.

#203-05 ALD. STEWART proposing the establishment of a commission to investigate the creation of a municipal electric distribution enterprise in Newton.

**REFERRED TO PUB. SAFETY/TRANS. AND PUBLIC FACILITIES COMMITTEES**

#61-05 ALD. SAMUELSON, DANBERG AND CANDACE HAVENS requesting that, as part of the reconstruction process for TYLER TERRACE and/or CLARK STREET, speed humps be redesigned in order to improve safety for moving traffic while still slowing speeds to 25 mph.

Said analysis should include, but not be limited to: living quarters (bedrooms, kitchens, etc); offices and workstations; HVAC and plumbing systems; window replacement; apparatus floor and any other physical plant improvements. Said analysis should assist the Board of Aldermen in understanding and prioritizing all needed improvements and create a “blueprint” and timeline to have improvements implemented and completed.
