Captain Anastasia, Newton Police Department joined the Committee for discussion on this item. He stated that Newton Taxi is renewing one license. Last year, Newton Taxi renewed two licenses.

Councilor Noel made a motion to approve this renewal taxi license request. Committee members agreed 7-0.

### Docket items #403-19 through #410-19 Discussion

Captain Anastasia, Newton Police Department joined the Committee for discussion on docket items #403-19 through #410-19.

Captain Anastasia stated that each company passed their vehicle inspection. All inspections have been completed. The Police Department has received no complaints regarding the companies or drivers. This year, taxi medallions have decreased, and public autos have increased.

### Committee questions and concerns:

• A Committee member stated that this year, City Council approved the adoption of the Climate Action Plan. In discussion, reducing carbon emissions from transportation, private transportation and housing were discussed. The Committee member asked if moving forward, can the City request companies purchase lower carbon or all electric vehicles? Chair Ciccone stated that he would prefer

the companies be present to discuss this request prior to this Committee discussing. He then suggested docketing an item for discussion and request companies attend the meeting for a discussion. Mr. Mahase addressed concerns over electric vehicles. He stated that electric vehicles are a step in the right direction and that it is necessary for technology to progress in order to make vehicles reliable.

- It was asked if it is the City or State who control the maximum age a vehicle is allowed for hire? Captain Anastasia answered that per City Ordinance no vehicle shall be approved for use as a taxicab, public auto or van in the City when the vehicle is ten years old or older. The vehicle age is checked when the Police Department conducts their annual inspection.
- A Committee member asked if the number of taxi licenses and public auto licenses have increased or decreased in the past ten years? Captain Anastasia did not have this information available. He then stated that this year, the City is down two taxis, public autos are up two and that Yellow Cab went out of service. This year, there have been no new requests for taxi medallions, only public autos. The Police Department has no regulations over Lyft and Uber vehicles. Dedicated taxi stands are no longer available in the City.

At approximately 6:45 p.m., Councilor Downs motioned to adjourn. Committee members agreed 7-0.
