#326-15 HIS HONOR THE MAYOR in accordance with Chapter 279 of the Acts of 1992

and Sec. 3-3 and 3-4 of the City Charter, appointing CAPTAIN DAVID MACDONALD as Chief of Police, appointed November 16, 2015, effective

November 30, 2015. [11/16/15 @ 3:39 PM]

NOTE: Captain David MacDonald joined the Committee for discussion on this item.

Captain MacDonald said that he has been with the Newton Police Department for almost 23 years and is excited to move forward with this opportunity. He then said that Chief Mintz should be commended for his great work including preparing for his successor.

Chair Ciccone stated that Captain MacDonald has had a distinguished career with the Newton Police Department. Amongst many previous police positions, experience, education and training Captain MacDonald also had the role of Executive Officer for 2 ½ years and as a narcotic officer which is important in today's society.

Committee members were pleased and excited with this appointment and expressed they have great confidence in his performance and look forward to working with him. They then stated that members of the Police Department are also excited. They agree that Chief Mintz did a great job. Continuity is important and great for the City and the Police Department.

Committee members suggested that Captain MacDonald return to this Committee several times per year to update them if necessary addressing any concerns, priorities or needs. Chair Ciccone suggested that Captain MacDonald return in ninety days.

Without further discussion, Chair Ciccone stated Captain MacDonald was an excellent choice. Therefore, he made the motion to approve this request appointing him as Chief of Police. Committee members agreed 6-0.

#311-15 STEVEN J. DONATO, 1211 Washington Street, Trustee of the 337 Washington Street Realty Trust, appealing the Approval of TC2-15 Traffic Council Decision on October 1, 2015: All existing Peabody Street resident permits and visitor passes will expire on December 31, 2015. A maximum of two (2) visitor permits will be available per dwelling unit for each address on Peabody Street, to be effective beginning January 1, 2016. A note will be added to TPR-202 for Peabody Street: "Beginning January 1, 2016, a maximum of one (1) visitor permit will be made available to residents of dwelling units located on corner lots which are contiguous to a lot that borders Peabody Street. These visitor permits are to continue to be made available on an annual basis, but only to residents living in these dwelling units who have a current Peabody Street resident permit or visitor pass. Resident of dwelling units located on corner lots which are contiguous to a lot that borders Peabody Street, but who do not currently have a Peabody Street visitor permit or resident sticker will not be entitled to obtain one." CURRENT POSITION-EXECUTIVE OFFICER

The Executive Officer reports directly to the Chief of Police and is the key liaison person with all internal system managers. As such, the Executive Officer ensures that the Chief has the necessary resources and data on which to base management decisions. A review and analysis of matters of fiscal management and assistance with the planning and preparation of the annual budget is key among these duties.

Within the Office of Chief of Police, the Executive Officer is responsible for staff management. Purchasing, payroll and police detail billing and collection are among the day to day duties that are overseen. Working with the Police Detail Clerk and City Solicitor, the Executive Officer has revised the Standard Operating Procedure on Detail Billing and Collection. The Executive Officer and the Solicitors Office work closely to collect on outstanding bills, communicating on this issue with the Comptroller on a quarterly basis.

The Executive Officer acts as the departmental advocate in Step 2 Grievances from the unions, deciding on the merits of the grievance by interpreting contract language. Throughout the grievance process, the Office of City Solicitor is worked with closely in order to ensure compliance with grievance protocols and prepare for possible arbitration. In preparation for Collective Bargaining, the Executive Officer works with and advises the City Solicitor and Executive Office and is a working member of management's bargaining team.

In the Chief's absence, the Executive Officer represents the Chief and/or department at various functions/meetings. The Executive Officer will also keep abreast of all matters of policy, operations, personnel and discipline that are implicated during said absence in order to properly brief and advise the Chief upon return to duty.
