NOTE: Officer Marini joined the Committee for discussion on the above docket items. He reviewed with Committee members the taxi/public auto contact list dated October 23, 2014, attached to this report. He stated that these vehicles passed inspection in October and recommends approval of renewing these public autos and taxi medallions.

One company, (Zakaria Atrousse of Boston City Limousine, Inc. 9 Hazelwood Street, Malden, MA, public auto #15) returned his medallion. Officer Marini contacted interested parties on the waiting list and anticipates issuing public auto medallion #15 to Donald LaPlante of Don's Car Service (a second public auto medallion) when the required application and fee is paid. Mr. LaPlante has been on the waiting list for quite some time. Officer Marini has informed Mr. LaPlante that he has to complete the necessary application and pay the required fee of \$25 to the City Clerk.

In October, (David Newcomb of Newton Coach, Inc. 275 Grove Street, Suite 2-400, Auburndale, MA, public auto #16) returned his medallion due to relocating out of State. Officer Marini has contacted interested parties on the waiting list and is waiting to hear if anyone is interested.

Committee members asked if Newton residents have first priority when medallions are issued. Officer Marini answered no; medallions are issued on a first come first serve basis. Interested applicants shall visit the Traffic Bureau requesting they be added to the waiting list for taxis or public auto licenses.

The Police Department is currently working with the City's Law Department on updating the City Ordinances *Vehicles for Hire* section as they are quite old and consistency is necessary. It is also the department's intent to amend the ordinance to provide Newton residents priority on obtaining taxi or public auto medallions.

Committee members asked if the City had regulations or specified parking areas for Zip Cars. Officer Marini answered no; the City does not have an ordinance regarding Zip Cars. Chair Ciccone answered that the City will be providing, at no cost, reserved parking for Zip Cars in the Pearl Street municipal parking lot.

Committee members then asked if Uber transportation service was in Newton. Officer Marini stated yes; he has received many complaints from Newton transportation companies informing him that Uber is taking business away from them. He then said that the City of Boston taxi hackney companies have filed a class action lawsuit against Uber. Veterans Taxi of Newton, LLC and Newton Yellow Cab, Inc. both companies from Newton intend to also file a lawsuit. In Newton, the businesses carry a one million dollar insurance policy. Uber vehicles are not regulated and they are passenger vehicles. The company uses a smartphone application to connect passengers with drivers of vehicles for hire. Customers use the smartphone app to request rides and track their reserved vehicle's location. It is the intent when updating the City Ordinances to include regulations for Uber vehicles. Licensees in Newton are checked on CORI reports, Board of Probations (BOP) report and driver history.

The Committee voted in favor 4-0, Ald. Harney not voting to approve renewals #387-14 through #398-14. The Committee voted in favor 5-0, to approve renewals #399-14 through #400-14.

At approximately, 8:20 pm, the Committee adjourned.
