ACTION: APPROVED 6-0-1 (Johnson)

NOTE: Mr. Gross is an attorney who lives in Newtonville south of the turnpike in a street with many historic homes. He is proposed to fill the Alternate Attorney seat on the Commission. Commission Member Mark Chudy recruited him. He approached the appointment with some trepidation, fearing that the Commission would impose unreasonable costly burdens on property owners and was pleased to find that the Commission was very reasonable in its dealings with property owners at the meeting he attended, striking a balance between cost and historic preservation. He looks forward to working for such a balance himself as a Commission member. Alderman Johnson said that she would abstain on the appointment until she had a chance to talk to him in depth about the position. She urged him to become familiar with the Historic District Study Report that outlines the historic qualities recommended for preservation in the district.

<u>ALD. BAKER</u> requesting discussion and planning of upcoming committee agendas, process, future work, and how to streamline committee work on minor or routine approvals in order to allow time to focus on more major or non-routine matters.

ACTION: HELD 7-0

NOTE: A lengthy discussion was held on how the Committee's work can be done more expeditiously. It focused on the appointment process as it related to the proposed schedule for the first three months of the year prepared by the Chairman. Eventually, it came down to a similar policy as that of the Programs and Services Committee. All appointees to regulatory commissions (which covers virtually all appointments that come to the Committee) will be asked to appear before the Committee. There was some disagreement as to how appointees who do not appear at the requested meeting should be handled. The Chair felt that re-appointees that are well known to one or more Committee members and to whom no one on the Committee objects might be confirmed without making a second request to appear. Alderman Johnson felt strongly that all appointees should be treated alike. The matter should play out as we begin our work. President Baker asked that the item be held. The Committee voted 7-0 to hold it after a lengthy discussion.
