HIS HONOR THE MAYOR requesting Home Rule legislation to amend the statutes that govern the Newton Community Development Authority (NCDA) and the Newton Housing Authority (NHA) relative to the NCDA acquiring affordable housing and to update the enabling acts in order to have them more accurately reflect the current operations of the NCDA and the NHA.

ACTION:

ZONING & PLANNING APPROVED AS AMENDED 6-0 (LAPPIN NOT VOTING)
PROGRAMS & SERVICES APPROVED AS AMENDED 7-0

NOTE: Mr. Kruse and Ms. Smalley went through the detailed item and explained the differences between the current legislation and that proposed. Currently the Newton Community Development Authority (NCDA) is able to only take property from the city. The NCDA needs more flexibility to participate in various new programs. This key change is embodied in section 7(o). Other changes clarify the actual roles that the Newton Housing Authority (NHA) and NCDA have been carrying out in the administration of Community Development Block Grants, the HOME program, etc., and in use of the ten-percent ordinance funds, and the implementation of the First Time Home Buyers Program.

Alderman Yates pointed out several changes that need to be made to reflect updating: "secretary of communities and development is now the "director of housing and community development." The "department of community affairs" is now the "department of housing and community development." The "city auditor" is now the "city comptroller." These technical changes were moved by Alderman Baker and accepted 6-0 by Zoning and Planning Committee 6-0 (Alderman Lappin had left to attend the meeting of Public Facilities).

Alderman Parker objected to adding upper moderate income to section 7(o), which had been moved by Aldermen Baker. It nonetheless passed 6-0 in Zoning and Planning Committee.

Alderman Yates said that the standby economic development powers of section 7(1) belonged with the Economic Development Commission. Members of Zoning and Planning agreed, and voted 6-0 to eliminate that section, and re-letter subsequent sections.

The committee then voted 6-0 to approve the item as amended.
