NOTE: The goal of the Ward aldermen and mayor was to find individuals with diverse backgrounds and skills to serve on both Joint Advisory Planning Groups. Resumes were attached to the agenda.

In the case of 1294 Centre Street, the group includes among other disciplines a planner, architect, attorney, neighbors, historian, writer, urban designer, abutter, and business owner. Finding a business owner was difficult because businesses involved in the proposed development of the Cypress Street parking lot were precluded, since they had potential financial interests that could conflict with the future reuse of the Health Department building. One appointee, Mr. Micozzi, was a bit reluctant to commit because he expects to be away for part of the summer. Ms. Havens suggested and the committee agreed that if a suitable replacement can be found, he might serve as an "alternate" member. The meetings are open to all who wish to attend.

In the case of 70 Crescent Street, with input from the Aldermen from Wards 3 and 4, which this site straddles, the group has among it a landscape architect, a planner, a member of the Historical Commission, and neighbors. There may be two additional appointees. In that case, they will be docketed in July. Again, the meetings are open to anyone who wishes to attend. Alderman Harney submitted an email in strong support of Angelo Conti, a longtime resident who owns two pieces of property both abutting 70 Crescent Street.

The Committee was impressed with the breadth of experience in both groups and voted 5-0 to confirm the appointees.
