Malcolm S. Salter (Chair) – Mal Salter is a former Senior Associate Dean and chaired Professor at the Harvard Business School. For over two decades, Mr. Salter was also president of Mars & Co, a strategy consulting company serving Fortune 100 clients in the United States, Europe, and Asia. His academic and advisory work has focused on the economics of business strategy and organizations, and the governance of public enterprises. His most recent book (2008) addresses the lessons to be learned from the collapse of Enron. A longtime resident of Newton, he served on the City of Newton's Blue Ribbon Commission on the Municipal Budget from September 2006 – February 2007. Mr. Salter has sat on numerous boards of business and nonprofit organizations, and currently serves as a Trustee and Director of the Dana Farber Cancer Institute, where he is an active member of both the Finance Committee and Science Committee. He and he wife, BJ, have also been active participants in a variety of arts organizations throughout the larger Boston community for over 30 years.

Ruthanne Fuller (Vice Chair) – Ruthanne Fuller is a citizen activist with broad education and experience in government and nonprofit organizations. When she lived in Brookline, Ms. Fuller co-chaired the town's Financial Planning Advisory Committee from 1993 – 1994, as well as served on the town's Brookline Finance Committee and chaired its Strategic Planning Sub-Committee. She lives with her family in Newton where she is currently President of the longstanding neighborhood organization, The Chestnut Hill Association. Ms. Fuller served on the City of Newton's Blue Ribbon Commission on the Municipal Budget from September 2006 – February 2007. Ms. Fuller also sits on the boards of a number of nonprofit organizations, such as the Boys & Girls' Club of Boston and Facing History and Ourselves, as well as being actively involved in WGBH public television. Ms. Fuller received her undergraduate degree from Brown University and earned a Masters in Business Administration with distinction from the Harvard Business School.

John D'Auria — John D'Auria has been an educator for 37 years, 22 of which he served as a middle school principal. He and his wife Ann have lived in Newton for over 25 years. Their two children attended the Newton Public Schools and graduated from Newton South High School. Most recently, Dr. D'Auria has been the Superintendent of the Canton Public Schools. With experience in urban and suburban settings, he has focused his work on eliminating the achievement gap among students. His writing and professional development initiatives are aimed at developing a vibrant school culture, improving communication, managing difficult conversations, and honing the academic focus of school teams. Dr. D'Auria has also coached aspiring leaders throughout the Commonwealth. He is also the co-author, with Jon Saphier, of *How to Bring Vision to School Improvement* and *Three Strands Form Strong School Leadership*. Dr. D'Auria received his B.A. and M.Ed. degrees from Boston College and his Ed.D. from University of Massachusetts, Boston.

A management consultant, he helps companies develop sustainable business strategies for greater profitability and reduced risk through strategic and operational approaches. Mr. Dutt has worked to improve the operations of top global corporations by optimizing processes and workforces, reducing waste, standardizing operating systems, defining and implementing programs for key performance metrics, and assessing operational optimization efforts. He has also managed manufacturing organizations with large budgets and diverse work forces. In Newton he has been active with the Green Decade Coalition, the Newton Centre Task Force, the Newton Energy Commission, and the High Performance Building Coalition as well as the Newton-Needham Chamber of Commerce. Mr. Dutt earned his Bachelors Degree in Mechanical Engineering from Princeton University and his MBA from Boston University.

and holds a Master of Science degree from the Krannert School of Industrial Administration at Purdue University and an MPA from the Kennedy School of Government.

Dan Richards – Dan Richards is currently Professor of Economics at Tufts University. Professor Richards earned a Ph.D in economics at Yale in 1981. He has taught finance and applied economics in undergraduate, graduate and executive programs, as well as co-authored a well-known undergraduate textbook on industrial organization. At Tufts, he currently serves as the chair of the University Budget and Priorities Committee, which makes recommendations regarding the expansion or contraction of educational programs, faculty salaries and benefits, and infrastructure spending to the deans of three Tufts schools. The committee also works to develop a three-year strategic plan for these schools indicating the priorities on which budgets are expected to be based. Underlying his work is a strong commitment to making the insights of careful analysis accessible to a general audience and readership. He lives in Newtonville with his family.

**Neil Silverston** – Neil Silverston is President and co-founder of WorkSource Partners, a workforce development firm that designs, implements and manages comprehensive employee education and development programs.
