- TC38-09 JANET WERTHEIMER, 11 Manitoba Road, Waban, requesting parking restrictions on Manitoba Road. (Ward 5)
Approve as amended (4-0). Change parking restrictions on east side of Manitoba Road from No Parking Any Time to No Parking on School Days. Continue 60-day trial of No Parking 3:30 p.m. to 4:30 p.m. on west side of Manitoba Road established on January 21, 2010.
- TC47-09 ALD. SALVUCCI on behalf of Mr. and Mrs. Scarpato requesting (a) parking restrictions on Watertown Street between Washington Street and Davis Avenue (b) parking restrictions on Eden Avenue. (Ward 3)
