#361-05 <u>ALD. SAMUELSON</u> requesting relocation of existing Stop Sign on Chestnut Street northbound at Rte. 9 service road from the south side of the bridge to the north side of the bridge

Note: Requires State approval. HELD 12/15/05

ALD. SAMUELSON requesting No Left Turn on eastbound Route 9 service road south side of the bridge) onto Chestnut Street northbound. Suggested route from eastbound Route 9 off-ramp; turn left onto Quinobequin Road, turn right onto Route 9 service road, and left onto Chestnut Street (north side of bridge).

Note: Requires State approval. HELD 12/15/05

#99-06 JOHN REICHARD, 63 Monadnock Road, Chestnut Hill requesting that parking be restricted to one hour between 7 am and 1 pm, including Saturdays and Sundays, on both sides of Monadnock Road between Wachusett and Hammondswood Roads. (Ward 7)
