 The remaining \$200 was a personal loan, reported as a liability, but not as a contribution as required OCPF guidelines. Additionally, the expenditures were underreported by \$10.78, which includes a \$2 bank fee which was not charged during the reporting period and a \$12.78 fraudulent expenditure to a NJ Dominos Pizza on 3/6/19, money not recovered. Last, the 10/28/19 Blue Chicken Design liability of \$1020 was adjusted to \$937.50 due to a billing error.
