Newton Parks & Recreation Commission Meeting Minutes City Hall, Room 209, 7:00pm January 24, 2011

Meeting called to order at 7:00pm

1. Off-leash Dog Recreation Areas – Fees

- Chairman Magni introduced Alderman Sangiolo who was invited to the meeting to have a discussion on fees for the off-leash areas. Alderman Sangiolo stated the off-leash fees were brought before the Programs & Services Committee (P & S) on October 6, 2010 and will be before P & S again on February 9, 2011. P & S is still waiting for a ruling from the Law Department on whether fees may be charged.
- Commissioner DeRubeis commented Marie Lawlor, Assistant City Solicitor has sent a memo to the Commission stating the City may <u>charge fees for the off-</u> <u>leash areas</u> if:
 - Assessed for a specific government purpose
 - Person assessed can decline service
 - Fee paid is to compensate city for it's costs, which must be reasonable and documented
 - <u>Land that received federal funding/grants.</u> In reviewing the Land and Water Conservation Fund Manual. It is permissible to charge a fee on land that has received federal funds/grants, fees charged to non-residents cannot exceed twice that of residents.
 - Charging a fee will impact the <u>Recreational Use Statute</u>. There are other defenses the City can utilize dependent on the situation.
- Mr. Bernheimer stated the proposed fees have not changed since first proposed in October 2010. The fees proposed are:
 - o The current fees proposed are \$50.00 for residents and \$100.00 for non-residents.
 - O Newton professional dog walker company fee: \$250 for first medallion and \$75 each additional medallion. Non-Newton professional dog walker company fee: \$350.00 for the first medallion and \$100.00 each additional medallion.
- Alderman Sangiolo stated the Board of Aldermen sets fees, if the Commission wants to make any changes, the changes must be submitted before the February 9th P & S meeting.

- Alderman Sangiolo stated fees are a good idea to help with the maintenance of the areas. The P & S committee likes the idea of fees but did have a few questions:
 - 1. If a resident hires a dog walker to take their dog to the off-leash areas, do they also need to also pay the resident fee? Commissioner DeRubeis stated the resident only pays the resident fee if they wish to take their dog to the off-leash area themselves.
 - 2. What is the money being used for and how will the money be spent?
 - 3. Will fees be used for additional enforcement? Commissioner DeRubeis stated this has been discussed. Possibly a part-time enforcement officer may be hired.
- Mr. Bernheimer inquired if the enforcement officer would be located in the offleash areas only. Commissioner DeRubeis stated any fees used to pay for enforcement must strictly be used for off-leash areas.
- Mr. Bernheimer asked if enough money could be raised through fees. Mr. McIntyre stated if there are more sites on-line, more medallions would be purchased.
- Commissioner DeRubeis stated most of the issues occur outside the off-leash areas, an example is Old Cold Spring Park off-leash area. The violations occur on the trails, outside the off-leash area.
- Alderman Sangiolo asked if there had been discussion on raising the dog license fee. Commissioner DeRubeis responded yes, but the license fee is not under the purview of the P & R Commission and David Olson, City Clerk is not inclined to raise the current fee, the fee is similar to those in surrounding communities. Compliance is an issue and raising the fee may cause less compliance.
- Chairman Magni thanked Alderman Sangiolo and asked the Commission members if there should be any changes to the fees structure.
- Mr. Johnson asked where the money from violations will go. Commissioner DeRubeis believes violation fees go into the general fund.
- Mr. Kastner stated using park rangers could be a police union issue.
- Mr. Tucker stated notification of the off-leash area fee will be sent out with the dog license renewal forms. How will those that do not receive the license form, be notified. This could be handled with public relations.
- Chairman Magni stated the fees will go to P & S as previously submitted. The group came to a consensus, the fees will remain as previously proposed:
 - o The current fees proposed are \$50.00 for residents and \$100.00 for non-residents.
 - O Newton professional dog walker company fee: \$250 for first medallion and \$75 each additional medallion. Non-Newton professional dog walker company fee: \$350.00 for the first medallion and \$100.00 each additional medallion.
- Mr. Kastner asked for an update on the Norumbega Proposal. Commissioner DeRubeis stated the Norumbega Park off-leash proposal is going back before the Conservation Commission in February.

2. Meeting Minutes -December 20, 2010

- Accepted 8-0
- 3. Commissioner's Reports on Programs, Forestry and Maintenance

- Commissioner DeRubeis commented the P & R Department Snapshot format is being updated to reflect the RecStat information. The new format will be completed for the February 28th Commission meeting.
- Commissioner DeRubeis reviewed the winter recreation programs at NSHS and NNHS. NNHS pool has programs running from the NNHS, NSHS and the Swim Team; some residents have been upset they do not have more access to the pool. Mr. Fishman inquired if putting a bubble over the Gath Pool has been considered. Commissioner DeRubeis stated yes, the cost would be ~ 2 million dollars, and Gath Pool is in poor condition there would need to be some repairs/reinforcement done in the pool area.
- The Camp Fair is being co-sponsored with the School Department and is being held at NNHS from 1pm-6pm on Sunday, January 30.
- Forestry has had over 180 calls due to downed limbs and trees during the recent snow storm.
- The snow ordinance did not pass in the Programs & Services Committee or Public Facilities Committee. The ordinance still has to go before the Finance Committee and the Full Board of Aldermen. Parks and Recreation has been the administrator for the snow shovelers list which has 176 names on the list. There is also a volunteer shoveler list, when residents call requesting a volunteer shoveler they are referred to either the Senior Center or Health Department depending on their age.
- The Canoe & Kayak program was a success this summer at Nahanton Park. Charles River Canoe & Kayak have submitted a financial report. There is a Request for Proposal (RFP) out now for a kayak and canoe program at Nahanton Park next season. The proposals are due in to the Purchasing Department by February 3.
- The Nahanton Park Working Group is having a meeting with Jeff Collins of the Mass Audubon Extension Group who is leading the Nahanton Park Natural Resources Inventory and Management Project. The meeting will take place on Wednesday, March 2 at 7pm in Drukers Auditorium in the Main Library. Abutters and interested groups will be notified of the meeting.

4. Elections

 Mr. Bernheimer made the motion to re-elect Arthur Magni as Chairman and Kathleen Heitman as Vice-Chairman of the Parks & Recreation Commission.
 Mr. Rice seconded the motion. Motion passed 8-0.

5. New Business

Commissioner DeRubeis commented the following items is going before the Board Of Aldermen and the Parks & Recreation Commission has been asked to review and comment:

#8-09 ALD. HESS-MAHAN, LINSKY, ALBRIGHT, FREEDMAN, MANSFIELD, JOHNSON, HARNEY & VANCE proposing an ordinance requiring that the installation of synthetic in-filled turf athletic fields on city-owned property shall use sustainable, recyclable, lead-free, non-toxic products to the maximum extent feasible. [12/30/08 @ 9:55 AM]

- The issue is with the crumb rubber used in the synthetic turf, they are looking for an alternative material.
- Mr. Kastner recommended removing the word "maximum". Maximum equals expensive materials, which could cost the City a lot of money. Mr. Bernheimer agreed.
- Ms. Charkoudian inquired if the current synthetic fields are lead filled and toxic.
 Mr. Fishman stated it is unclear. Mr. Stern agreed the science is unclear.
- Mr. Clarke commented EPA standards allow for 8% of lead in lead free brass used for household water pipes. Lead free needs to be defined.
- Commissioner DeRubeis commented equipment was purchased specifically for maintenance of the crumb rubber. It would need to be determined if the current equipment could be used with different products.
- The final comments from the Commission on Item #8-09:
 - 1. Is this ordinance really necessary?
 - 2. If it is necessary will existing synthetic turf fields be grandfathered into the ordinance?
 - 3. Remove the word 'maximum" from the ordinance

Meeting called to order at 7:05pm

1. Meeting Minutes - January 24, 2011

Minutes approved 7-0

2. Commissioner's Reports on Programs, Forestry and Maintenance

- o Commissioner DeRubeis presented and reviewed an updated department "snapshot" (attached). The Commissioner will present this snapshot to the Commission each month.
- o Commissioner DeRubeis stated the January 30th Camp Fair was a success. The department partnered with the Newton Public Schools and held the camp fair at NNHS.
- February school vacation camp took place last week. Vacation camps fill up quickly. All went well.
- o March 2nd at 7pm in Druker Auditorium a public meeting is scheduled for the Nahanton Park Natural Resources Inventory and Management Plan study being performed by Jeff Collins of Mass Audubon.

3. Susan G. Komen 3-Day for the Cure Event- information only

o Jennifer Ricker, SGK 3-Day Event Coordinator reviewed the proposal (attached). The Komen 3-Day for the Cure is an incredible special event. Thousands of women and men will unite for three days, July 22-24, 2011, and walk 60 miles in a bold display of courage and commitment. It's a weekend of hope, as we honor lives lost, celebrate survivors and help bring breast cancer care to those who so desperately need it. Net proceeds from the Komen 3 Day for the Cure fund innovative global breast cancer research and local community programs supporting education, screening and treatment. Virtually every major advance in the fight against breast cancer in the last 27 years has been impacted by a Susan G. Komen for the Cure® grant. We would like to request the use of fields at West Newton Playground on Friday, July 22, 2011 from 9:00am to 5:00pm as a rest stop for our 2,000 participants (NOTE:

Only 100 to 150 people on-site at any given time). At a typical Pit Stop we would erect three 15'x15' non-staked tents for our staff and volunteers who will offer food, drink and medical attention to the Walkers who elect to stop. All food and drink are provided by the event. Nothing will be sold on site. In addition, we would place several portable toilets on the premises. Trash boxes will be provided to collect trash and debris. Once the site is a closed, all trash will be disposed of in our dumpsters located off-site.

- o Mr. Stern asked if the Police are required at street crossings. Ms. Ricker stated yes at some of the street crossings. Ms. Ricker is in contact with the Police, Fire and Inspectional Services Departments. Commissioner DeRubeis requested Ms. Ricker set up a meeting with him and Captain Mintz.
- The drop off time of supplies at the location is usually at 4am but can be pushed to 6am. Commissioner DeRubeis stated 6am would be a better time for the neighbors.
- Ms. Ricker inquired about who she should contact to use the NNHS as an alternate location for inclement weather. Commissioner DeRubeis recommended Ms. Ricker contact the School Department.
- o Commissioner DeRubeis commented notification will be sent to the West Newton Playground abutters of this event. The abutters will be given the opportunity to ask questions and comment on the proposal at the March 21st Commission meeting.
- Ms. Ricker will attend the March 21st Commission meeting to respond to abutters questions and concerns.

4. Clay Court Tennis Fees - Mike Lewitt

o Mr. Lewitt is under contract with the City as the manager of the clay courts in Newton Centre and to provide tennis lessons city wide. Mr. Lewitt presented the 2011 Clay Court rules and regulations and fees (attached). Mr. Lewitt stated there have been no changes to the rules, regulations or fees.

Mr. Bernheimer made the motion to accept the 2011 clay court rules, regulations and fees. Ms. Heitman seconded the motion. Motion passed 7-0.

5. Off-leash Area Working Group- update

- o Commissioner DeRubeis provided an update on the amendment to the off-leash dog ordinance:
- o On February 23, 2011 at the Programs & Services Committee meeting, agenda item #360-09(4) was presented to make the following amendment (in bolded text) to Chapter 3, Section 3-30 of the City Ordinances, Dogs Off-Leash Program:
- (c) Rules and Regulations. In addition to the minimum conditions listed in section (a) applicable to all designated off-leash areas, the commissioner may from time to time promulgate rules and regulations for the general operation and use of all off-leash areas, as well as rules and regulations specific to the use and operation of an individual site. The commissioner may require permits and set reasonable fees for participation in the off-leash program. The commissioner may impose time, seasonal, or other restrictions for the use of any area. In the case of off leash areas on sites under the jurisdiction of another

agency or commission, that agency or commission shall approve such rules, regulations and restrictions, and may make such additional rules, regulations, and restrictions it deems necessary.

- The Programs and Services Committee voted on and approved the amendment. This amendment will be presented to the full Board of Aldermen on March 7.
- Mr. Bernheimer stated this amendment is the best approach.
- Commissioner DeRubeis stated the Off-Leash Area Working Group is reviewing the fees but there have been no changes to the fees originally presented.
- Mr. Stern inquired if there will be additional enforcement for off-leash areas. Commissioner DeRubeis commented there is discussion on hiring two part time animal control officers.
- o A request to the Conservation Commission was made by Director Havens to postpone the Norumbega off-leash area proposal. During the February 24 Conservation Commission meeting there was a vote not to allow off-leash dogs in conservation areas.
- o Mr. Fishman commented the neighbors use Norumbega Park to walk their dog's off-leash, but they do not want the area made into a legal off-leash site.
- o Mr. Tucker inquired if Norumbega Park is the only conservation area proposed for an off-leash area. Commissioner DeRubeis said no, Flowed Meadow is also a proposed off-leash site.
- Mr. Bernheimer commented the Commission needs to go with what is in place and see how it works. Ms. Heitman agrees.
- o Commissioner DeRubeis commented he will be requesting the contingencies be lifted from the off-leash areas at the March 21 meeting. When the areas are open he is hoping the people who use the areas will contact him if there are any problems.
- Commissioner DeRubeis commented two accounts have been set up for the off-leash areas; one account will be for the fees, the second account will be for gifts/donations.

Meeting called to order at 7:01pm

1. Meeting Minutes -February 28, 2011

Minutes approved 8-0

2. Commissioner's Reports on Programs, Forestry and Maintenance

- Commissioner DeRubeis presented and reviewed the department "snapshot" (attached).
- o The Clancy Basketball Tournament was held on March 5, 2011.
- o Camp Counselor interviews are scheduled this month.
- Mayor Warren has appointed Commissioner DeRubeis as the Marathon facilitator.
- April Vacation Camp is scheduled and open for registration
- Newton Corner Library is going through the re-use process; Commissioner DeRubeis has requested use of the Newton Corner Library. The Parks and Recreation administration and program staff would move from 70 Crescent Street to the Newton Corner Library.
- o Due to the winter storms there are many tree limbs down. Forestry, with the assistance of Public Works, is picking up the limbs. The limbs are being stored at Nahanton Park until they are ground up and removed at a later date.

3. Susan G. Komen 3-Day for the Cure Event

o Chairman Magni stated the abutters of the Elm Street Park in West Newton have been notified of this event. Jennifer Ricker, Event Coordinator was present to answer any questions. Chairman Magni requested comments, questions or concerns from those present at the meeting. There were no comments, questions or concerns.

Mr. Johnson made the motion to accept the proposal as submitted for the Susan G. Komen 3-Day for the Cure Event on Friday, July 22, 2011. Ms. Heitman seconded the motion. Motion passed 8-0.

4. Relay For Life

- o Gillian Baudreau, representative from the American Cancer Society for the Relay for Life presented the proposal (summary attached). The American Cancer Society would like to formally request the use of Forte Park for its annual Relay for Life event, taking place on Sunday May 21-22, 2011. We would like to request the use of the entire park beginning at 6:00 a.m. on May 21 and ending at 6 p.m. on May 22. Teams of 1-15 people set up campsites and take turns walking the track while enjoying music, food and entertainment. Last year the event raised \$42,000 to fight cancer. Since the event has been held at Forte Park the fund raising amount has increased.
- o Chairman Magni thanked Ms. Boudreau. The abutters will be notified of this event and Ms. Baudreau should be present at the April 25, 2011 Commission meeting to respond to comments and questions from the abutters.

5. St. Mary of Carmen Festival

- Chuck Proia is requesting the use of JoAnne C. Pelligrini Playground for the 76th annual St. Mary of Carmen festival (letter attached).
 - Set-up will begin Monday July 11th at 8 a.m.
 - Festival begins Wednesday July 13 and closes Sunday July 17.
 - Fiesta Shows will operate the carnival and food vendors.
- There have been no significant changes to the festival from last year.
- o Commissioner DeRubeis commented there has been new construction around Hawthorne and the carnival will have to be careful with the new concrete. Mr. Proia is aware of the construction and will take care of the concrete.
- o Chairman Magni commented the abutters will be notified of this event and Mr. Proia should be present at the April 25, 2011 Commission meeting to respond to comments and questions from the abutters.

6. Lowell Park Master Plan

- o Danielle Bailey from the Planning & Development Department presented the updated Master Plan for Lowell Park (map attached). The Master Plan was presented to the Commission in December 2008. Since December 2008 there have been meetings with the Newtonville Advisory Committee and the Landscape Architect, Ray Dunetz. Abutters, the Historic Commission and the neighborhood were also notified of this meeting tonight, a total of six hundred people were notified.
- Mr. Tucker asked if there are new trees to be planted. Ms. Bailey stated yes, there are existing trees and there will be new trees planted under the supervision of the City's Tree Warden.
- Mr. Stern asked if the funding is still in place. Ms. Bailey stated yes the funding is in place.
- Mr. Stern asked if maintenance is included in the funding. Ms. Bailey stated no, CDGB funding does not include maintenance.
- Mr. Bernheimer stated the P & R Department maintains the park. Commissioner DeRubeis does not expect an increase in maintenance costs.
- Mr. Kastner asked if the benches have backs. Ms. Bailey stated yes, bench backs are considered accessible benches.

- Mr. Bernheimer inquired if any of the funding has come from the neighborhood. Ms. Bailey stated no, the funding is CDBG funding.
- Mr. Stern inquired if the MBTA was going to move the bus stop shelter. Ms. Bailey stated no, the City is considering participating in the MBTA shelter program (CIMUSA bus shelters).
- o Mr. Johnson commented there appears to be more asphalt in the updated plan. Ms. Bailey said yes there is more asphalt. The pathway now connects both sides of the park to the streets on each side.
- Mr. Kastner recommended Ms. Bailey speak with the Mayor's Committee for People with Disabilities, in regards to pathway surfacing.
- o Mr. Clarke asked what type of bike rack was being installed. Mr. Clarke recommended not using the standard school yard bike rack because the bikes fall over. Ms. Bailey stated the bike rack has been ordered and it is not a standard bike rack.
- Chairman Magni asked the Commission members what is next for this master plan. Mr. Stern would like more details on the plan before he votes. Ms. Charkoudian agreed with Mr. Stern.
- Ms. Bailey stated the master plan must be approved for the money to be available for construction documents.
- o Ms. Schein, P & R Open Space Coordinator stated there aren't any amenities proposed in this master plan that don't exist in our parks. Ms. Schein stated the process of this master plan has been thoughtful, responsive, modest and has been revised to meet the budget.
- Commissioner DeRubeis stated at the December 2008 meeting the issues circled around the traffic. The traffic issues have been resolved.
- o Mr. Bernheimer stated whatever modifications need to be made will be minor; there is no reason not to approve the master plan. Mr. Bernheimer stated he has confidence in the P & R staff.
- Mr. Kastner stated the master plan is a general layout/theme, and this master plan is fine. The Commission asked to see the final construction plans when the time comes.

Mr. Bernheimer made the motion to approve the Lowell Park Master Plan subject to seeing the final specs before going to public bid. Ms. Heitman seconded the motion. Motion passed 8-0.

7. Off-leash Area Working Group Update

- o Commissioner DeRubeis updated the Commission members:
 - The fees have been accepted and passed by the Board of Aldermen
 - Two revolving accounts have been approved by the Board of Aldermen and set up by the Comptroller. One account is for fees, the second account is for any donations collected.
 - The \$50,000.00 gift from the Leveen family for the off-leash areas is going before the Finance Committee on March 28th.
 - A budget for the off-leash areas has been drafted (attached)
 - The signage is ready to go to print for each of the areas.
 - Mutt Mitts are ready to be ordered and installed for each location.
 - David Olson, City Clerk, is ready to administer the medallions and permits.

- An off-leash recreation brochure has been created as information for residents. The brochure will be sent to residents with the mailing done by the City Clerk to the licensed dog owners the first week of April.
- Mr. Stern asked if there were conditions to the gift. Commissioner DeRubeis stated yes there are some restrictions but the gift is under the control of the P & R Department.
- o Commissioner DeRubeis stated Newton Centre, Claflin Playground and McGrath Park will be ready to open around April 15th. Hunnewell Park and Cabot Park should be ready to open sometime in May after the fences have been installed.
- o Mr. Stern asked what the projected compliance rate is. Commissioner DeRubeis stated based on Brookline, of those residents sent notification of the off-leash fees, 50% have purchased a permit.
- Mr. Johnson requested the violation information be included on the signage. Mr. Stern requested that notification of the \$50.00 fine also be included.
- Mr. Tucker inquired if the brochure will be posted on the website. Commissioner DeRubeis said yes, and the TAB will be notified.
- Mr. Johnson asked if the off-leash recreation permit application will be on the website for download. Commissioner DeRubeis will check with the City Clerk.
 David Olson has been a great help in implementing the off-leash fee program.
- Mr. Kastner asked if there should be public comment before the motion. Chairman Magni asked for comments.
 - Kathy Quimby, of Gordon Rd. commented she is impressed with the progress that has been made.
 - Harry Sanders commented the six sites to be approved are open field, non-tree settings. There is another off-leash culture that enjoys trail walking with their dogs. There also needs to be off-leash areas on the south side of the city.

Mr. Bernheimer made the motion to authorize the P & R Commissioner to open the specific parks approved by the Commission on a schedule he sees fit. Mr. Johnson seconded the motion. Motion passed 8-0.

8. New Business

Cold Spring Park Incident

- o Commissioner DeRubeis stated last week there was an incident at Cold Spring Park where a Terrier was killed by a Great Dane. This incident was human error and could have happened on a street corner. Commissioner DeRubeis referred to Animal Control Officer Ralph Torres. Officer Torres commented the owner of the Great Dane had a self imposed muzzle order due to a separate incident. The terrier was killed and the Terriers owner was bitten. The Great Dane was removed from the State the day after the incident.
- Mr. Bernheimer stated most of those present are responsible dog owners and they have a responsibility to educate those who willfully disobey the rules.
 Mr. Stern stated that is a nice thought but they are not the police.
- Commissioner DeRubeis stated there is a plan to hire a part-time animal control officer to assist Officer Torres. Part of the responsibility of the parttime person will be to educate.

Nahanton Park

- o Commissioner DeRubeis stated there are over 2,000 locations around the City that have downed limbs and brush from the winter snow storms. There are different dumpsites around the City to dump snow and limbs and Nahanton Park is number three on the list. Public Works has been assisting with the pick-up and the debris has been dumped at Nahanton Park, Winchester Street entrance.
- o On Friday there was a meeting with Duane Hillis, Friends of Nahanton Park, Newton Conservators and Bob Rooney, Dave Turocy, DPW, Chairman Magni at Nahanton Park. Mr. Hillis and others were asking why Nahanton Park?
- o Mr. Stern stated there were a lot of Christmas trees included in the debris. Commissioner DeRubeis commented when there is a mass pick up of limbs there ends up being a lot of private yard waste included.
- o Commissioner DeRubeis stated the meeting went well. We need to reassess private locations. The City has contacted New England Development, the owner of the old Omni Foods to use that location to store the limbs.
- Mr. Stern stated Wellesley pipes sewerage through Newton, do they have available sites.
- Mr. Bernheimer asked what happens to the limbs that are dumped at these sites. Commissioner DeRubeis stated a tub grinder will chip the limbs into a truck for removal.
- o Mr. Kastner asked what the long term solution is for the Public Building Department using the building in Nahanton Park. Mr. Stern inquired if the Audubon is including the building in the Natural Resources Inventory and Management Plan for Nahanton Park. Commissioner DeRubeis stated yes.
- o Mr. Hillis thanked Commissioner DeRubeis, Chairman Magni, Mr. Rooney and Mr. Turocy. They have listened and been very responsive regarding this issue. It is important to the park users to see this type of response. Mr. Hillis stated for the future the City needs a chipper and truck to dispose of limbs as they fall instead of dumping the limbs in the parks. The Audubon is looking at the building and Mr. Hillis would like to get cost estimates to repair the building. The outcome of the building should be thought about by all groups, maybe the building should be taken down and the area returned to nature.





1. Meeting Minutes - March 21, 2011

Accepted 6-0

2. Commissioner's Reports on Programs, Forestry and Maintenance

- o **Department Snapshot** Commissioner DeRubeis reviewed the snapshot (attached).
- o **Budget** The FY12 budget book and a line item report were distributed to the members. Discussion on the budget was held for the end of the meeting
- o Off-leash Area Working Group Commissioner DeRubeis commented three additional off-leash recreation areas opened on Thursday April 21; Claflin Playground, Newton Centre Playground and McGrath Park. Signs and Mutt-Mitt dog waste disposal dispensers have been installed at each site. The City Clerk has sold 420 resident medallions and one professional dog walker medallion.

3. Relay For Life – Public Hearing

o Chairman Magni stated the abutters of Forte Park have been notified of this event scheduled for May 21 and May 22. Sharon Stout, Event Coordinator was present to answer any questions. Chairman Magni requested comments, questions or concerns from those present at the meeting. There were no comments, questions or concerns.

Mr. Bernheimer made the motion to accept the Relay for Life proposal as presented. Mr. Tucker seconded the motion. The motion passed 6-0.

4. St. Mary of Carmen Festival - Public Hearing

- Chairman Magni stated the abutters of Pelligrini Park have been notified of this
 event scheduled July 13 July 17. Chuck Proia, Event Coordinator and John Flynn,
 Festival Manager were present to answer any questions. Chairman Magni requested
 comments, questions or concerns from those present at the meeting.
- o Mr. Marini of 45 Hawthorne St. stated he is not against the carnival but requested a buffer zone on the rides and to reduce the music. Mr. Proia commented there is a 50' buffer zone and the music is shut off at 9:00 pm. If the buffer zone is increased the carnival would lose money. Quieter rides have been put in the area of Mr. Marini's home. Mr. Marini asked if there is a footprint for the carnival. Mr. Proia stated yes the City gives them the footprint.
- o Mr. Deluca of 30 Hawthorne St. has spoken with Mr. Proia regarding the carnival and he listens to the abutters, and noise has been reduced. Mr. Deluca's concern is the porta-potty's that are dropped off on Monday before the carnival and are lined up in front of his house. Before the carnival begins on Wednesday the porta-potty's are moved to the back, but until then the smell at his house is awful and they are lined up right in front of his house. Mr. Bernheimer asked why the porta-potty cannot be dropped off in the back on Monday. Mr. Flynn stated they did not want to damage the field with the big truck driving on the field. The porta-potty is brought to the back with a hand lift. Mr. Bernheimer suggested having the porta-potty's delivered on Wednesday instead of Monday.
- o Commissioner DeRubeis commented Mr. Flynn the Carnival Manager has made great improvements in his time of managing the carnival.
- Alderman Lennon commented the administration changes have been for the better.
 The carnival is a great event.

Mr. Tucker made the motion to approve the carnival as proposed. Ms. Charkoudian seconded the motion. Motion passed 6-0.

5. Nahanton Park - Parking Lot Proposal

- o Ms. Schein presented a proposal (attached) to expand the upper parking lot at the Nahanton Street entrance. The need for expanded parking is anticipated due to increased usage of Nahanton Park in general and specifically with Charles River Canoe & kayak rentals for 5 months. And the department is being proactive in gathering input on this proposal. Ms. Schein took the recommendations for the parking areas from the Master Plan developed by Pressley Associates.
- Ms. Heitman commented the Canoe & Kayak rentals was very busy last summer, this
 was a great addition to the park. Mr. Tucker asked if the Canoe & Kayak Company
 approves of the proposal. Ms. Schein stated yes.
- O Commissioner DeRubeis asked what type of surface would be added to the area. Ms. Schein stated the area would not be paved. Gravel and stone dust would be used for the surface. Anne Phelps of the Conservation Commission did not have any issues with this proposal as it is outside of 200' from the Charles River.
- o Ms. Jane Sender of the Newton Conservators reminded the Commission of the Natural Resources Inventory and Management Plan for Nahanton Park that is in progress. Jeff Collins of the Audubon should look at this area. There are Wood Cock's in the area, it is a sensitive area. The existing upper parking area should be used first without removing existing brush.

- Mr. Magni asked if the existing parking area had been looked at. Ms. Schein said improving just the existing parking lot foot print could be considered. Ms. Schein stated Mr. Collins will be out in May to look at the area.
- o Ms. Suzette Barbier of the Newton Conservators stated the upper lot on Winchester Street should be considered as there is plenty of parking in this area. It would take the same amount of time to walk from the Winchester Street parking area as it would from the proposed area. We should work with what we have.
- Ms. Sender recommended using signage to direct people to the Winchester Street lot.
- Mr. Duane Hillis of Winchester Street commented Ms. Barbier's comment is valid.
 The parking is short term for rentals. You have not looked at all the options. The Winchester Street entrance is not cleaned up from the snow dumping this winter.
- o Commissioner DeRubeis commented Mr. Hillis is correct the Winchester Street entrance should have been cleaned up by now.
- o Mr. Fishman stated the previous comments of redirecting traffic and looking at the parking situation at Nahanton Park is valid. This proposal is worth looking at.
- o Ms. Schein stated this proposal is informational only.

6. Farlow Park - Keith Jones

- Mr. Jones provided an update to the Commission of the Farlow Park Pond restoration project for a vote so the project can go to the Community Preservation Committee (CPC).
- o Mr. Jones displayed pictures from the early 1900's of Farlow Park with the pond and the bridge. Mr. Jones has been working on this project since 2004. Phase One of the project was to gather information. Five spots have been dug in the basin. The basin appears to be intact, and there are no cracks in the concrete.
- Safety around the pond was an issue. Thirteen communities were surveyed including Boston. None of the communities require fencing around the ponds and had no concerns.
- o Mr. Tucker asked how high the curbing is around the pond. Mr. Jones stated the curbing is even with the ground.
- o Mr. Jones commented a well has been dug and there is enough water available to supply the pond and possibly the irrigation system at the Underwood School. Mike Cronin of the NPS Operations Department has agreed to pay the electric bill for the system. The water bill is approximately \$5,000.00. The electric bill will be less than \$3,000.00. That is a savings for the school of \$2,000.00.
- o Mr. Jones distributed a draft of the budget (attached). Chairman Magni asked if the bridge is included. Mr. Jones stated no.
- o Chairman Magni asked if the members wanted to take a vote.
- o Mr. Bernheimer, who is also a member of the CPC commented if legislation is amended to include park projects, where would the Farlow Park project be as a priority, currently there are master plans for Braceland and Whitmore parks.
- Mr. Jones stated Farlow Park is in the Historic Registry as the oldest park in Newton.
 It is a restoration project.
- o Mr. Bernheimer stated the CPC has many historic projects.
- o Commissioner DeRubeis commented funds have been raised to test the well to confirm the well will supply the pond and the irrigation system.

- o Mr. Tucker recommended having a public hearing after the well test is complete. Mr. Bernheimer commented the CPC will not hear any new projects until October.
- o Commissioner DeRubeis recommended having the well test done in May and the public hearing in June. Chairman Magni agreed.

8. Crystal Lake & Gath Pool Swim Fees

- Ms. Stapleton presented the 2011 swim fees for Crystal Lake and Gath Pool (attached). There are no changes to the fees from the 2010 season.
- o Mr. Bernheimer stated swim fees should be raised.
- Ms. Stapleton commented 144 scholarships were provided at Crystal Lake last year and 274 scholarships were provided at Gath Pool.

Mr. Fishman made the motion to accept the swim fees as proposed. Ms. Heitman seconded the motion. Motion passed 5-1.

9. New Business

NWLL – Scoreboard

- Mr. Enselek handed out documentation (attached) requesting permission to install a new scoreboard at Lyons Field. The new scoreboard will be:
 - Made of aluminum
 - Using wireless technology, which will eliminate the need for one volunteer
 - Approximately 4' x 8' x 6"
 - No need for electrical wires, pipes already have been installed
 - Hung in left field the same as the existing sign
 - Taken down in the Fall
- Mr. Bernheimer asked if there will be advertising on the sign. Mr. Enselek said no. Mr. Bernheimer stated if this sign will be replacing the existing sign a public hearing is not necessary.

Mr. Bernheimer made the motion to accept the request for a new sign by NWLL. Ms. Heitman seconded the motion. Motion passed 6-0.

Budget

- Commissioner DeRubeis handed out the Parks & Recreation Budget report book created by Marc Welch, Forestry Director and a line item budget report.
- This budget was a zero based budget. Commissioner DeRubeis looked at the budgets from the past 5 years and took an average
- The department has a \$94,000.00 cut. Two maintenance positions were cut through attrition along with \$6,000.00 from work by other departments, which was money for custodians at NNHS.
- Mr. Bernheimer asked how these cuts will effect the department.
 Commissioner DeRubeis stated he is working with Nancy Forrester, Director of Performance Management to find efficiencies to save money.


- Ms. Charkoudian asked the difference between wages and salaries.





 - 3 Newton based professional dog walking company permits have been purchased.
 - Mr. Kastner asked if attendance at the Old Cold Spring Park off-leash area has gone down. Commissioner DeRubeis commented that Officer Torres has said the attendance has gone down at Old Cold Spring Park off-leash area.

3. Susan G. Komen 3 day for the cure event- McGrath Park - Public Hearing

o Jennifer Ricker, Event Coordinator presented a map (attached) of McGrath Park describing the route and layout for the lunch stop at McGrath Park on Friday July 22, 2011. Lasell College has been used for the lunch stop but Lasell is unavailable due to construction. There will be six tents, two food tents, two water tents and two medical tents. There will be 2-3 buses to transport people. The portable toilets will be brought in Thursday afternoon and will be removed by Friday afternoon. The lunch stop hours are from 11:15 am-2:45pm.

- o Commissioner DeRubeis commented all of the items are located in the P & R parking area. Ms. Ricker stated yes there is no need to put the tents on the field; the participants will sit on the ground to eat their lunch.

- o Mr. Stern asked if there would be any signage. Mr. Matthew stated no, there would be no signage.



1. How many resident off-leash permits have been sold?

To date there have been 566 off-leash permits sold.

2. How many non-resident off-leash permits have been sold?

There have been 2 non-resident off-leash permits sold, both to individuals in Needham.


3. How many professional dog walker permits have been sold?

To date there have been 3 sold to Newton based companies.

- **4. Has any resident purchased their dog license while purchasing a medallion?** Yes. There have been a few, but it is only about 8% of the total. The vast majority, 92%, of off-leash permits sold have been to owners who had already licensed their dogs
- **5. Do you see an increase in dog license compliance?** We are seeing an increase in compliance; however, it is hard to say it is directly from the sale of off-leash permits. Only fifteen dog owners are both new to our licensing system and have purchased both a license and off-leash permit for the first time, since we started selling off-leash permits. We have been working hard over the last few years to bring the number of licensed dogs up with marketing and advertising, and the trend is continuing. We are on track to license 4,000 dogs this year.







2. Commissioner's Reports on Programs, Forestry and Maintenance

3. Farlow Park - Keith Jones

Mr. Jones presented the proposal for the Farlow Park Pond restoration to the Commission at the April 25, 2011 meeting. The Commission requested Mr. Jones return to the Commission after the draw down test was completed. The draw down test was done to verify the well will supply enough water to the pond. A summary of the project including the draw down test were submitted (attached). Mr. Jones is requesting approval on the project to move forward for a public hearing in September.

- Commissioner DeRubeis asked for the test results. Mr. Jones stated the test determined the well will supply the pond with 20-25 gallons per minute and will also supply the irrigation system for the season.
- Chairman Magni asked the members if there were any questions.
- Mr. Clarke asked if there was a lot of sediment. Mr. Jones stated there is 18" of soil. Mr. Clarke asked if the depth of the pond is 18". Mr. Jones stared yes the pond is being restored to its original depth of 18". Mr. Clarke asked if a quality test was done on the water. Mr. Jones stated no.
- Mr. Kastner asked if a concrete core sample was taken.
 Commissioner DeRubeis stated yes the concrete basin is in tact.
- Mr. Clarke commented the summary mentions skating during the winter, who will manage the skating at the pond. Mr. Jones stated the Friends of Farlow Park would try to make it work. Mr. Clarke asked how skating would effect the concrete. Mr. Jones stated that is a good question and will follow-up with Weston & Sampson.

Mr. Rice made the motion to approve the concept of restoring Farlow Park Pond as presented. Ms. Heitman seconded the motion. The motion passed 8-0.

4. Lowell Park - Danielle Bailey

- Ms. Bailey from the Newton Planning Department came before the Commission to present the Master Plan for the restoration of Lowell Park in March of 2011. The Commission approved the plan for Lowell Park but requested she return with the final plans before construction began in the park.
- Ms. Bailey presented the final plans (attached). The final plans include three benches, the signs to be posted, tree & shrub removals and plantings and an adopt-a-space apple orchard. Ms. Bailey introduced Newton resident Michael Dugan who came up with the idea of the apple orchard.
- Mr. Tucker asked if the trees will be ok with all the vehicle exhaust. Mr. Dugan stated yes.
- Ms. Charkoudian asked what type of apples. Mr. Dugan stated Dwarf, organic apples.
- Mr. Clarke asked if the apples are dwarf or the trees. Mr. Dugan replied the trees are dwarf, they will grow to around 12'.
- Mr. Tucker asked what the square footage is for the area. Ms. Bailey commented the park is a half acre.
- Ms. Bailey commented there will also be a community planting bed and a new bike rack. New curb cuts will be installed using CDBG funding by the Department of Public Works.
- Mr. Sanders, Newton resident asked Ms. Bailey if she is aware of the problems buses and trucks have turning the corner of Walnut and Watertown Street. If the curbs are extended it will be even more difficult for large vehicles to turn that corner.

- Mr. Kastner asked how the trees and garden will be watered. Ms.
 Bailey stated that will need to be determined.
- Chairman Magni asked for the timeline of the construction. Ms.
 Bailey stated tree work would begin in August, DPW will begin work in September, turf and additional tree work will begin on October.
- Ms. Chairman thanked Ms. Bailey and Mr. Dugan.

5. Half court basketball court- Lincoln Warren Park-

- Stephanie Lapham-P & R Dept. Alderman Rice, Dave Miller, Resident were present.
- Mr. Miller stated he purchased the property across from the Lincoln Warren Park and he is proposing a half court basketball court be added to the park. Money will be raised to build the court.
- Mr. Rice asked if the court would be fenced.
- Mr. Kastner asked if the school sites have been considered.
- Ms. Lapham commented the school does have a basketball court.
 And other areas have been looked at within the park. The court requires accessibility.
- Chairman Magni asked if the area needs to be paved for accessibility.
 Ms Lapham stated no, a hard surface is required.
- Mr. Tucker asked if there has been input from all of the neighbors.
- Ms. Lapham said there is a group interested. Chairman Magni asked if the group understands the public process. Ms. Lapham stated yes.
- Mr. Fishman commented the neighborhood should be polled. The sports leagues should be involved. A couple of options should be brought forward.
- Commissioner DeRubeis stated this idea needs more research. This is a heavily used area.

6. Off-Leash Area Working Group - Presentation

- Commissioner DeRubeis stated there are 5 open off-leash recreation areas, Cold Spring Park, Newton Centre, Claflin Playground, McGrath Park and Hunnewell Park which is a fenced area. Cabot Park should be opened within the next week. Cabot Park is a fenced area also.
- The City Clerk reported to there have been 606 Resident Medallions Sold.
- Commissioner DeRubeis presented (attached) four areas as proposed off-leash recreation areas:
 - Forte Park
 - o Ward 1
 - Open weekdays dawn to noon
 - Goose Mitigation
 - Ample parking
 - Spears Park
 - Ward 1 Ms. Elizabeth Spears left the gift of land at 89
 Walnut Park to the City of Newton in her will. In 1936 the gift was accepted by the City of Newton and named Spears Park.

- o Currently an unused space
- Fenced area –currently fenced on two sides install ornamental fence
- o Hours: dawn- dusk
- o Small dog area- dogs less than 25 lbs.
- o Memorial bench for Ms. Spears to be donated and placed in the park.
- West Newton Common
 - o Ward 3
 - Hours of operation
 - o March 16th December 14th
 - o Weekdays: dawn-noon
 - o December 15th March 15th
 - Weekdays dawn-dusk
 - o Closed on week-ends year round
 - o Off-leash dogs must not enter the tot lot swing area

- Braceland Playground
 - o Ward 5
 - o Lower tier
 - Ample parking
 - Off-leash area is closed from December 15th March 15th for sledding
 - Dogs must remain on-leash until they enter the off-leash recreation area

- Chairman Magni stated Mr. Stern, who is not present is concerned about the dog bite that took place in Cold Spring Park a few weeks ago and wants to know what is being done about this issue.
 - Commissioner DeRubeis stated the Off-Leash Area Working Group (OLAWG) has developed a procedure. When a resident completes an off-leash area recreation application and checks off yes to the question, "Has your dog been the subject of a complaint or other action as set forth in Section 3-30(a) (11) of the Newton City Ordinances or has ever caused injury to a person or another dog?" The application would be held by the City Clerk and referred to Officer Torres. Officer Torres would evaluate the dog. If the application is denied the applicant would have the opportunity to appeal the decision and appear in front of the Off-Leash Area Working Group.
- Chairman Magni asked if Officer Torres has the ability to cross check the information. Commissioner DeRubeis said yes, Officer Torres is aware of what is going on. Several applications have been forwarded to Officer Torres.

9/11 Memorial


- Commissioner DeRubeis stated a group has come forward proposing a 9/11 memorial on the City Hall grounds.

- The P & R Commission members present came to a consensus to endorse the concept but if the memorial is on park land it should not be a rushed process.



SUBJECT: Farlow Park Pond Executive Summary

This memorandum serves to summarize the progress to date on the Farlow Park Pond Restoration Project. Weston & Sampson was hired by the City of Newton to perform a safety and feasibility study on the restoration of the original pond feature at the park. These findings are outlined below. Based on the data gathered in the course of the last year and extensive precedent studies conducted at similar water features in public parks, near schools and playgrounds intended for young children, we have determined that the restoration of the Farlow Park Pond does not pose undue safety concerns. Further, we have established that through use of the existing well, water can be supplied to both the pond and the irrigation system for the adjacent ball field.

- The Safety Matrix (attached herein) shows that in general there were no safety concerns with open water ponds in public landscapes. Maintenance concerns were mostly related to geese and trash collection on the open water surface. Aeration and some water additives will mitigate mosquito concerns.
- An aeration device will be required to ensure movement of water to discourage stagnation, algae growth and mosquito breeding.
- The existing concrete pond shell was investigated through test pits and borings. Given the results, we have made general assumptions about the condition of the concrete and expect to find minimal to moderate repairs necessary to the existing concrete. An applied liner will be required but will not ensure 100% water tightness, which was deemed acceptable by the City.
- The perception of safety, specifically in regards to the abutting day care center, should be addressed with fencing at the property line, not around the pond. Outreach highlighting the educational benefits of the feature was encouraged.
- The existing well appears to have excellent water quality, although no specific water quality testing was performed, per the direction of the City. Yield was confirmed at 21 gpm with some higher levels given seasonal impacts and draw down times. The resulting report is attached herein.
- The existing irrigation system is one zone supported by the city water supply system. By transferring the source of water to the existing well, the system must be removed and reinstalled to include multiple zones that will make more efficient use of the well yield.



- The final design (currently at 85% completion) will include water supply from the existing well, a variable frequency drive pump that will pull water from the well and direct it to source the pond (to refill from leakage or evaporation) or the irrigation system depending on time of day. A water level sensor will be installed in the pond to communicate to the pump when additional water is needed. An aerator will be located under the bridge to provide adequate water turnover and oxygenation to discourage algae growth that impacts water clarity and quality. These systems will be powered either from the mechanical room of the school or the closest pole on the street adjacent to the park. Finally, the pond will have an overflow / drain inlet that will allow the pond to be drained down seasonally and accommodate stormwater run-off from rain and snow melt. This drain will either make use of existing drain lines or require new lines to be installed in place of the existing.
- It has been acknowledged that this proposed feature cannot negatively impact park operations and maintenance staff who are already overtaxed. In response to this, the Friends of Farlow Park have verbally committed to organizing seasonal clean ups to remove leaf build up and debris that falls into the pond. In addition, they will manage any winter skating programming for the pond.
- Total construction costs have been estimated at \$265,000 which includes the new irrigation system and a 10% construction contingency.



- Hurricane Irene- Commissioner DeRubeis stated the storm was actually listed as a tropical storm. There was significant damage around the City. (report attached) Marc Welch, Superintendent of Forestry and crew did an excellent job responding to emergencies and the storm clean-up. There are large piles of brush at Braceland Playground, Forte Park and Rumford Ave. These piles will be removed this week using a tub grinder.

- Off-leash recreation areas There will be a Public Hearing during the October 17 Commission meeting for the Braceland playground and Spears Park proposals
- Albemarle Community Commons- Commissioner DeRubeis will attend the CPC meeting on Wednesday night regarding the funding for this project.
- Newton Highlands Project-no discussion
- P & R Department Move —The Parks & Recreation Department will be moving to Newton Corner sometime this Fall.

3. Farlow Park - Keith Jones - Public Hearing

- Mr. Jones reviewed the Farlow Pond Restoration Project (summary attached).
- Ms. Carla Miller of the Eliot Church stated concerns of having a pond so close to the day care program at the church. Mr. Jones proposed a fence between the church parking lot and playground including a gate to the tot lot.
- Mr. Bernheimer stated this is a historical restoration, how many years did the pond exist in Farlow Park. Mr. Jones stated 80 years. Mr. Bernheimer asked if there were any drowning incidents in the 80 years. Mr. Jones said no, there are many waterways in Newton. An example is the Auburndale Cove which has a playground directly along the river bank.

- Mark, resident of 32 Church Street stated the project is a great idea and the pond would be a great addition to the neighborhood.
- Richard Belkin, resident of Park St. stated he strongly supports this project and there is strong support throughout the community.

- Sande Young, a 911 Memorial Committee member played a 2 minute public service announcement supporting the memorial for the Commission.
- Ms Young stated the 911 Memorial Committee was formed in May 2011. There was a design competition with a jury of 30 members. The design by Mark Sangiolo is the winning design. The site location chosen is on City Hall grounds next to the War Memorial. The Veterans Office had no objections to the proposed site on City Hall grounds. The Historic Commission recommended using the Commonwealth Ave carriage road as a site location and not the City Hall grounds. The design & proposal were presented to the Board of Alderman on September 7, 2011. The committee has raised \$20K and have 501(C) (3) nonprofit status.
- Mr. Kastner asked how much time was given to each designer when presenting their designs. Ms Young commented each designer had the time they needed, they were not interrupted. There was an opportunity for questions & answers and open discussion.
- Mr. Kastner stated it appears that there was not enough time to reflect on the design and the winner had an unfair advantage because he knew about the competition ahead of time and a member of the committee. A public memorial does not have to be a competition.
- Ms. Young stated the competition was posted in the TAB for 6 weeks.
- Ms. Susan Huffman commented she was present at the design presentation all participants had all the time they needed and she voted for Mr. Sangiolo design because it is beautiful.
- Mr. Bernheimer stated the memorial is a fabulous idea but he is conflicted. His son's best friend was killed in the attacks; his son is also an architect so he understands the process. Mr. Bernheimer was part of a jury of six to choose a public site for a memorial and the process has taken a year and the site was decided before the design. Mr. Bernheimer is uncomfortable voting for the City Hall site. This

- should be done carefully, a permanent structure in a public space. He would not vote for this proposal because it was done too quickly and too private.
- Mr. Tom Mountain stated adequate public notice was given about the competition. The City Hall location is the Olmsted Legacy, it will be here in 100 years, and the carriage road may not.
- Alderman Swiston commented the 911 Memorial Committee is a private organization being as transparent as they can and using private money to give this gift to the City.
- Mr. Kastner commented there is a process to approve private funds.
 There is a P & R memorial guideline which requires a six month review.
 Mr. Kastner stated this design makes a statement devoid of art; the design represents the buildings that were destroyed.
- Virginia Gardner the Committee Chairperson stated everyone has an opinion. The House of Representatives of the Commonwealth of Massachusetts sent a citation in support of the memorial. Fine local businesses, State Representatives, Senators, the Board of Alderman and Mayor support this proposal. The committee has commitments from 10 landscapers to assist with the project and raised \$20K. \$35K is required for the monument. Ms. Gardner read the names of all the Newton residents who were killed in the 911 attacks.

- Mr. Stern stated P & R along with the Historic Commission hold the title to the City Hall land and yes there is political support but we cannot jeopardize its National Historic Register listing.
- Mr. Bernheimer stated there needs to be broader consideration of locations.
- Mrs. Susan Sangiolo stated from a landscape perspective the monument enhances the area.
- Mr. Bernheimer requested the documents that went to the architects.
 Ms. Young will send the documents to the Commission Secretary.
- Ms. Gardner stated the City Hall location represents unity, it is not the south side of the city or the north side if the City it is the "heart".
- Ms. Charkoudian understands why the committee wants the memorial in the City Hall location. Ms. Charkoudian asked what would be written on the tablets. Ms Garner passed around a document (attached) with the wording for the top of the tablets.
- Mr. Tucker commented any process should be beyond reproach, but from tonight's meeting there are indications of concern. The project either goes forward of not, if it fails it will because of process not concept.



Meeting called to order at 7:05pm

Chairman Magni rearranged the agenda to accommodate the Public Hearing.

1. Off-Leash Recreation Area Proposals – Public Hearing

- Commissioner DeRubeis presented the Off-Leash Area Working Group proposal for off-leash recreation areas at Braceland Playground and Spears Park (presentation attached).
- Chairman Magni introduced the Aldermen present and asked them to comment before they had to go into another meeting.
- Alderman Crossley commented she is impressed with how far the city has come with off-leash areas. Currently there is a predominance of off-leash areas in the north side of the City. Alderman Crossley stated she lives in the Newton Highlands and believes the topography of Braceland Playground works well with an off-leash area. The off-leash areas are important to a large number of families and this process allows the areas to be open in a controlled way. Alderman Crossley supports the proposal for the off-leash area and also supports a dedicated entryway and crosswalk at Braceland Playground.
- Alderman Rice commented a few years ago there was a meeting at Emerson Community Center for the original off-leash proposal at Braceland Playground. There were issues that have been addressed since the meeting at Emerson. One issue was the fact that citizens were proposing the off-leash areas and not the City, but now the City is managing the off-leash areas and proposals. A second issue was sledding and off-leash dogs and this proposal addresses' the issue by closing the off-leash area during the winter. Another issue was, not wanting to be the first off-leash area open in the City, currently there are six off-leash areas open throughout the City. Most of the issues have been addressed by the City.
- Alderman Lennon commented he has concerns with the Spears Park proposal. There are parking and traffic issues and there are already a number of off-leash parks in the area and he would like to have other parks open around the City before Spears Park is open.
- Alderman Albright thanked the Commission for their careful concern during this process, it has made a difference. There are several parks in Ward 2 and people will be against the off-leash area in Spears Park

- because they are afraid the park will be overrun with dogs, but that has not happened in any of the open off-leash areas. It will be a win/win situation in Spears Park and if it does not work out the off-leash area will be closed.
- Alderman Yates stated he sees people walking their dogs on leash around the neighborhood and sees no reasons to change Braceland Playground. There are parking issues and the off-leash dogs will be disruptive to the activities in the upper level. Alderman Yates suggested the group think outside the box if they want an area in Upper Falls, look at Hemlock Gorge or the former site of the Pillar House.
- Chairman Magni announced the Commission would take public comments for the Spears Park proposal, there is a two minute limit, all comments are to be directed to the Commission, there will be no heckling and please identify who you are.
- Norman Wirtz, 38 Waban St., commented Spears Park is a wasted and unused space. His small dogs would like an off-leash area and urges the Commission to approve the proposal.
- David Frenette, 84 Walnut Park stated his issues with an off-leash area are, cleanliness, noise, dogs barking disturbing the neighbors, traffic and dog bites.
- Sister Rosemary Brennan, of the Montessori School, Sister Brennan commented the athletic field directly abuts Spears Park. Sister Brennan is not in favor of the off-leash area due to safety concerns. There are 400 students from her school that uses the athletic fields and fencing would not keep the children safe.
- Resident of 475 Washington St commented the off-leash area would disrupt the calmness and serenity of the park. There are traffic concerns and his family's acupuncture business would be disturbed.
- Mr. Best, 74 Walnut Park stated his main issue is parking.
- Shirley McKay, 88 Walnut Park, commented the park is used by small children; the off-leash area would create litter, smells and noise. There are already dogs there, keep it as it is.
- Ms. Alla Mantsur, Jaconnet Rd commented she has been attending the off-leash recreation area meetings for two years and has seen that dogs make the city beautiful. There was concern at Claflin Playground about parking, but people do not drive to Claflin it is a neighborhood park, people walk to the area. The off-leash area users are self-policing. In Old Cold Spring Park if the off-leash area users see an off-leash dog on the trails we will explain to the dog owner why it is important to keep their dog on the leash until they enter the off-leash area. This off-leash area will help to make improvements to this park and keep it from being a snow dump.
- Lisa Sampson, 698 Beacon St has recently moved from Brookline where there are many successful dog parks. Ms. Sampson supports the proposal and a small dog off-leash area. Ms. Sampson has been to several off-leash areas and there are no smells from the dogs.
- Ted Kuklinski, 84 Edge hill Rd and Off-Leash Area Working Group member addressed the closeness of a school to the off-leash area. Mr.

- Kuklinski stated he had just attended a funeral in Philadelphia in a dense area where there is a successful off-leash are next to a school. It is possible to have an off-leash area near a school.
- Elaine Kelly, 84 Walnut Park commented Spears Park is a beautiful park and the only greenery left on Washington St and asked why you can't leave the space for the children.
- Chairman Magni asked the Commission members for their comments.
- Mr. Stern asked Commissioner DeRubeis what the height of the proposed fence will be. Commissioner DeRubeis stated the fence will be 4' the same as the fence at Coletti-Magni Park.
- Ms. Charkoudian commented Spears Park is only a 1/8th mile from the Cabot Park off-leash area; parking and Washington Street are a mess.
- Ms. Heitman agreed it is difficult to park and there are a lot of children at the school.
- Mr. Tucker suggested deferring the proposal to a later date.
- Mr. Bernheimer commented if there are a lot of sites in one area maybe we should wait until the sites are spread throughout the City.
- Mr. Johnson asked if there are other off-leash areas directly across the street from homes. Mr. Bernheimer replied yes, Claflin Playground offleash area.

Mr. Tucker made the motion to table the Spears Park off-leash recreation area proposal for a later time. Ms. Heitman seconded the motion. Motion passed 6-2.

- Chairman Magni announced the Commission would take public comments for the Braceland Playground proposal, there is a two minute limit, all comments are to be directed to the Commission, there will be no heckling and please identify who you are.
- Jonathan Norris, 1175 Chestnut Street stated he is not for or against the off-leash area but if the City is going to spend money they should address the deplorable conditions at the park
- Resident stated he just moved from Boulder Colorado, the people tonight are speaking like dogs are the devil. He has worked with dogs who have been volunteers to assist people. Most dogs are well behaved and do not smell. Dogs bring joy to a lot of people.
- Mr. Joyce, 28 Pennsylvania Ave brings his dog Sweetie to Braceland Playground daily and the majority of the time they are the only ones in the lower level, though he has seen other people with their dogs at the park. People tonight have mentioned cleanliness as a problem when he was at the Braceland with Sweetie the other day he picked up three bottles left behind from the sports activities.
- Doug Clott, 22 Oakland Rd, Newton Girls Softball, commented he is not for or against the off-leash area. Braceland Playground lower level is underutilized, but he does use it for Newton Girls Softball. His hope is to skin the lower level of the field by the backstop to create a softball field.
- Dick Selnick commented his grandchildren play soccer at Braceland Playground and is surprised to hear there is nobody at the park. The

- proposal should be that the park belongs to the dogs for part of the day and the sports activities the remainder of the day.
- Lee McIntyre, 607 Commonwealth Ave and Off-Leash Area Working Group member stated there is lots of available space in the 80 parks throughout the City. Currently over 700 off-leash medallions have been sold and there are no off-leash areas below route 9. A lot of thought went into the proposal for Braceland Playground. The other dog parks are clean and working well. The culture at Cold Spring Park has changed. The users of the off-leash area no longer walk their dog's off-leash on the trails. Mr. McIntyre has been to Braceland Playground with his dogs and has spoken with the neighbors. Mr. McIntyre believes the people would use and enjoy the off-leash area.
- Linda Camp, 1125 Chestnut St agrees with Alderman Yates. Ms. Camp is not for or against the off-leash area but Braceland Playground is for children and dogs are distracting.
- Mr. Bornstein complimented the Commission on their approach to off-leash areas; it has been fair and objective. Mr. Bornstein enjoys the park and supports the proposal. Everything has changed since the meeting at Emerson two years ago. The open off-leash areas have a good track record. The off-leash area will be no more disruptive than any other activity. The proposal can be used to improve the area such as adding a cross walk.
- Resident, the park areas must meet the needs of all residents.
 Braceland is a big area and the proposed off-leash site will not interfere with other activities. More off-leash areas must be added so there is less of a burden on only a few open areas.
- Ms. Alla Mantsur, Jaconnet Rd commented the off-leash area can work. Families bring their dogs with them to watch games and they can use the off-leash area. The proposed area is in the lower tier, the dogs will not see flying balls, if there is a field dogs will run in the field.
- Susan Hoffman, Highland Area Council, commented she is 100% in favor of the off-leash proposal.
- Greg Schwartz, Highlands Area Council stated he looks at the bigger picture to accommodate the desires/needs of all residents and maximize the use of the resources the City has. Mr. Schwartz commented the Commission is doing a good job and supports the offleash area and the work done by the Off-leash Area Working Group.
- Resident of Randlett Park stated she is a dog owner, who has a dog license and has purchased an off-leash medallion. There were people with dog's off-leash in parks before there were legal off-leash recreation areas. This process opens the off-leash areas with controls. Alderman Yates said he sees people walking their dogs on leash in the neighborhood that is because there is nowhere to go off-leash in the neighborhood. There needs to be more off-leash areas spread throughout the City.
- Representative from the pre-school that uses Braceland Playground everyday commented children are afraid of dogs, owners do not clean up after their dogs. An off-leash area should be a fenced area.

- Mrs. Larson-Dill, Ward 5, supports the off-leash area and believes in mixed use.
- Jan Bornstein, Ward 5, stated she would be walking to the park from Pennsylvania Ave but having a park with plenty of parking is important. The park should be shared. Develop areas for kids, sports and dogs.
- Barry & Stephanie Siroka, 1159 Chestnut St commented they have lived in their house for 25 years. There is no way to control dogs in an offleash area. There is a lot more athletic activity than just leagues, there is also cricket and volleyball. The Siroka's agree with Alderman Yates.
- Claudia Morris, 227 Pleasant St uses the Newton Centre Off-leash area. Newton Centre is not fenced, it is shared usage. Because Newton Centre is legal there is motivation to follow the rules. If sports teams set up in the area, the off-leash users go home. It can work.
- Dan Cuphone, 529 Auburn St commented he has been involved with the Braceland proposal since the beginning. Mr. Cuphone is impressed with how the off-leash program is working. Issues have been addressed. Braceland Playground would be a great addition to the program.
- Myra Jackson, Spring St stated she is terrified of dogs, but she is ok with having an off-leash area in Braceland Playground because then she would know where the off-leash dogs would be and she would not go to that area of the park. Ms. Jackson supports the proposal.
- Ms. Richer does not believe the drop off to the lower level will stop dogs from running out of the off-leash area. If it does not work without a fence, a fence can be added.
- Resident, a user of Cabot Park off-leash area stated the off-leash area at Cabot Park is working, a community is developing. Dogs are smart, once they learn they are going to the off-leash area they do not stop in other areas in the park they go directly to the off-leash area.
- Chairman Magni asked the Commission members for their comments.
- Mr. Bernheimer commented this proposal makes sense and it is important to have an off-leash area on the South side of the City, but it should not be open until there is traffic control such as a crosswalk and it should wait to open until March 16. If the area opens now it will close for the winter in a few weeks.
- Ms. Charkoudian agreed with Mr. Bernheimer and asked if a light could also be added to the crosswalk.
- Commissioner DeRubeis stated he could meet with traffic about the crosswalk but a light would take years to have approved.
- Mr. Stern asked how users will be notified if the area is permitted.
- Commissioner DeRubeis replied advanced notice would be posted at the site.
- Mr. Neville commented his personal opinion is that dogs and kids do not mix well and does not approve of this proposal.

Mr. Bernheimer made the motion to accept the Braceland Playground off-leash proposal leaving the timing of opening the off-leash area and other safety concerns to the discretion of the Commissioner with subsequent reporting to the Commission. Mr. Tucker seconded the motion. Motion passed 7-1.

- Ms. Charkoudian stated the 911 Memorial Committee is a private group.
- Mr. Fishman stated most projects are started from private groups, we need a process.



Meeting called to order at 7:05pm

1. Meeting Minutes -October 17, 2011- accepted 8-0

2. Commissioner's Reports on Programs, Forestry and Maintenance

- Gath Pool & Crystal Lake Reports (attached)
 - The numbers were down compared to last year at Gath Pool & Crystal Lake due to weather conditions.

Programs & Services Resolution (attached)

 The Programs & Service Committee received a petition to allow swim at your own risk at Crystal Lake and are requesting the Commission review the policy. Commissioner DeRubeis has spoken with Deborah Fogel who submitted the petition. Ms. Fogel is putting together a proposal to appear before the Commission.

Department Snapshot (attached)

- Mr. Tucker commented on the 18 year back log to prune trees and asked what the back log was last year. Commissioner DeRubeis stated the backlog increases exponentially each year. Tree pruning is contracted and the budget allows for 20 days of pruning each year.
- o Mr. Tucker stated trees are a safety issue.
- Commissioner DeRubeis and Marc Welch, Director of Forestry have met with the Executive Office and presented a proposal to bring crews inhouse.

Budget

 The current Administration has maintained a dynamic budget rather than a static budget. Commissioner DeRubeis will provide a copy of the budget at the next meeting.

Camp Scholarship Report (attached)

 This summer the Parks & Recreation Department is partnering with the Newton Community Service Center to provide NCSC participants a specific number of spots in the P & R Summer Camps.

Newton Corner Move

- The former old Boys & Girls Library (124 Vernon St) is just about ready for the move. Public Buildings is doing a great job.
- Newton Highlands Project

• Gale Associates has almost completed the feasibility study at Newton Highlands Playground.

3. Public Hearing Venues

- Ms. Charkoudian requested a discussion on alternate meeting locations for Public Hearings. The War Memorial is the usual location where Public Hearings are held for the P & R Commission and the acoustics are horrible. If the Commission is going to have a public hearing, it needs to be heard.
- Chairman Magni asked if Ms. Charkoudian could do some research as to what other locations are available. Ms. Charkoudian requested the group discuss the options.
- Linda Plaut suggested the auditorium at the Cultural Center, 225
 Nevada St.
- Carol Stapleton recommended the Aldermanic Chambers on a night besides a Monday night.
- Mr. Bernheimer commented the need to use of the Aldermanic Chambers would depend on the Public Hearing Agenda.
- Chairman Magni asked the members present if they agreed to use the Aldermanic Chambers for Public Hearings. All members present agreed.

4. Poetry in Edmands Park (proposal attached)

- O Mr. Grey Held and Ms. Wendy Drexler presented the proposal. Mr. Held stated the idea is to take poetry out of the books and put it in Edmands Park, which is a natural park setting. The nature-oriented poetry would be visible but not "in your face". There are existing structures that would make great places to install the poetry. The installation would include engraved stainless steel plaques that would last 50 years. There will be a public contest for the poetry selection. Funding will come from the entry fee and a grant from the Newton Cultural Council.
- Chairman Magni requested the proposal be vetted through the P & R
 Department to check the deed of Edmands Park.
- o Commissioner DeRubeis will check with the Law Department
- Ms. Charkoudian stated she has been to Tacoma Park in Maryland which has poetry scattered throughout the City along the public sidewalks, it is beautiful. Ms. Charkoudian asked if the Commission would have final say on the design and the wording of the poetry. The Commission wants to be sure nobody would be offended by the wording.
- Mr. Stern asked what the parameters will be for the contest. Mr. Held replied the poems should relate to nature, dog walking, etc.
- Mr. Clarke suggested Mr. Held forward a history of the park to the contestants to integrate into the poems. Ms. Drexler commented it would be helpful to know the tree and plant species in the park.
- Mr. Tucker asked if they will be selecting new poems or existing poems.
 Mr. Held would encourage the contestants to submit new poems.

- Mr. Kastner stated Forest Lawn Cemetery has a rotating exhibit of public art. Once the art is in place it would be hard to change. Mr. Kastner suggested putting a life term on the project or install the poems on wooden plaques that are meant to deteriorate; the poems would become part of the history of the park.
- Mr. Stern asked if the slabs for mounting would be raised. Mr. Held stated no, they would remain as they are.
- Chairman Magni asked if a public hearing is required. Mr. Bernheimer stated yes. There is a Friends of Edmands Park group that should be contacted first.
- Mr. Bernheimer stated Mr. Held is going about this proposal the correct way. Contacting the Commission for input, having a public hearing and then having a public contest with the Commission having the final approval.
- Ms. Schein requested a sample of the plaque.
- Chairman Magni stated Mr. Held should talk with the "Friends" group and then come back to the Commission with more detailed information:
 - contest parameters
 - locations of where the poems will be installed
 - a maintenance plan
 - a sample of the plaque
- Once the additional information is presented and approved a public hearing will be scheduled.

5. Policy Sub-Committee-update

Historical Perspective City Hall Grounds

- o Chairman Magni requested an update from the sub-committee
- The sub-Committee has reviewed a memorial guidelines draft sent by Ms. Schein the P & R Open Space Coordinator.
- Mr. Stern asked if the group was looking at the historical perspective.
 Mr. Bernheimer stated no they were to create a general memorial policy. Mr. Stern stated the sub-committee was to determine if the 911 memorial and other memorials are appropriate for City Hall grounds.
- o Mr. Clarke stated there is already a policy for City Hall Grounds.
- Ms. Schein stated there is no policy for City Hall grounds. There is an approved Master Plan for Newton City Hall and War Memorial Grounds completed in 2006 by Pressley Associates. In the report Pressley Associates recommends the Commission declare a moratorium on future installations on the City Hall and War Memorial Grounds.
- Commissioner DeRubeis stated currently there is no moratorium.
- Mr. Clarke stated there should be a moratorium until there is a policy in place.
- Mr. Clarke recommended making a motion for a moratorium to be put in place. Chairman Magni stated Mr. Clarke is an alternate member of the Commission and is sitting in for Vice-Chair K. Heitman. This allows Mr. Clarke to make motions and vote at tonight's meeting.
- Chairman Magni stated the Commission will be required to provide a reason for the moratorium. And if a moratorium is voted on and passed

- it would be in good faith for the Commission to expedite creating the policy.
- Mr. Bernheimer commented other government agencies should be involved in creating the policy.
- Mr. Stern commented the Historic Commission (Co-caretaker) said no to the 911 Memorial on City Hall Grounds. The sub-committee needs to acquire more information.
- Mr. Fishman stated one policy may not be a one size fits all policy. It seems that City Hall is sacred ground.
- Mr. Stern stated he is not sure of the legality of memorials if another government agency is involved, for example is the State Highway Department involved with decisions regarding the Commonwealth Ave median strip. The Design Review Committee should be involved. Mr. Bernheimer suggested Mr. Stern work on organizing a meeting with the other City agencies. Mr. Stern agreed to do so.
- Mr. Tucker commented it would be a mistake to allow anything on City Hall Grounds before a policy is created.
- Mr. Clarke stated he was under the impression the 911 Memorial Committee was aware of the Pressley Master Plan. Commissioner DeRubeis stated he and Ms. Schein have made the committee aware of the Master Plan.

Mr. Clarke made the following motion: Newton Parks and Recreation Commission declares a moratorium on future installations of commemorative markers, monuments, or other non-historic additions on the City Hall and War Memorial Grounds, until guidelines specific to this historic landscape can be established. Mr. Bernheimer seconded the motion. Motion passed 8-0.

Mr. Stern made the following motion: The Commission will diligently proceed on the creation of a policy and procedure regarding public art, monuments and the like on real property under the jurisdiction of the P & R Commission. Mr. Rice seconded the motion. Motion passed 7-1.

6. New Business

Natural Resources Inventory and Management Plan for Nahanton Park

- A copy of the final plan was distributed to the Commission members.
 Commissioner DeRubeis stated Ms. Schein is working with the Group to make recommendations to the Commission.
- Mr. Stern commented this report is a result of the proposal submitted by Newton Community Farm to expand farming into Nahanton Park. Commissioner DeRubeis stated yes.
- Mr. Clarke commented that recommendations should be made based on the report. The Community Gardens has a waiting list of people for garden plots. This is an existing use and should be considered.
- O Mr. Clarke stated the report's recommendations for the building used by Public Buildings at the Winchester Street entrance should be reviewed. Most people would like to see the building demolished and the area go back to its natural state. Ms. Schein agreed most people would like to see the building demolished but she will check into the

history of the building as it was recently assessed to be "mediocre" historical significance.

Newton Parks and Recreation Department Scholarship – 2011 Final Report

Money available for the summer of 2011 was \$51,782.00. The number of applicants decreased from 2010 to 2011 by 6 with a total of 62 in 2011. Of the 62, 58 applicants accepted the scholarship at a total of \$33,185.00 and attended camp some going to two or more of our camps. The remaining 4 applicants did not qualify or declined our offering and did not attend. The amount awarded to each participant was based on need and number of weeks attending camp. Every applicant whom applied was awarded approximately 80% in scholarship per week toward their tuition. Below please note the list of camp offerings, scholarships awarded to each with the amount, and the amount of money raised by each camp for the scholarship program.

Proposal

Poetry in Edmands Park, Newton, MA



Summary: The objective of this proposal is to transport nature poetry from the library and the printed page into the living landscape of Newton's Edmands Park. Strolling park-goers who serendipitously come upon 20 nature poems inscribed on stone pilasters and granite slabs in the park will directly encounter the way poetry enhances the beauty of the natural landscape and enriches the park experience. The 20 poems will be etched into 1/8-inch stainless steel plates (each plate approximately 6 x 8 inches) and secured to existing stone structures within the park.

Vision: Edmands Park's beautiful oak forest, interspersed with beeches, locusts, maples, birches, and pines, is enjoyed by Newton's hikers, cross-country skiers, and nature lovers. If the Poetry in the Park proposal is implemented, Edmands Park would become a destination for poetry lovers from Newton and beyond, as well as a model for other communities seeking to bring poetry to a wider audience. It is our belief that park founder John Wiley Edmands would smile on this proposal: in addition to gifting the 33-acre park to the city of Newton, Edmands gave \$15,000 toward the establishment of the first public library in Newton and \$5,000 toward the purchase of books. He also paid for the library's architectural plans and laid the cornerstone. Given these gifts to the city, we believe that Mr. Edmands would support this project to intertwine verse and nature at Edmands Park as outlined in our Poetry in the Park proposal.

Precedent: As part of the Newton 2000 celebration, plaques with poetry by Robert Pinsky, Newton resident and Poet Laureate of the United States, were placed in the grounds around Newton City Hall. There has been no vandalism of these plaques and no further maintenance required. There are also several "Poetry Walks" in the United States, notably in Berkeley, CA.

Fabrication: The selected poems will be etched in 1/8-inch stainless steel by New England Etching for a cost of \$60 to \$80 per poem. The steel plaques will be predrilled with holes so that the plaques can be flush-mounted to the pilasters and slabs. The plaques can either be etched with dark text on a light metal background, or with light text on a darkened background. See below for examples of these two modes, light on dark on the left, and dark on light on the right.

Installation:

The poem plaques will be professionally installed under supervision from the Poems in the Park Committee and with the approval of City of Newton personnel. To install each plaque, four 1/8-inch diameter holes will be drilled to a depth of 1 inch into each stone pilaster or slab. The plaques will be screwed in/mounted.

Longevity and maintenance:

The edged metal technology is well suited for exterior use and has longevity in excess of 50 years.

Placement of the poems: The old stone pilasters in the park, which look like they once formed part of a fencing system, will provide the pre-existing support for the poems (see photos: the white sheets of paper represent the approximate size of the poem plaques). There are also several strewn granite slabs that seem well adapted for securing the plaques.

Committee members will submit a plan/map for where the poems are to be installed, and final approval for placement will be made by the Parks and Recreation Department.



Poetry selection process: We will select approximately 20 poems by conducting a poetry contest open to all Massachusetts residents. The first step will be to place a "call for entrants" in *Poets & Writers* magazine (national circulation), Grub Street News (circulation in the Massachusetts area), Winning Writers email newsletter (national circulation), email listings to the Concord Poetry Center and other local poetry groups, and word of mouth at various Boston-area poetry venues. There will be a nominal entry fee of \$15 for up to 3 poems. Judging will be anonymous. Wendy Drexler (Belmont resident), Grey Held (Newton resident), and Barbara Helfgott-Hyett (Brookline resident) will do the initial screening of poems. Wendy Mnookin (Newton resident) will select 20 poems from the finalists. The Director of Newton Parks and Recreation will give final approval. Please see below for the credentials of the four committee members.

The selected poems will be of the highest caliber. Nature will be the theme or undercurrent of the selected poems. Poems will be no more than 30 lines. In addition to having a "nature theme" poems selected will have some connection to the New England landscape. Here are three examples:

Newton Highlands Playground

- 3. CPA funding for "historic preservation" would be jeopardized the more the original design was altered with art, monuments or other modifications.
- 4. The Historical Commission opposed the proposal location of the 911 monument (i) given its size (ii) since the south side of the City Hall grounds has remained fundamentally consistent with the original Olmstead design (vs. the alteration caused by Millennium/Balsamo Park) and (iii) based on the desire to support the Pressley firms master plan of City Hall's grounds to restore the original, historic design.

CIP Executive Summary

EXECUTIVE SUMMARY – Highlights and Key Findings

Overview

The initial intake of capital needs from the operational departments and the municipal building assessment identified over 1,000 projects considered important to maintain and preserve the physical assets that support city operations, programs, and services. These physical assets include 78 buildings, 58 parks and playgrounds, 298 miles of roadways, over 200 pieces of rolling stock (heavy vehicles), and more than 600 miles of water, sewer, and stormwater infrastructure. The investments identified are intended to properly maintain or replace capital assets in addition to adding new infrastructure. All of these project proposals were evaluated using a risk-based approach.

Where it made sense, repair/replacement of like-items were bundled into larger capital investments, while other items were migrated to the departments' operational budgets (eg. smaller capital valued at less than \$75,000, maintenance items, administrative vehicles, tree trimming maintenance, etc). This resulted in a final CIP project listing of about 380 projects valued at \$240M. The break-down of projects by asset category is illustrated in Tab 2. As the pie chart illustrates, the majority (66%) of capital needs belong to the City's building inventory. A listing of the twenty buildings with the highest capital needs is listed at the end of this section.

The FY2013-2017 Capital Improvement Plan proposes funding nearly \$119M in projects valued at \$75,000 or more, across the spectrum of infrastructure. The break-down of projects by funding categories is illustrated in Tab 3.

Highlights of Process

This Capital Improvement Plan represents a significant shift in the manner by which capital projects are recorded, reviewed, and eventually executed in the City of Newton. Like any planning program, it is fully expected it will continue to evolve, adopting changes that will only improve the process and the manner in which we allocate scarce resources to our infrastructure needs

The goal of this City-wide comprehensive capital plan is to identify and prioritize critical capital needs across the City, and to allocate funding to implement those projects through a process that is logical, transparent, and data-driven. To that end, a mathematical model was developed to create a standard framework for the decision-making process across all departments' capital needs.

One of the first steps was to assess the current condition of the various capital assets both below and above the ground. Consultants (Kleinfelder/SEA Inc.) were commissioned to conduct the technical assessment of municipal buildings and to give the City a current snapshot of both short term critical needs and longer term investments needed to maintain the serviceability of each facility. In a similar fashion, various departmental staff reviewed assets under the stewardship of their respective departments. All assets were rated based on their individual merits and/or deficiencies

The rating process evaluated and compared the different capital needs using the same criteria: the probability of failure and the consequences of failure of a particular asset or proposed project. *Probability of Failure* considers the age and condition of an asset while *Consequence of Failure* considers the impact of not implementing a project or not purchasing a new capital asset. The details of this risk-based approach are described in Section 3 of this document. It is important to point out that this methodology is the driver for management's evaluation of capital improvement needs within the context of competing demands.

The data from the Building Assessment and the departments was then integrated and reviewed by a CIP Steering Committee to apply a common decision-making metric to what ends up being very different capital needs. For example, it is necessary to conduct a relative comparison of the importance of a fire truck to a roof repair based on a unique risk-based approach. Consistency in the metrics at this level in effect 'calibrates' the rating values across all departments.

Through a weighted average computation, the Risk Factor was calculated as the probability of failure multiplied by the weighted summation of the consequence factors to yield:

$$Risk Factor = PF \times O$$

Where:

PF = Probability of Failure

Q = Consequence of Failure

The CIP is then prioritized according to the magnitude of the Risk Factor for each capital need. Finally, the City's annual funding capacity determines the degree to which capital projects in the CIP are funded according to the priority. This model provides a transparent decision-making framework that can support the capital improvement planning process into the future.

The initial master list of prioritized projects included several top priority projects that were identified for FY12 capital funding. Those FY12 projects have been submitted to the Honorable Board of Aldermen for appropriation and are listed in Appendix I of this document.

 - site plan noting location of portable signs
 - neighborhood parking plan
 - A valid Certificate of Insurance for your organization which names the City
 of Newton as "Additional Insured" in amount of \$1,000,000 or greater
 covering general liability including bodily injury, property damage and
 personal injury.
 - A Special Event Permit Application*
 - A Volunteer Application for Improvement and Maintenance of City Property.*

Upon receiving the above information, your Organization will be contacted by the Commissioner or designee to arrange a meeting regarding your proposal.

An approved applicant will be required to sign a license agreement with the City of Newton.
