### 2. Commissioner's Reports on Programs, Forestry and Maintenance

- Snow removal has been the focus
- Camp Fair registration- This was the first season with automatic credit card processing. There was a technical glitch with the new system on the first night of registration. The staff immediately communicated the issue with the participants. The glitch was fixed by the following day and participants were able to register for the camps.

### 3. Cabot School Renovation project- Alex Valcarce, Public Buildings - informational

- Mr. Valcarce stated Cabot school is next in line for renovation. The project is similar to the Angier School renovation project, where organized parking is in the plan, additional space is required and tonight the group is looking for input from the Commission.
- Leno Fillipi and Donna DiNisco of DiNisco Design Partnership presented three options for a revised parking plan at Cabot School. Each plan requires a portion of Cabot Park. Currently there are 27 parking spaces the new plan includes 70 parking spaces.
- Mr. Kastner asked if there is a footprint of the new school. Mr. Valcarce said no, they are waiting for the Commission's input on the parking.
- Mr. Stern asked what is driving the need for additional parking. Mr. Valcarce stated the basic need for parking, right now the teachers are parking all around the neighborhood. Mr. Stern suggested taking the two houses on the corner next to the school. Mr. Valcarce commented the City would like to work within city land.
- Alderman Fuller commented there are issues at the park such as parking and financing upgrades. This project could provide useful upgrades for the school and for the park; it would be a win-win for everyone.
- Mr. Dunker commented during league games there is a parking issue.
- Commissioner DeRubeis stated there has been serious discussion to keep the little league field where it is. There is an opportunity to look at the irrigation and add to the baseball field and major league field.
- Mr. Kastner asked Commissioner DeRubeis if Cabot Park is in the capital plan. Commissioner DeRubeis replied no Cabot Park is not in the capital Plan.
- Mr. Stern asked if the plan includes cutting down trees. Mr. Valcarce commented he would work closely with Marc Welch, Director of Urban Forestry.
- Mr. Stern asked Ms. Schein if Cabot Park has a master plan, Ms. Schein responded no, Cabot Park needs a master plan.
- Ms. Schein asked where the school playground would be located.
- Chairman Magni asked which option works best for the committee, Alderman Fuller responded the committee is still sorting out which would be best, renovation or a new school, the committee has to make the best plan for the next 100 years.

February 2015 Page 1 of 3 Meeting Minutes

- Mr. Stern stated the Commission also must think of the next 100 years. There is a constant parade of well-meaning folk asking for park land.
- Mr. Clarke asked the committee to come back with a cost benefit analysis that does not involve park land.
- Mr. Tucker suggested the committee look into acquiring more property.

### 4. Kennard Park Art Show – Carolyn Kraft, Alison Newsome – informational

- Ms. Kraft, friends of Kennard Park presented an idea to create the opportunity for people to come to Kennard Park for an outdoor art show. Ms. Newsome is an artist and has participated in a similar type of art show in Portsmouth, NH. A webpage would be developed for people to follow the progress of the artists. There would be a grand opening celebration.
- Mr. Clarke asked where in Kennard Park this art show would be held. Ms. Kraft stated anywhere; the group is also working with the Conservation Commission.
- Mr. Stern asked if there would be a cost to the P & R Department. Ms. Kraft stated they would work with the P & R Department staff.
- Ms. Newsome stated there would be 7 or 8 artists, sometimes less is more. The exhibit would be a place of renewal.
- Mr. Tucker asked if this could be an annual event. Ms. Kraft responded yes.
- Mr. Kastner suggested a write up about the history of the building and land is included
  at the exhibit. Ms. Kraft stated that is a great idea and the Friends of Kennard Park will
  support the City to bring back the building and land.

Mr. Stern made the motion to approve the concept of this proposal. Mr. Fishman seconded the motion.

Motion passed 8-0.

### 5. **Bike Newton-Informational**-Helen Rittenberg, Lois Levin, Caroline Genco, Nathan Phillips, Alicia Bowman

- Bike Newton is proposing a traffic garden be installed into one of the City's parks, possibly Newton Centre, between the tennis courts and Centre St. A traffic garden is used to educate children and adults on bike, pedestrian and auto safety. Mr. Phillips commented he has been to a traffic garden in the Netherlands; it is not only educational but a fun activity for families. (Mr. Phillips provided a video link to the Commission of the Netherlands Traffic garden, <a href="https://vimeo.com/31545084">https://vimeo.com/31545084</a>). There is a traffic garden in Connecticut.
- Ms. Rittenberg stated the location of the traffic garden should be in a central, accessible location. The traffic garden would be around 3,600 square feet. The full time Newton Police Safety Officer and Bike Newton would be on site to provide the educational piece of the program. Bike Newton will be looking for contributions from the community. The plan is to design the traffic garden in 2015 and have it built in 2016. The P & R Department will take care of the area maintenance.
- Commissioner DeRubeis stated that at this stage the Newton Centre location is not set in stone. No matter where the traffic Island is installed it would have to blend in with the site and include plantings and possibly a storage area. When Bike Newton makes their next presentation a detailed plan/schematics to show what the area will look like would be required.
- Mr. Tucker asked if the traffic garden would be for all ages and who would supervise the activity. The traffic garden will be for all ages and there are many volunteers through Bike Newton that will supervise the activities.
- Carolyn Genco stated she lost her daughter in a bicycle accident and believes the traffic garden would be a wonderful way to educate children and adults about bike, pedestrian and auto safety. Ms. Genco is also part of a 501c(3) that is willing to donate to the traffic garden.
- Mr. Palmer asked what the cost of the traffic garden will be. Ms. Levin stated the project is in the preliminary stage
- Ms. Bowman stated the next step would be to contact the Connecticut traffic garden organizers for their input.

- Mr. Kastner stated it is sad that the immediate thought is to further intrude on limited park land, other options should be considered.
- Ms. Levin stated she is an advocate for open space.
- Mr. Stern stated Newton Centre Playground is an Olmstead Brothers designed park. Would a traffic garden compromise the historic standing of the park. The more you venture from the original plan the less historic the site.



1. Meeting Minutes – February 23, 2015 – accepted 8-0

### 2. Commissioner's Reports on Programs, Forestry and Maintenance

- Currently the department is working with contractors to clear the turf fields to prepare
  for the season. The MIAA has already pushed back their season, the leagues are in
  discussion about how to handle the season, waiting for the snow to melt and the fields
  to be ready.
- Other issues will need to be addressed when the snow melts, such as damaged fences.
- NNHS netting- Commissioner DeRubeis met with Alderman Norton, Alderman Crossley, Athletic Director Tom Giusti to discuss the plan to put netting up on 60 foot poles, behind the backstop, on the corner of Hull St and Lowell Ave. The cost would be around \$325,000.00. The project is tentatively scheduled for 2016.
- Waban Hill Reservoir- the full Board of Alderman will vote tonight on the purchase of the Waban Hill Reservoir. A two thirds vote is needed to purchase the area.
- The RFP was put out to bid for the Farlow Park pond/bridge project. There were no bidders.
- The Departments budget presentation is scheduled for Thursday April 23<sup>rd</sup>.
- The Newton Tab printed an article on the Nahanton Park Alms House History and there was also a public tour of the building. The Friends of Nahanton Park have voted 4-1 to demolish the building. Alderman Sangiolo is submitting paperwork to nominate the building as an historic landmark. Mr. Kastner stated the committee has not decided what should be done with the building. The committee needs a deadline to submit a proposal to the Commission. Mr. Clarke stated and RFP should be sent out for ideas of what to do with the building. Chairman Magni held the conversation until the **New Business** agenda item.

### 3. Nonantum Village Day – Informational – Lois Dominique

- Ms. Dominique stated this is the 4<sup>th</sup> year of the Nonantum Village Day. The event will be the same as last year and will take place on Watertown Street between Adams Street and Chapel Street and there will be activities in the Magni-Coletti Park (see attached) the event will take place rain or shine.
- Mr. Stern asked if there were any issues with the bounce house safety or wind. Ms. Dominique replied the children are watched carefully, and the bounce house is secured.

Mr. Tucker made the motion to move the proposal to a public hearing. Mr. Fishman seconded the motion.

Motion passed 8-0.

- 4. St. Mary of Carmen Festival Informational Chuck Proia
  - Mr. Proia stated this is the 80<sup>th</sup> Anniversary of the festival. The dates are July 15<sup>th</sup> July 19<sup>th</sup> (see attached). Fiesta Shows will be managing the festival this year. This is a family friendly event.
  - Chairman Magni asked if there were any issues last year. Mr. Dunker thought there were issues with the breakdown times last year. Commissioner DeRubeis stated the company was within the permit rules, and commented that Mr. Proia and Fiesta Shows do a great job every year managing the festival.
  - Mr. Dunker asked where the money goes that is raised during the festival. Mr. Proia stated approximately twenty thousand goes to Police details, thirteen thousand is spent on entertainment, any remaining money is donated to the church, the Boys & Girls Club and other organizations in the community.

Mr. Johnson made the motion to move the proposal to a public hearing. Mr. Kastner seconded the motion.

Motion passed 8-0.

### 5. **Auburndale Cove** – Alcohol

- Commissioner DeRubeis explained the current parameters of the Auburndale Cove alcohol policy are difficult to enforce.
- Questions/Comments:
  - If alcohol is banned will this prohibit alcohol during the St. Mary of Carmen Festival?
  - The difference between cove permits and the festival permit:
    - The festival attends a two meeting process with the P & R Commission, including a public hearing, the cove permit holders do not.
    - The festival has a constant police detail, the cove permits rarely have police details assigned to the picnics.
    - The festival restricts alcohol consumption to a roped off area. At the cove people are not restricted to a specific area, it is impossible for police to enforce.
  - o The concerns are:
    - Unsupervised consumption of alcohol around children and the river in a secluded location
    - P & R staff managing the cove and trying to enforce the policy have a difficult time with permit holders. The weekends are booked 9am-8pm during the season, with a minimum of 300+ people occupying the sites all day long (this number does not include people using the park who do not have a permit).
  - Commissioner DeRubeis will ask a member of the Law Department for input on this issue.
  - This item will be tabled until there is more clarity on how the ban of alcohol at the cove will affect the St. Mary of Carmen festival.

### 6. New Business

- Nahanton Park Tool Shed
  - o The Newton Tab printed an article on the Nahanton Park Alms House History and there was also a public tour of the building. The Friends of Nahanton Park have voted 4-1 to demolish the building. Alderman Sangiolo is submitting paperwork to nominate the building as an historic landmark. Mr. Kastner stated the committee has not decided what should be done with the building. The committee needs a deadline to submit a proposal to the Commission. Mr. Clarke stated and RFP should be sent out for ideas of what to do with the building. Chairman Magni held the conversation until the New Business agenda item.


- Continuing the discussion, Mr. Kastner restated a timeline for a proposal and a chairman should be assigned to the working group. And before landmark status is assigned to the tool shed there are other sites that should be reviewed such as the Newton Centre Hut and the building in Kennard Park.
- Mr. Clarke Public Buildings has used the tool shed since 1964, the structure is solid and a use should be found for the building. Keep the building to remember the history.

Mr. Fishman made a motion to nominate Vice-Chairman Tucker as the chairman of the Nahanton Park Tool Shed Working Group and requested a proposal be submitted to the Commission by the October 2015 P & R Commission meeting (October 19, 2015). Mr. Johnson seconded the motion. The motion passed 7-0.

• Chairman Magni introduced and welcomed Mr. Sam Figler, the newly appointed alternate member of the P & R Commission.

### 1. Meeting Minutes - March 16, 2015

### 2. Commissioner's Reports on Programs, Forestry and Maintenance (report was given after item #8)

- The Marathon was uneventful, the concern was protestors but it was a good day
- Newton Serves Parks & Recreation supported 45-50 projects with tools, bags and deliveries of mulch
- Crescent Street re-use is back on the table
- Crystal Lake Working Group is drafting a management RFP

### 3. Nonantum Village Day - Public Hearing

 Ms. Dominique appeared at the March 18 P&R Commission for an informational meeting. This is the 4th year of the Nonantum Village Day. The event will be the same as last year and will take place on Watertown Street between Adams Street and Chapel Street. There will be activities in the Magni-Coletti Park (see attached) the event will take place rain or shine. Abutters were notified of the public hearing to share comments, issues or concerns. There were no abutters present.

Mr. Tucker made the motion to approve the proposal as presented. Mr. Kastner seconded the motion.

Motion passed 8-0.

### 4. St. Mary of Carmen - Public Hearing

- Mr. Proia appeared at the March 18 P&R Commission for an informational meeting. This
  is the 80th Anniversary of the festival. The dates are July 15th July 19th (see
  attached). Fiesta Shows will be managing the festival this year. This is a family friendly
  event. Abutters were notified of the public hearing to share comments, issues or
  concerns. There were no abutters present.
- Chairman Magni recused himself from the vote. Chairman Magni is a member of the St. Mary of Carmen Society.

Mr. Tucker made the motion to approve the proposal as presented. Mr. Stern seconded the motion.

Motion passed 8-0.

### 5. Bike Newton – Traffic Garden – Informational - Helen Rittenberg, Lois Levin, Alicia Bowman

- Bike Newton is proposing a traffic garden be installed into one of the City's parks,
  possibly Newton Centre, between the tennis courts and Centre St. A traffic garden is
  used to educate children and adults on bike, pedestrian and auto safety. The group
  presented the attached proposal. And are asking the Commission to recommend a
  location and approval to proceed with proposal.
- The Commission members concerns:

- o There is limited open space in Newton, many groups' present proposals for use of open space. The Commission asked the group if they have looked at utilizing school property. The group would like a central location for all residents to access. Using school property raises concerns for the schools, having people they do not know on their property. Bike Newton members stated Newton Centre appears to be an ideal location, there is the space required near the tennis courts and the park is centrally located. Ms. Schein commented the proposal would be required to go before the Conservation Commission due to the water running through the park.
- Ms. Charkoudian requested info on the plastic composition of the grates proposed to be used for the track.
- The Commission requested Bike Newton research other available non Parks & Recreation property as an option for the traffic garden.

### 6. Pellegrini Park - Shade Structure - Informational

- Lydia Scott of the Planning Department presented the plan for the shade structure at Pellegrini Park. The Shade structure is part of the Master Plan for the area the concrete slab is in place and will be installed through CDBG funding. (See attached)
- Commissioner DeRubeis commented that, the shade structure is an appropriate use for the area.
- Mr. Johnson asked if the structure will be installed after the St. Mary of Carmen Festival.
   Ms. Scott relied yes.
- Chairman Magni asked if a public hearing is required.

Mr. Tucker made the motion to suspend the requirement of a public hearing.
Mr. Johnson seconded the motion. Motion passed 8-0.

Mr. Stern made the motion in favor of installation of the shade structure at Pellegrini Park.

Mr. Johnson seconded the motion. Motion passed 8-0

### 7. Tennis Fees – Mike Lewitt

- Clay Court Fees -Rules & Regulations no changes for the season.
- Mr. Johnson asked the breakdown of residents and non-residents. Mr. Lewitt replied 94 residents and 9 non-residents. Mr. Stern asked what the goal is for membership. Mr. Lewitt stated 150 members is the goal.
- Commissioner DeRubeis stated of the 94 members 15 are women. To increase women membership a bathroom facility would be required. The Hut is being used for a summer camp and after school program so, it is unavailable for the tennis court members.
- Mr. Kastner asked the cost to maintain the clay courts. Mr. Lewitt replied \$400.00.

Mr. Tucker made the motion to accept the 2015 Newton Tennis clay court rules, regulations and fees.

Mr. Kastner seconded the motion. Motion passed 8-0.

### 8. Nahanton Park – Tool Shed- Update

- Nahanton Park Tool Shed Working Group Chairman Tucker provided and update from the group.
  - The temporary fire station will be leaving the park this summer/early fall.
  - The Memo of Understanding (MOU) between the Commission and City needs to be reviewed and enforced.
  - o It is important that the ruins be well documented and preserved.
  - o The working group majority are ok with taking the building down.
  - It is highly unlikely CPC funds will be available, this building is not a top priority of the city. To restore the tools shed is cost prohibitive.
  - The Newton Historic Commission has tabled the request for the building to be landmarked the Mass Historical Commission requires additional information. Mr.


- Tucker contacted Mass Historical Commission and they informed him the building would not be landmarked the land/park would be landmarked. Mr. Clarke put a lot into the research and history of the Alms House, worthy of resect and gratitude.
- Seeking landmark status seems counter-productive. Ms. Schein and Ms. Schroeder have suggested memorializing the area with a nice path through the actual ruins of the Alms House. Ms. Schein stated interpretive signs could be installed. Mr. Figler asked a cost estimate. Ms. Schroeder suggested a BCA intern make a plan.
- o Mr. Clarke made a presentation showing a few of the 50 cubic feet of documents regarding the almshouse, many of which have been recently found in the City Archives, including: indenture contracts from 1730-1789, petitions of the Overseers of the Poor over the same period, almshouse registers and ledgers from about 1820 to 1912, and minutes of the Overseers of the Poor and their successors from about 1865 to 1968. The Newton City Archivist, Nancy Kougeas, believes these to be among the most complete set of such documents in Massachusetts.
  - Mr. Clarke also observed that:
  - Nahanton Park is Newton's only true heritage park. Unlike parks such as Farlow, Edmands and Burr, which were donated by wealthy families, Nahanton Park derives from Newton's rich social and cultural history.
  - The remaining structure is still standing because it was made to last of brick, stone and heavy beams, and has been in constant use since its construction in 1938.
  - Nahanton Park has nothing to do with Nahanton (Nehoiden) who occurs in history mainly as a land dealer, so the name does not reflect its history.
  - Nahanton Park exists because half of its land was the almshouse and poor farm, constructed in 1900, and the other half the Diocesan Working Boys Home, constructed in 1896. Consequently, it is Newton's Almshouse Park.
  - The remaining stone and brick structure along with the entire almshouse landscape should be preserved because of the history it represents in how Newton and the nation sought to provide for the less fortunate. The request pending before the Newton and Massachusetts Historical Commissions is to preserve the almshouse landscape in order to acknowledge and reflect the role of almshouses in the social structure of Newton through 18th, 19th and 20th centuries..
- Chairman Magni asked what the plan is for funds so the building doesn't just sit where it is as is, even if the building receives landmark designation there is no money available.
- Alderman Sangiolo stated she has forwarded the information to the Aldermen, and a couple
  of Aldermen are supporting the request for landmark status. Alderman Sangiolo requested
  the Commission let the landmark status application play out. The documents have been
  submitted; if the park is landmarked the money will come.



- The Beautification Department will now be under the Parks & Recreation Department starting July 1, 2015.

- Chairman Magni reminded all in attendance this is an informational meeting, public comment will be held until there is a public hearing.
- Mr. Filippi presented the attached design for the Cabot School renovation project. There have been several designs throughout the process. With the

- current plan the group is keeping the original building built in 1929. The goals are to provide additional parking and connectivity with the park.
- Mr. Tucker asked how much of the park is being taken for additional parking. Mr. Filippi replied a half acre.
- Mr. Kastner asked if any other alternatives have been looked at. Mr. Fillipi replied this design has the least impact overall.
- Mr. Neville asked if the bus entrance is on park land. Mr. Fillipi replied yes.
   Mr. Johnson stated with the turnaround (1/4 acre) and additional parking (1/2 acre) the total park land taken is ¾ of an acre.
- Mr. Tucker asked if eminent domain is still an option. Alderman Albright responded this is a different situation than the Zervas project, the status of the houses near Zervas was one house was in foreclosure and the other house was for sale.
- Alderman Albright stated she is thrilled to be part of the Cabot School renovation project and creating a better connection between the school and the park. Parking is a concern and there are other parking alternatives.
   Alderman Albright has spoken with the owner of Cabot Village and he is willing to participate in a parking study. Alderman Albright asks the city to work harder to find other options.
- Alderman Fuller commented the group has looked at a lot of options. A





    - Mr. Palmer: question design of little league field. Mr. Bolinger replied the little league field is 210' all around.
    - Mr. Tucker: In favor of the plan, asked if there was any concern about safety of kids in the wooded area. Mr. Bolinger replied safety is an item to be discussed, to his knowledge, over the past few years there have been no reported incidents. Inviting people to use the park creates more security. Mr. Kastner suggested requesting Police reports for the area or any other area with a proposal.
    - Abutter: this was a wonderful presentation. The wooded area is an untouched areas heavily wooded with bugs, etc. Not many people will use the paths.
    - Abutter: There is a lot of poison ivy on Dedham Street. Agrees the formalized paths are not a good idea, keep the wooded area in its natural state.
    - Mr. Kastner: What is a seat wall? Mr. Bollinger replied the seat wall is a stonewall, for sitting. Mr. Kastner suggested adding a back to the

- wall, the backing may be a good option for seniors. Mr. Bolinger replied there will also be benches though-out the park.
- Alderman Crossley: Had the pleasure of previously working with Weston & Sampson and is enthusiastic about this plan. Alderman Crossley is concerned about the capacity in the culvert the plan needs to tie back into the culvert. Has there been discussion of collecting water for watering the grass. Mr. Bolinger stated the idea has been discussed. Alderman Crossley stated the City does not have a phosphorus removal plan to improve water quality, but a plan is coming using water without phosphorus is a great idea.
- Abutter: Is the Upland Ave extension being graded to change the width? Mr. Bolinger stated the money for the master plan is for the park land proper but they are coordinating with the Engineering and Public Works departments to upgrade the street.
- Abutter: 56 Washington Street ramp to Sunoco gas station is higher than the field
- Abutter: what is the timeframe on the upgrade? Mr. Bolinger stated it is dependent on funding. Commissioner DeRubeis stated three years is being optimistic
- Abutter: is there a plan to restore the water fountains. Commissioner DeRubeis stated it depends on the location of the water lines.
- Mr. Neville: asked the purpose of the perimeter pathway and the width of the pathway. Mr. Bolinger stated the pathway will be 5' to 6' wide, connect the facilities and meet ADA regulations. - Mr. Tucker asked if parking is first come first serve or assigned spots. Mr.
   Valcarce replied the spots are usually not assigned. During school hours
   the spots would be used by school staff, during non-school hours the
   parking would be shared usage. Mr. Tucker asked if neighbors lose the
   option to park in the spots during school hours. Mr. Valcarce answered
   ves.
- Chairman Magni asked how they came up with 90 spots required. Mr.
   Valcarce replied an analysis was done at the school on the usage by full time, part time and specialist staff.
- Mr. Stern asked what the percentage of the parks land is taken for the no lot option. Mr. Filippi stated .39 acres.
- Mr. Stern asked besides the use of Cabot Village what other alternatives were explored and rejected. Mr. Valcarce stated nothing has been rejected; the parking will be in the neighborhood. A parking study will be done in the next few weeks.
- Chairman Magni asked Commissioner DeRubeis if sports teams could use other fields instead of moving the softball field. Commissioner DeRubeis stated losing the softball field is not an option, if the field is not relocated then the soccer field will have a partial dirt surface.

- Chairman Magni asked the members to take a vote to move the proposal to a public hearing and which proposal will be presented at the public hearing.
- Mr. Valcarce stated the group is looking for approval of either the 28 car lot or no lot option. The 45 car lot has been removed as an option.
- Mr. Tucker stated he lives near Boston College (BC) and there is perpetual parking in the neighborhood by BC staff, is this the same issue at Cabot School?
- Alderman Fuller commented there would be a plan for parking at Cabot School similar to NNHS including the school/community input.
- Mr. Tucker made the motion to move the proposal to public hearing, Mr.
   Dunker seconded the motion
- Mr. Stern asked if all three options were going to public hearing. Mr.
   Valcarce stated only the 28 car lot and no lot options will be presented at a public hearing.
- Mr. Stern suggested amending the motion and split the vote into two votes, one vote for the 28 car lot and one vote for the no lot.
- Mr. Kastner stated even with the no lot option park space is being taken for perimeter parking, the play area and turnaround. Is it safe for kids to be playing near a turn around?
- Mr. Johnson stated it is shortsighted not to have both options for public comment. Will there be additional information on alternative parking ideas by the public hearing? Mr. Valcarce stated they will continue to work on the alternative ideas.
- Ms. Charkoudian asked why there is no 4<sup>th</sup> option, one without a turn around. Mr. Valcarce stated the turnaround is needed for parking and drop off.
- Ms. Charkoudian stated there is no mention of mitigation if parkland is utilized. Mr. Valcarce stated there is a list of various ideas and the list is still out there.
- Mr. Stern asked the members if there is a reason for a two part vote. Is there any chance, as stewards, that the 28 car lot option would pass a vote?
- Mr. Tucker commented there is shared park land at Angier School and most likely down the road for Zervas School. There is concern, are we doing the best job we can, but we cannot vote down a school project.
- Ms. Charkoudian stated it is the Commissions responsibility to protect park land.

### 2. Cabot School Renovation Project - Public Hearing

- Chairman Magni notified all in attendance the meeting was being recorded. Speakers will have three minutes to speak on the proposal.
- Alex Valcarce, Public Buildings Department commented that tonight's presentation is the fourth update to the Parks & Recreation Commission of the Cabot School Renovation Project. The Project Team is looking for the best solution while following the Mass School Building Authority requirements. The current plan seeks to strengthen the connection between the school and the park as well as improving student and pedestrian safety. The new Cabot School will need 90 parking spaces for its staff. There has been discussion of working with Cabot Park Village to use spaces in its lot. Mr. Valcarce introduced Leno Filippi of DiNesco Design Partnership.
- Mr. Filippi reviewed the current plans for a renovation and addition to the Cabot School and described how the design and site plan evolved. The part of the school built in the 1950's will be demolished. The building from 1929 will be kept. Currently the school has 27 thousand square feet and it needs 85 thousand square feet. Mr. Filippi reviewed the two site plan options being presented for consideration by the Parks & Recreation Commission, one showing 28 head-in parking spaces along Parkview Ave. and a 28 space parking lot, for a total of 56 parking spaces (the "56 parking space plan"). The second option eliminated the parking lot, but retained the 28 head-in parking spaces along Parkview Ave. (the "28 parking space plan"). With the exception of the parking lot, the two plans show the same relationship of the school to the park.
- Mr. Tucker thanked all for coming to the meeting. There are two sides to
  the parking issue, those who wish to preserve the park and open space
  and those who do not. The Parks & Recreation Commission mission is to
  preserve the park, it may sound mean spirited but it is not, the
  Commission is doing their job. There are other choices, such as the Cabot
  Park Village. The Commission does not want to give up open space and

never have it returned. The necessity of 90 parking spaces is for a majority of the staff that is not full time. Safety was a major concern in the e-mails/letters the Commission received. Restricting access to Parkview Ave. is designed to help with the safety issue but the rotary near the playground will create safety issues. Mr. Tucker suggested allowing people to park on the park side of East Side Parkway, not on the residential side, this would allow for more parking. The designers should have presented a plan with additional options besides the use of park land.

- Mr. Valcarce stated a parking study has been completed and a report will be provided. It is difficult to build a new school with no new parking close by and 90 spaces is the minimum needed. These plans propose shared use of parking and hardscape. The park has no parking and the school hardscape can be used for recreation. Included in the plan are additional improvements to be made to the park.
- Chairman Magni opened up the discussion to public comment:
- Wayne H, Westminster Ma speaking for his in-laws, Mr. & Mrs. Vestal that reside at 235 Cabot St. The Vestals have been residents for 49 years and are not in favor of the proposed changes. The changes create a negative impact on:
  - Quality of life
  - Property value

The Vestals are requesting when the decision is made take into account the real impact to the area and residents.

- Erin E, Gay Street is a member of the Cabot PTO. Cabot School is special and she loves Cabot Park and sees this proposal as an enhancement and likes the pathways across the park, the current situation is dangerous. She does not want to protect the park at the safety of the children.
- Jen A, Whitney Road echo's Erin's comments. This is a once in a century opportunity to enhance the school and the park.
- Karla H, Austin Street a former staff person at Cabot. Parkview needs to be closed. During a fire drill when bringing the children back to the school from the park at the end of the drill, cars sped down the street and she had to step in front of a car, and was almost hit, to stop it before it ran into the children.
- John M, Simpson Terrace a member of the Newtonville Historic District Commission, this proposal creates a direct connection between the school and park but is against the proposal for the following reasons:
  - o Replaces green space with asphalt
  - 65 spaces are required additional parking can be on the existing streets next to city land
  - o Cabot Park Village option is not shown on this proposal
  - Relocating field and utilities
  - The turnaround creates a hazard
- Natalie A, Landscape Architect, Cabot St, there are three problems/solutions;
  - o Parking-this is a city not a suburb, parking is difficult

- The drop off & pick up area in proposal does not meet standards, the blue zone should be 720'
- o Closing Parkview Ave., design a pedestrian priority zone.
- Lee G, Cabot After-School, finding parking to carry heavy supplies into the building for the after school program is difficult. The staff has previously tried using Cabot Park Village to park, but when it snows the cars need to be moved immediately upon request and sometimes that is not possible if it means leaving the children unattended. Parking needs to be a safe distance to the school for the staff.
- Tom M, Parkview Ave., the Parks & Recreation Commission should have been brought into the project earlier. The Commission is being taken for granted now and will be taken for granted again.
- Andrea S, Kimball Terrace, Cabot Parent supports the 28 car lot, this allows safety for the students and park users.
- Marion B, Bridges Ave, school supporter but is against taking the park land and closing Parkview Ave.
- Daphne P, Parkview Ave., understands the proposal is to accommodate staff but the character of the neighborhood will be disrupted with the changes. Relocating the softball field will send balls into the tot lot and the swing area.
- Bob C, Eastside Parkway, loves living at the park even though his vehicles have been hit by softballs. There is plenty of parking in the neighborhood, open space is a valuable commodity and we are not making anymore.
- Alicia B, Chestnut Terrace, member of Safe Routes for Schools and is on the Mayor's Transportation Advisory Group. John M made a clear case. The circle shown on the plan creates a hazard. Use the money allocated for the parking area to enhance the walking paths around the school.
- Melissa N, Cabot teacher, and a mom, first concern is safety for the kids and the teachers need parking closer to the school.
- Lindsay O, Cabot teacher, it is very difficult to find parking especially on trash day and during snow storms.
- Beverly L, Melrose Street, Cabot employee, concern is for the safety of the children.
- Tom E, Gay Street, this is an exciting opportunity to make the right decision, it is about compromise.
- Zac H, Cabot After-School staff person, agrees with Tom E.
- Joe G, Cabot teacher, Parkview needs to be closed it is a dangerous area for the children.
- Linda C, Cabot teacher, the school is long overdue for an upgrade and this
  plan creates a direct connection with the park which creates safety for the
  children.
- Angela P, Joseph Road, Cabot parent, this proposal is a tradeoff/compromise, safety vs. greenspace.
- Alice C, Otis Street, Cabot parent/After-School, the condition of the school is deplorable and needs an upgrade.

- Susan B, abutter- Lewis Street, Cabot parent and an Environmental professional. This plan is the best solution for the school and park.
- Olivia B, Ripley Street, teacher, resident, and mom supports 28 car lot plan.
- Jenn L, C teacher, close Parkview Ave, creates accessible space and is best for the children.
- Nicole C, Nahant Road, Teacher, supports the proposal.
- Karen W, Holland Street, agrees with all, there needs to be a compromise.
- Beth W, Salisbury Road, Loves schools, President of the Newton Conservators, in favor of preserving open space. Wants what is best for the school but not at the expense of parks.
- David B, Page Road, a member of the Newton Conservators, wants what is in the best interest of all residents, disappointed to see part of Cabot Park will be paved, once the green space is gone it will most likely not be given back, this sets a precedent.
- Ellen S, Blake Street, no managed parking plan please. Traffic rule breakers will continue to break the rules.
- Shoshana A, Morton Street, teacher, special education support services, supports proposal.
- Joanna J, Blake Street, Supports proposal.
- Wendy L, Lewis Street, Cabot parent supports closing Parkview Avenue.
- Dan K, Bemis Street, agrees with Mr. Tucker. Leave the park alone, create parking at Edmands Park.
- Mary Lou D, Principal at Cabot School, supports proposal. There are 78 staff, volunteers, and support service that visit the school on a daily basis at overlapping time periods. This proposal provides safety and access to the park.
- Don K, Oakwood Road, supports proposal
- Jen H, supports proposal
- Diana G, Islington Road, has been on school committee and is a park user; this is a win-win proposal.
- Robert G, Claremont, The P & R Commission guidelines state it is their policy to protect the parks, until all other reasonable options have been discussed. The Commission needs to respect their guidelines and preserve the park.
- Alderman Fuller, we are trying to do what is right for the Cabot community. The park is an active park, the additional parking proposed in this plan would benefit the park users, play equipment would be placed where you want it to go and there would be access to the hardscape and the school gym.
- Phillipe W, Bellevue Street, Cabot/Underwood supporter. Supports connection to the park, like Underwood School and Farlow Park.
- Alderman Albright commented she is disappointed this proposal has become so contentious. The community should work together to come up with a plan that works for all.

- Jean Marie P, Newton Girls Softball (NGS), there are 300 families involved in NGS and they use the softball field in Cabot Park. She wants the school to get what it needs, the little league and baseball field will not be touched but the softball field will be relocated and she would like to be involved in the design of the relocated field.
- Bud G, Eastside Parkway, Parks & Recreation Commission protects the parks, does not support parking in the park.
- Alan S, Westchester Street, we must remove emotions from facts, there
  are safety issues but there are other options, like raised crosswalks, etc.
  Does not believe other options have been looked at.
- Cate D, Mother Nature's voice, does not support the proposal.
- Kim, supports teachers, supports proposal.
- Deirdre O, there is less parking than ever, no vice-principal at the school, the building is in terrible condition, and it is time for a change. In support of proposal.
- Beth H, Kids in sports programs at Cabot Park. The way the relocated softball field is configured, balls will be hit into tot lot and onto Parkview Ave.
- Chairman Magni closed public comment and asked Commission members for their comments.
- Mr. Kastner stated the Commission standards call for all alternatives to be examined; there has been failure to look at other alternatives with this proposal.
- Mr. Neville requested Mr. Valcarce clarify taking of softball field. Mr.
   Valcarce stated whatever parking is not approved will be managed
   elsewhere, the softball field will be moved even if no parking on park land
   is approved.
- Mr. Tucker asked the budget for the Cabot School renovation;; Mr. Valcarce stated the budget is 45 million dollars.
- Chairman Magni asked for a motion.
- Mr. Fishman made the motion to approve the 56 parking space plan. Mr. Kastner seconded the motion and then withdrew his second of the motion; Mr. Kastner requires clarification of improvements to park.
- Mr. Valcarce stated improvements previously discussed were signage, play structures, benches, picnic tables and extending the irrigation.
- Mr. Fishman stated promises are made and then the budget gets cut when it is time to add the promised items. Mr. Fishman appreciates the members who do not want to give up park land unless there is a strict need, but each proposal must be looked at in a case by case basis. The Commission must do something about parking. If the City does not meet its promise the next time land is asked for Mr. Fishman will protest.
- Associate City Solicitor Ouida Young stated the minutes can reflect the improvements offered as well as the comments of the members.

Mr. Fishman made the motion to support the 56 parking space plan subject to mitigation and improvements. Mr. Dunker seconded the motion. Motion failed 2-5.

Ms. Charkoudian made the motion to provide no park land for parking. Mr. Neville seconded the motion. Motion failed 3-4.

Mr. Tucker made the motion to support the 28 parking space plan.

- Mr. Fishman asked the rationale of the motion. Mr. Tucker stated this is a compromise. This reduces the likelihood of car/kid issues, the 56 parking space plan would double the likelihood of accidents.
- Mr. Kastner stated the designer can continue to plan and the Commission can take a second look.
- Mr. Valcarce stated there will be less mitigation provided to the park with the 28 car parking plan.
- Mr. Dunker stated the City will get a better park out of this compromise.
- Chairman Magni asked for a vote on the motion:

Mr. Tucker made the motion to support the 28 space parking plan subject to mitigation and improvements. Mr. Dunker seconded the motion.

Motion passed 5-1-1.


### MOTION TO APPROVE THE 28 PARKING SPACE SITE PLAN (ATTACHED)

The Parks and Recreation Commission approves the following motion:

- Approves development of the edge of Cabot Park along Parkview Avenue as shown on the attached Site Plan which includes the following shared use elements on park land:
  - ➤ 28 head-in parking spaces along Parkview Avenue, with approximately ½ car length on park land;
  - A roundabout located on both school and park lands to facilitate two-way traffic on Parkview Avenue:
  - An emergency access road along the edge of the school gym;
  - Creation of a new play structure on the Park which is protected from fly balls coming from the Little League field;
  - > Development of the school plaza into the edge of the Park; and
  - Creation of two paved lighted pedestrian path-ways to facilitate travel between East Side Parkway and the west side of Cabot Park.
- The Parks and Recreation Commission includes the following additional conditions in its motion:
  - ➤ Directs that the mature oak trees along Parkview Avenue be protected when head-in parking is developed;
  - ➤ Limits the removal of any park trees to the extent possible in the development of the Park as authorized by this motion and requires the replacement of any removed trees at locations in the Park;
  - ➤ Requests the Cabot School Design Team consider ways of enhancing use of the plaza by recreational users during non-school hours;
  - Permits the relocation of the softball field and requires its replacement with an equivalent or improved softball field at a different location in the Park; and
  - Permits the use of that portion of the Park to be developed for the shared park/school improvements to be used for temporary construction activities.
- This Motion to Approve is based on the "28 PARKING SPACE SITE PLAN" presented to the Parks and Recreation Commission at its meeting of September 30, 2015 a copy of which is attached to this Motion. The Design Team shall return to the Parks and Recreation Commission for further review and approval if there are material modifications proposed for the Park portion of the Site Plan.
- The Parks and Recreation Commission further directs Parks & Recreation Commissioner DeRubeis to work with the Design Team to implement all of the above, and in particular to be sure that the relocation and upgrade to the softball field meets the needs of all users of such field, as well as to secure mitigations to the Cabot Park such as an improved soccer field consistent with the impact the construction activities will have on the Park.

 Ms. Charkoudian asked if we are committed to commemorate the site historically. Mr. Tucker stated that has been discussed and will be a future discussion.







### City of Newton Policy for the Regulation of Temporary, Free-Standing Placard-Type Signs on City Property

### **Purpose:**

This policy has been enacted to: (1) establish an orderly procedure for the placement of such signs on City property; (2) provide designated, approved locations for the placement of such signs on City property; (3) establish timeframes for the removal of such signs and penalties for failure to remove them; and (4) deter the random, haphazard placement of signs on City property.

### Policy:

This policy applies to all City of Newton departments and entities, and non-profit entities, or individuals seeking to place temporary, free-standing placard-type signs on City property for an event or events taking place in the City of Newton. This policy applies to signs placed on *City property* and is not intended to replace or supersede any City of Newton Ordinance or regulation relative to the regulation of signs on non-City property and in open-space/recreation and public use districts. This policy does not apply to election signs or to sandwich boards.

The City has established a list of approved City locations where such signs may be placed. Each entity or individual shall be allowed to place one sign which may be no larger than 2 feet by 2 feet at each designated City location. Such signs shall not be illuminated, shall be placed in or on the ground only, and may not be permanently affixed to the ground or any City property. If the sign advertises or announces a one-time event, such sign shall not be placed before fourteen (14) days preceding the event and shall be removed no later than forty-eight (48) hours after conclusion of the event. If the sign advertises or announces a recurring event, for example, an event that occurs every Tuesday during the summer months, such sign may be placed at such locations for a maximum time period of three (3) months and shall then be removed no later than forty-eight (48) hours after the expiration of the three (3) month period. It shall be the responsibility of the entity or individual who places any such sign(s) on City property to remove such sign(s) within the designated time frames. Failure to adhere to this or any other condition of this policy may result in the entity or individual being prohibited from placing signs on City property in the future. The City reserves the right to remove and discard any sign(s) left in place longer than forty-eight (48) hours after expiration of the event, and under no circumstances will the City be responsible for retaining such sign(s). The City of Newton also reserves the right to remove and discard any sign it deems inappropriate or offensive. The City of Newton assumes no liability for signs which have been removed, stolen, damaged or defaced.

### **Designated Locations:**

Temporary free-standing placard-type signs may be placed at one or more of the following locations, with only one (1) sign allowed per event per designated location:

- Halloran Field fence on Crafts Street
- Cold Spring Park on Beacon St. on the grassy area that faces Beacon Street
- Lowell Park at the corner of Walnut and Watertown Street
- Spears Park on Washington Street
- Nahanton Park at the entrance on Nahanton Street
- At the site of the event

Such signs may not be placed on or around any traffic islands, curbs, berms or historic sites unless express permission is given by the Commissioner of Public Works.

### 2. Commissioner's Reports on Programs, Forestry and Maintenance

- Newton South Tennis Courts are undergoing a complete rebuild. These courts
  will be closed until early July 2016. The goal is to have the topcoat done
  before winter the seal coat will be done in the spring. This will impact the
  spring tennis season.
  - Mr. Stern inquired about the funding. Commissioner DeRubeis stated the project is funded by CIP money and is a Parks & Recreation Project on school property. The next courts to be rebuilt are McGrath Playground in FY17 and Burr Park in FY18.
  - Mr. Palmer asked if the east courts at McGrath Playground will be done, Commissioner DeRubeis stated no the east side courts have been recently crack filled with the Riteway System.
- The Highland Playground Project is tentatively scheduled for spring construction. Commissioner DeRubeis will appear before the Community Preservation Committee on December 10th to request one million dollars, total cost 3.3 million.
- The Farlow Park Project is now being managed by Elaine Gentile. The pond basin has many holes and the engineers have recommended a gunite bottom which will increase the cost.
- Programs:
  - Currently NNHS indoor recreation programs are running
  - School vacation camp registration is open and the department is preparing for the summer camp fair the end of January.
  - There is an increase in minimum wage in January which will increase the seasonal wages.
  - The Scholarship fund for summer camps is also running low. All who apply will receive some assistance. Mr. Stern asked if information could be circulated about making donations.
  - Over 55 programs run year round, Nancy Scammon, Director has implemented intergenerational and inter department programs.

- Special Needs Programs

   Karen Peirce has been added as an assistant to Mark Kelly, Special Needs Director. This has created the opportunity for additional programs for adult special athletes.
- O Programs & Services Committee will be discussing the leaf blower ban and have asked the Commissioner for the impact the ban would have on the department. There would be approximately 30% increase on the maintenance side and a 7%-10% decrease in tree removals and pruning's, Forestry uses leaf blowers for tree clean up. Mr. Palmer asked if this ban would include snow blowers, Commissioner DeRubeis replied no it would not.
- O Mr. Figler asked for an update on turf fields and synthetic fields. Commissioner DeRubeis stated there was a meeting with Youth Soccer representatives. Halloran or Forte field are options for a synthetic field because they are heavily used and already lighted. The concern with synthetic fields in the infill used. Fessenden School currently used organic material on the newly constructed synthetic field; we will wait to see how the organic material compares.

### 3. New Business

- Chairman Magni received a suggestion from Mr. Kastner, Commission Member to include commission committee reports to the agenda, such as the Farm Commission, CPC and Golf Course. All agreed this was a good suggestion, committee reports will be added to the agenda going forward.
- Chairman Magni requested the Cabot Redesign Committee be included to the Committee Updates on the agenda.
- Commissioner DeRubeis reported on Off-leash Areas: Jason Roberts has been out due to an auto accident. Officer Torres reported issues with professional dog walking companies at Hunnewell Park. OLAWG will be meeting December 4<sup>th</sup> to discuss the issue.
- The Angier School project is moving along. Staff and the contractor are cleaning the wooded triangle area as agreed upon.
- Mr. Stern asked for an update on Crystal Lake. Commissioner DeRubeis stated there is no update.
