## 2. Commissioner's Reports on Programs, Forestry and Maintenance

- Marathon preparation meetings have begun. Main topic of discussion is the cost of blocking the side streets leading to the Marathon route. The City has requested assistance from the BAA.
- Alan Nogee and the Friends of Cold Spring Park have requested a kiosk be installed at the park. The group is raising funds to renovate the trails. The Commissioner is meeting with Mr. Nogee next week.
- 1294 Centre St, the previous Health Department is being renovated and the department is being asked to run programs at the location.
- Meeting scheduled with neighbors of NSHS to discuss the lights to be installed and the policy regarding use.
- Scheduling a get together for Peter Johnson's retirement from the Commission.
- A resident has requested a playground in Waban, near the aqueduct. The resident and department staff met with Waban Area Council last week.
   Project is moving forward.
- Meeting with abutter of McGrath Park, Ryan Oldham, to discuss Lacrosse Wall.
- Carol Stapleton commented Paramount will be filming "Defending Jacob" in Cold Spring Park April 8,9, 17<sup>th</sup>. Mr. Neville asked if it states in the contract that the staging area in the park will be left in the same condition or better once, they depart. Ms. Stapleton replied yes; the language is in the contract.

## 2.a Nonantum Village Day – Informational – Lois Margaret Dominique

 Event is the same as last year except for the Bounce House. Insurance has been increased and group will contact the State as instructed by the city's Licensing Department regarding the bounce house.

Mr. Clarke made the motion to move the proposal to a public hearing. Mr. Stern seconded the motion. Motion passed 8-0.

## 3. St. Mary of Carmen Festival- Public Hearing

- The St. Mary of Carmen Society will celebrate its Annual Festival on July 17th, 2019 through July 21st, 2019. This is the 84th anniversary celebration with no material changes.
- A letter was received regarding a fence along Pellegrini Park being damaged and needing repair. The fence was checked, it is an older fence but is intact.
- Commissioner DeRubeis commented the festival is a lot different than it was 20 years ago thanks to Mr. Proia and Mr. Flynn.
- Chairman Magni asked if there were any public comments. There were no comments.

Mr. Dunker made the motion to approve the proposal as presented. Mr. Neville seconded the motion. Motion passed 7-0. Chairman Magni recused himself as he is a member of St. Mary Carmen Society.

## 4. Sculpture Show on the Greenway -Informational-Chuck Tanowitz

- Mr. Tanowitz commented the 2018 event was a success with \$12,000 in sponsors, 15 artists and positive feedback from the community.
- The event will be the same as last year. The proposed dates are June 10-Sept 12.
- There was some vandalism last year which the artists will consider with placement of artwork.
- Chairman Magni asked if lighting would help deter the vandalism? Mr.
   Tanowitz replied the area is a large area and the artwork is spread too far apart.
- New additions this year will be dance and yoga.
- Requesting assistance from city to clean up poison ivy along the trail.

Mr. Tucker made the motion to move the proposal to a public hearing. Mr. Neville seconded the motion. Motion passed 8-0.
