
# **Newton Parks & Recreation Commission**

### 1. Meeting Minutes

#### 2. Commissioner's Reports on Programs, Forestry and Maintenance

- This past weekend there were two major events, Paddy's Road Race and Harvest Fair. As usual, Mark Kelly did a great job with Paddy's Road Race. This was the first year Paula Gannon managed the Harvest Fair and did a great job.
- Met with Claire Rundelli from Conservation regarding the NSHS lights. Conservation
  does not have a problem with digging holes on the conservation land, they were more
  concerned about the light spillage, the group explained there is minimal to no spillage
  with the new technology. Parks, Recreation & Culture Department will be responsible
  for digging the holes, the NSHS Booster Club is raising money for the lights.
- Chairman Magni asked about the possible lawsuit from abutters. Currently there is no lawsuit, the group has been meeting with neighbors to work out the issues.
- Kate Nyquist a resident of Waban has proposed a tot lot at the intersection of Waban Ave and Alban Rd on the old MWRA land now owned by the city. The Law Department stated a change of use would have to go before the Council. Mayor Fuller will be visiting the site in the next couple of weeks.
- Peter Mazzapica has been hired as the Off-leash Recreation Specialist (OLRS). He will begin working the week of October 28. The focus will be Hunnewell off-leash area. Mr. Tucker asked if the Animal Control Officer is receptive to the OLRS. Commissioner DeRubeis responded yes.
- Meeting with a Crystal Lake Conservator representative to discuss bathhouse plan. The bath house is on the CIP list but there is no consensus on the building size or whether it is a seasonal or 12-month building.
- Each year there is a request to clear the brush from around the waters edge at the Waban Hill Reservoir. This is a \$10k-\$12k project, that is not budgeted.
